Any and all fees or 22 assessments, or both, levied on the state to cover the costs of the 23 operations and activities of the interstate health professions 24 licensure compacts with participating authorities listed under 25 chapter 18.130 RCW shall be borne by the persons who hold licenses 26 issued pursuant to the authority and procedures established under 27 the compacts. In fixing said fees, the secretary shall set the fees

EFFECT: Exempts a person whose nursing assistant or home care aide certificate has been expired for more than six months but less than two years from any continuing education requirement imposed as a precondition for returning to active status. Prohibits the Department of Health (DOH) from increasing licensing fees for home care aides during the 2023-2025 biennium and requires the DOH to submit a budget request to the Legislature if there is a resulting revenue shortfall. Restores the requirement that a long-term care worker meet minimum training requirements within 120 calendar days after the date of being hired (the underlying bill extends this period to 200 days).
