Any person licensed 23 as a dental hygienist in this state may apply topical anesthetic 24 agents under the general supervision, as defined in RCW 18.260.010, 25 of a dentist or a dental therapist: PROVIDED HOWEVER, That licensed 26 dental hygienists shall in no event perform the following dental 27 operations or services:

- 1 (1) Any surgical removal of tissue of the oral cavity;
- 2 (2) Any prescription of drugs or medications requiring the
- 3 written order or prescription of a licensed dentist or physician,
- 4 except that a hygienist may place antimicrobials pursuant to the
- 5 order of a licensed dentist and under the dentist's or dental
- 6 therapist's required supervision;
- 7 (3) Any diagnosis for treatment or treatment planning; or
- 8 (4) The taking of any impression of the teeth or jaw, or the
- 9 relationships of the teeth or jaws, for the purpose of fabricating
- 10 any intra-oral restoration, appliance, or prosthesis, except that a
- 11 dental hygienist may take an impression for any purpose that is
- 12 either allowed:
- (a) For a dental assistant registered under chapter 18.260 RCW; or
- (b) As a delegated duty for dental hygienists pursuant to rules
- 15 adopted by the dental quality assurance commission.
- 16 Such licensed dental hygienists may perform dental operations
- 17 and services only under the supervision of a licensed dentist or
- 18 dental therapist, and under such supervision may be employed by
- 19 hospitals, boards of education of public or private schools, county
- 20 boards, boards of health, or public or charitable institutions, or
- 21 in dental offices."
