## <u>SSB 5072</u> - H COMM AMD By Committee on Education

## ADOPTED 03/22/2023

- 1 Strike everything after the enacting clause and insert the 2 following:
- 3 "NEW SECTION. Sec. 1. (1) The legislature finds that, for highly capable students, access to accelerated learning and enhanced 4 instruction is access to a basic education. The legislature has 5 6 directed school districts to prioritize equitable identification of 7 low-income students for participation in highly capable programs and services. The research literature strongly supports using universal 8 screening and multiple criteria to equitably identify students for 9 highly capable programs. There are multiple 10 approaches to 11 implementing universal screening and the use of multiple criteria. 12 The legislature intends all school districts to use best practices and does not intend to prescribe a single method. 13
  - (2) The legislature further intends to allocate state funding for the highly capable program based on five percent of each school district's student population. The legislature does not intend to limit highly capable services to five percent of the student population. School districts may identify and serve more than five percent of their students for highly capable programs and services.
  - Sec. 2. RCW 28A.185.020 and 2017 3rd sp.s. c 13 s 412 are each amended to read as follows:
  - (((1) The legislature finds that, for highly capable students, access to accelerated learning and enhanced instruction is access to a basic education. There are multiple definitions of highly capable, from intellectual to academic to artistic. The research literature strongly supports using multiple criteria to identify highly capable students, and therefore, the legislature does not intend to prescribe a single method. Instead, the legislature intends to allocate funding based on 5.0 percent of each school district's population and authorize school districts to identify through the use of multiple, objective criteria those students most highly capable and eligible to

- receive accelerated learning and enhanced instruction in the program

- NEW SECTION. Sec. 3. A new section is added to chapter 28A.185
  RCW to read as follows:
- 14 (1) Other basic education funding can be used alongside 15 categorical funding to identify students and provide programs and 16 services for highly capable students.
- 17 (2) Each school district must conduct universal screenings in 18 accordance with RCW 28A.185.030 to find students who may qualify for 19 potential highly capable program placement.
- 20 **Sec. 4.** RCW 28A.185.030 and 2009 c 380 s 4 are each amended to 21 read as follows:

- ((Local school)) (1) School districts may establish and operate, either separately or jointly, programs for highly capable students. Such authority shall include the right to employ and pay special instructors and to operate such programs jointly with a public institution of higher education. ((Local school))
- (2) School districts ((which)) that establish and operate programs for highly capable students shall adopt identification procedures and provide educational opportunities as follows:
- 30 ((\(\frac{(1)}{(1)}\)) (a) In accordance with rules adopted by the superintendent of public instruction, school districts shall implement procedures for ((nomination)) referral, screening, assessment ((and selection)), identification, and placement of ((their most)) highly capable students. ((Nominations shall be based upon data from))
- (i) Referrals must be available for all grade levels not being universally screened, and may be submitted by teachers, other staff, parents, students, and members of the community.

(ii) Each school district must select a grade level to implement universal screening procedures for each student. Universal screening must occur once in or before second grade, and again in or before sixth grade. The purpose of universal screening is to include students who traditionally are not referred for highly capable programs and services. Students discovered during universal screening may need further assessment to determine whether the student is eligible for placement in a program for highly capable students. Districts must consider at least two student data points during universal screening, which may include previously administered standardized, classroom-based, performance, cognitive, or achievement assessments, or research-based behavior ratings scales. There is no requirement to administer a new assessment for the purpose of universal screening, however districts may do so if they desire.

(iii) Assessments ((shall)) for highly capable program services must be based upon a review of each student's capability as shown by multiple criteria intended to reveal, from a wide variety of sources and data, each student's unique needs and capabilities. Any screenings or additional assessments must be conducted within the school day and at the school the student attends, except that school districts, on a case-by-case basis and with the consent of the parent or guardian, may offer a student screenings or additional assessment opportunities during the summer, outside of school hours, or at an alternative site.

((Selection)) (iv) Identification and placement decisions shall be made by a ((broadly based committee of professionals,)) multidisciplinary selection committee after consideration of the results of the ((multiple criteria assessment)) universal screening, any further assessment, and any available district data. Students identified pursuant to procedures outlined in this section must be provided, to the extent feasible, an educational opportunity that takes into account each student's unique needs and capabilities, and the limits of the resources and program options available to the district, including those options that can be developed or provided using funds allocated by the superintendent of public instruction for this specific purpose.

(b) In addition to the criteria listed in (a) of this subsection, district practices for identifying highly capable students must seek to expand access to accelerated learning and enhanced instruction at elementary and secondary schools and advance equitable enrollment Code Rev/CC:lel 3

- practices so that all students, especially students from historically underrepresented and low-income groups, who are ready to engage in more rigorous coursework can benefit from accelerated learning and enhanced instruction.
  - $((\frac{(2)}{(2)}))$  Mhen a student, who is a child of a military family in transition, has been assessed or enrolled as highly capable by a sending school, the receiving school shall initially honor placement of the student into a like program.

    - (((3) Students selected pursuant to procedures outlined in this section shall be provided, to the extent feasible, an educational opportunity which takes into account each student's unique needs and capabilities and the limits of the resources and program options available to the district, including those options which can be developed or provided by using funds allocated by the superintendent of public instruction for that purpose.))
- 22 (4) ((The)) For a student who is a child of a military family in 23 transition, the definitions in Article II of RCW 28A.705.010 apply to 24 subsection (( $\frac{2}{1}$ )) (3) of this section.

  - (1) In order to ensure that school districts are meeting the requirements of an approved program for highly capable students, the superintendent of public instruction shall monitor highly capable programs at least once every five years. Monitoring shall begin during the 2002-03 school year.

- (3) Beginning June 30, 2003, and every five years thereafter, the office of the superintendent of public instruction shall submit a report to the education committees of the house of representatives and the senate that provides the following:
- (a) A brief description of the various instructional programs offered to highly capable students; and
- 9 <u>(b) Relevant data to the programs for highly capable students</u> 10 <u>collected under RCW 28A.300.042</u>.
- (4) Beginning November 1, 2023, and annually thereafter, the 11 superintendent of public instruction must make data publicly 12 available that includes a comparison of the race, ethnicity, and low-13 income status of highly capable students compared to the same 14 demographic groups in the general student population of each school 15 district. - 22 **Sec. 6.** RCW 28A.300.042 and 2016 c 72 s 501 are each amended to 23 read as follows:
  - (1) ((Beginning with the 2017-18 school year, and using the phase-in provided in subsection (2) of this section, the)) The superintendent of public instruction must collect and school districts must submit all student-level data using the United States department of education 2007 race and ethnicity reporting guidelines, including the subracial and subethnic categories within those guidelines, with the following modifications:
- 31 (a) Further disaggregation of the Black category to differentiate 32 students of African origin and students native to the United States 33 with African ancestors;
- 34 (b) Further disaggregation of countries of origin for Asian 35 students;
- 36 (c) Further disaggregation of the White category to include 37 subethnic categories for Eastern European nationalities that have 38 significant populations in Washington; and

- 1 (d) For students who report as multiracial, collection of their 2 racial and ethnic combination of categories.
  - (2) Beginning with the 2017-18 school year, school districts shall collect student-level data as provided in subsection (1) of this section for all newly enrolled students, including transfer students. When the students enroll in a different school within the district, school districts shall resurvey the newly enrolled students for whom subracial and subethnic categories were not previously collected. School districts may resurvey other students.
- (3) All student data-related reports required of 10 superintendent of public instruction in this title must be 11 12 disaggregated by at least the following subgroups of students: White, Black, Hispanic, American Indian/Alaskan Native, Asian, Pacific 13 Islander/Hawaiian Native, low income, <u>highly capable</u>, transitional 14 bilingual, migrant, special education, and students covered by 15 section 504 of the federal rehabilitation act of 1973, as amended (29 16 17 U.S.C. Sec. 794).
- 18 (4) All student data-related reports prepared by the 19 superintendent of public instruction regarding student suspensions 20 and expulsions as required under this title are subject to 21 disaggregation by subgroups including:

  - (5) All student data-related reports required of the superintendent of public instruction regarding student suspensions and expulsions as required in RCW 28A.300.046 are subject to cross-tabulation at a minimum by the following:
    - (a) School and district;
- 18 (b) Race, low income, <u>highly capable</u>, special education, 19 transitional bilingual, migrant, foster care, homeless, students 20 covered by section 504 of the federal rehabilitation act of 1973, as 21 amended (29 U.S.C. Sec. 794), and categories to be added in the 22 future;
  - (c) Behavior infraction code; and
  - (d) Intervention applied.
  - (6) The K-12 data governance group shall develop the data protocols and guidance for school districts in the collection of data as required under this section, and the office of the superintendent of public instruction shall modify the statewide student data system as needed. The office of the superintendent of public instruction shall also incorporate training for school staff on best practices for collection of data ((on student race and ethnicity)) under this section in other training or professional development related to data provided by the office."
- 34 Correct the title.

<u>EFFECT:</u> Permits school districts, on a case-by-case basis and with the consent of the parent or guardian, to offer screenings or additional assessment opportunities during the summer, outside of

school hours, or at an alternative site, rather than only within the school day and at the school the student attends.
