- NEW SECTION. **Sec. 1**. A new section is added to chapter 29A.72 RCW 11 to read as follows:
- (1) For every legislative action raising taxes as defined by RCW 43.135.034 that is not referred to the people by a referendum petition found to be sufficient under RCW 29A.72.250, a measure for a non-binding tax increase consent vote is required and shall be placed on the next general election ballot under this chapter. Each tax
- 17 being increased is subject to a separate vote.
- 18 (2) By August 1 of each year, the attorney general must send 19 written notice to the secretary of state of any tax increase subject 20 to a tax increase consent vote. The secretary of state must assign a 21 serial number to the measure within five business days and transmit a 22 copy to the attorney general.
- 23 (3) Within five business days of receipt from the secretary of 24 state, the committee on tax increase consent votes must formulate a 25 short description of the tax increase consent vote. The committee 26 consists of the speaker of the house of representatives, the majority 27 leader of the senate, and the minority leaders of both the house of

1 representatives and the senate. A majority of the committee must
 2 agree on the short description before it can be transmitted to the
 3 secretary of state under this section. The description may not exceed
4 thirty-three words and is not subject to appeal. The description must
5 be formulated and displayed on the ballot as follows: "The legislature
6 imposed, without a vote of the people, (identification of tax and
7 description of increase), costing (most up-to-date ten-year cost
8 projection, expressed in dollars and rounded to the nearest million)
9 in its first ten years, for government spending. This tax increase
10 should be ..."
