10 <u>NEW SECTION</u>. Sec. 1. A new section is added to chapter 29A.72 RCW 11 to read as follows:

12 (1) For every legislative action raising taxes as defined by 13 RCW 43.135.034 that is not referred to the people by a referendum 14 petition found to be sufficient under RCW 29A.72.250, a measure for a 15 tax increase consent vote is required and shall be placed on the next 16 general election ballot under this chapter. Each tax being increased 17 is subject to a separate vote.

18 (2) By August 1 of each year, the attorney general must send 19 written notice to the secretary of state of any tax increase subject 20 to a tax increase consent vote. The secretary of state must assign a 21 serial number to the measure within five business days and transmit a 22 copy to the attorney general.

(3) Within five business days of receipt from the secretary of state, the attorney general must formulate a short description of the tax increase consent vote. The description may not exceed thirtythree words and is not subject to appeal. The description must be formulated and displayed on the ballot as follows: "The legislature
