13 RCW 43.135.034 that is not referred to the people by a referendum 14 petition found to be sufficient under RCW 29A.72.250, a measure for a 15 non-binding tax increase consent vote is required and shall be placed 16 on the next general election ballot under this chapter. Each tax 17 being increased is subject to a separate vote.

18 (2) By August 1 of each year, the attorney general must send 19 written notice to the secretary of state of any tax increase subject 20 to a tax increase consent vote. The secretary of state must assign a 21 serial number to the measure within five business days and transmit a 22 copy to the attorney general.

(3) Within five business days of receipt from the secretary of state, the attorney general must formulate a short description of the tax increase consent vote. The description may not exceed thirtythree words and is not subject to appeal. The description must be formulated and displayed on the ballot as follows: "The legislature 1 imposed, without a vote of the people, (identification of tax and 2 description of increase), costing (most up-to-date ten-year cost 3 projection, expressed in dollars and rounded to the nearest million) 4 in its first ten years, for government spending. This tax increase 5 should be ..."

6 (4) Voters shall be given the option to choose "Repealed" or 7 "Maintained."

8 (5) After the short description is completed, the attorney general 9 must transmit it to the secretary of state for filing.

10 (6) If at least sixty percent of voters select "Repealed" in a tax 11 increase consent vote under this section, the chamber of the 12 legislature in which the bill raising taxes originated must pass a 13 resolution in the following session that either affirms or disapproves 14 of its prior support for the bill."

Requires that if at least sixty percent of voters select "Repealed" in a Tax Increase 5082-S.E AMH ZOLL 330 3 - Official Print Consent Vote, the chamber of the legislature in which the bill originated must pass a resolution that either affirms or disapproves of its prior support for the bill. Removes the intent section.
