EFFECT: Assumes passage of House Bill No. 1011 (long-term services and supports), which repeals the Long-Term Services and

Supports Trust Program (Trust Program). Appropriation authority for the Employment Security Department and Department of Social and Health Services to implement the Trust Program are eliminated. Repayment to the General Fund-State for Trust Program start-up costs from the dedicated Trust account is eliminated. General Fund-State costs are partially offset by reducing the amount per state-funded full-time equivalent student at The Evergreen State College to reflect the average amount for the public regional four-year universities, and assuming that participation in the vaccine booster incentive program will be 50 percent, rather than 80 percent.

FISCAL IMPACT: Reduces the Long-Term Services and Supports Account - State by \$84,702,000. Increases General Fund-State by \$696,000.
