16 (b) The aerospace and aviation advisory committee must provide a 17 first report to the appropriate standing committees of the legislature 18 by June 30, 2024, and a final report by June 30, 2025. The reports 19 must identify specific policy and fiscal recommendations that build 20 off the state's core strengths and respond to emerging opportunities 21 for unmanned, autonomous, space, and future propulsion systems, and to 22 enhance the economic performance and safe and efficient use of public 23 use airports and aerospace facilities in the state. The 24 recommendations may address the following areas:

25 (i) Research and development activities, review of trends 26 analysis, and economic forecasts for relevant industry sectors; 27 (ii) New, changed, or proposed federal and state regulations and
 initiatives of the legislature, governor, and state agencies;

3 (iii) Infrastructure and multimodal investment needs and priority
4 recommendations for state and federal level programs;

5 (iv) Strategy and policy analysis and recommendations for domestic 6 and international air service retention and recruitment, and growth of 7 corporate and general aviation business opportunities;

8 (v) Strategy and policy recommendations for retention, growth, and 9 recruitment of aviation and aerospace industry businesses;

10 (vi) Strategy and policy recommendations to improve economic 11 development opportunities for airports, including industry gap 12 analysis for national and international competition;

13 (vii) Workforce development gaps, including state education system 14 deficiencies and needs, as identified by the aerospace and advanced 15 materials manufacturing pipeline advisory committee;

16 (viii) Carbon reduction strategies and land use requirements;

17 (ix) Export assistance and supply chain development; and

18 (x) Other matters as the advisory committee deems appropriate.

19 (c) The advisory committee must conduct workforce marketing, 20 including outreach to students and workers about potential employment 21 and other opportunities in the aviation and aerospace sector, to 22 inform the recommendations identified under (b) of this subsection.

(d) The director of the department, or the director's designee,
shall appoint members to the advisory committee, including:

(i) Two local elected leaders, one from east of the crest of the 26 Cascade mountains and one from west of the crest of the Cascade 27 mountains;

(ii) An executive level representative from a Washington state 29 based aerospace employer or their designee;

30 (iii) An executive level representative from a Washington state-31 based aviation company;

32 (iv) The director of the aviation division of the department of 33 transportation, or the director's designee;

34 (v) The aerospace lead from the department;

1 (vi) Two executive officials of a commercial service airport, one 2 from an airport east of the crest of the Cascade mountains and one 3 from an airport west of the crest of the Cascade mountains; 4 (vii) One representative from each of the following: 5 (A) The state board for community and technical colleges; 6 (B) The military department; 7 (C) A statewide environmental organization; 8 (D) An airport association; 9 (E) A labor organization with a relevant apprenticeship program; 10 (F) An aviation association; and 11 (G) An aerospace association; and 12 (viii) Other representatives as deemed appropriate by the 13 director. 14 (e) The director shall request participation from the federal 15 aviation administration on the advisory committee. 16 (f) The director of the department, or the director's designee, 17 shall serve as the administrative chair of the advisory committee. 18 (q) The committee must meet at the call of the administrative 19 chair. 20 (h) The department must provide staff support for all advisory 21 committee meetings." 2.2
