"NEW SECTION. Sec. 1. The legislature finds and declares that 3 gun violence is a threat to the public health and safety of 4 Washingtonians. Assault weapons are civilian versions of weapons 5 created for the military and are designed to kill humans quickly and 6 7 efficiently. For this reason the legislature finds that assault weapons are "like" "M-16 rifles" and thus are "weapons most useful in 8 military service." Assault weapons have been used in the deadliest 9 mass shootings in the last decade. An assailant with an assault 10 11 weapon can hurt and kill twice the number of people than an assailant 12 with a handgun or nonassault rifle. This is because the additional 13 features of an assault weapon are not "merely cosmetic"; rather, 14 these are features that allow shooters to fire large numbers of rounds quickly. An analysis of mass shootings that result in four or 15 16 more deaths found that 85 percent of those fatalities were caused by 17 an assault weapon. The legislature also finds that this regulation is likely to have an impact on the number of mass shootings committed in 18 Washington. Studies have shown that during the period the federal 19 20 assault weapon ban was in effect, mass shooting fatalities were 70 21 percent less likely to occur. Moreover, the legislature finds that 22 assault weapons are not suitable for self-defense and that studies show that assault weapons are statistically not used in self-defense. 23 24 The legislature finds that assault weapons are not commonly used in 25 self-defense and that any proliferation is not the result of the 26 assault weapon being well-suited for self-defense, hunting, 27 sporting purposes. Rather, increased sales are the result of the gun 28 industry's concerted efforts to sell more guns to a civilian market. The legislature finds that the gun industry has specifically marketed 29 these weapons as "tactical," "hyper masculine," and "military style" 30 in manner that overtly appeals to troubled young men intent on 31 32 becoming the next mass shooter. The legislature intends to limit the

- 1 prospective sale of assault weapons, while allowing existing legal 2 owners to retain the assault weapons they currently own.

Unless the context clearly requires otherwise, the definitions in this section apply throughout this chapter.

((4))) (5) "Bump-fire stock" means a butt stock designed to be attached to a semiautomatic firearm with the effect of increasing the rate of fire achievable with the semiautomatic firearm to that of a fully automatic firearm by using the energy from the recoil of the firearm to generate reciprocating action that facilitates repeated activation of the trigger.

 $((\frac{5}{1}))$ (6) "Crime of violence" means:

- (a) Any of the following felonies, as now existing or hereafter amended: Any felony defined under any law as a class A felony or an attempt to commit a class A felony, criminal solicitation of or criminal conspiracy to commit a class A felony, manslaughter in the first degree, manslaughter in the second degree, indecent liberties if committed by forcible compulsion, kidnapping in the second degree, arson in the second degree, assault in the second degree, assault of a child in the second degree, extortion in the first degree, burglary in the second degree, residential burglary, and robbery in the second degree;

"Firearm" does not include a flare gun or other pyrotechnic visual distress signaling device, or a powder-actuated tool or other device designed solely to be used for construction purposes.

through metal detectors or magnetometers commonly used at airports or any firearm where the barrel, the slide or cylinder, or the frame or receiver of the firearm would not generate an image that accurately depicts the shape of the part when examined by the types of X-ray machines commonly used at airports.

- (i) "Readily" means a process that is fairly or reasonably efficient, quick, and easy, but not necessarily the most efficient, easy process. Factors relevant in speedy, or making determination, with no single one controlling, include the following: (A) Time, i.e., how long it takes to finish the process; (B) ease, i.e., how difficult it is to do so; (C) expertise, i.e., what knowledge and skills are required; (D) equipment, i.e., what tools are required; (E) availability, i.e., whether additional parts are required, and how easily they can be obtained; (F) expense, i.e., how much it costs; (G) scope, i.e., the extent to which the subject of the process must be changed to finish it; and (H) feasibility, i.e., whether the process would damage or destroy the subject of the process, or cause it to malfunction.
- (ii) "Partially complete," as it modifies frame or receiver, means a forging, casting, printing, extrusion, machined body, or similar article that has reached a stage in manufacture where it is clearly identifiable as an unfinished component part of a firearm.
- ((43))) <u>(46)</u> "Unlicensed person" means any person who is not a licensed dealer under this chapter.
- (((44))) (<u>47)</u> "Untraceable firearm" means any firearm manufactured after July 1, 2019, that is not an antique firearm and that cannot be traced by law enforcement by means of a serial number affixed to the firearm by a federal firearms manufacturer, federal firearms importer, or federal firearms dealer in compliance with all federal laws and regulations.

NEW SECTION. Sec. 3. A new section is added to chapter 9.41 RCW to read as follows:

- (1) No person in this state may manufacture, import, distribute, sell, or offer for sale any assault weapon, except as authorized in this section.
- 6 (2) Subsection (1) of this section does not apply to any of the following:
 - (a) The manufacture, importation, distribution, offer for sale, or sale of an assault weapon by a licensed firearms manufacturer for the purposes of sale to any branch of the armed forces of the United States or the state of Washington, or to any law enforcement agency for use by that agency or its employees for law enforcement purposes, or to a person who does not reside in this state;
 - (b) The importation, distribution, offer for sale, or sale of an assault weapon by a dealer that is properly licensed under federal and state law for the purpose of sale to any branch of the armed forces of the United States or the state of Washington, or to a law enforcement agency in this state for use by that agency or its employees for law enforcement purposes;
 - (c) The distribution, offer for sale, or sale of an assault weapon to or by a dealer that is properly licensed under federal and state law where the dealer acquires the assault weapon from an individual legally authorized to possess or transfer the assault weapon for the purpose of selling or transferring the assault weapon to a person who does not reside in this state. The purpose of this section is to allow individuals who no longer wish to own an assault weapon to sell their assault weapon and is not intended to allow Washington dealers to purchase assault weapons wholesale for the purpose of selling a stock or inventory of assault weapons online or in person to nonresidents;
 - (d) The out-of-state sale or transfer of the existing stock of assault weapons owned by a licensed dealer that was acquired prior to January 1, 2023, for the limited period of 90 days after the effective date of this section;
 - (e) The receipt of an assault weapon by a person who, on or after the effective date of this section, acquires possession of the assault weapon by operation of law upon the death of the former owner who was in legal possession of the assault weapon, provided the person in possession of the assault weapon can establish such provenance. Receipt under this subsection (2)(e) is not

"distribution" under this chapter. A person who legally receives an assault weapon under this subsection (2)(e) may not sell or transfer the assault weapon to any other person in this state other than to a licensed dealer, to a federally licensed gunsmith for the purpose of service or repair, or to a law enforcement agency for the purpose of permanently relinquishing the assault weapon; or

- (f) Any person on active military duty receiving orders to move to Washington state, or military retirees moving to Washington state.
- (3) For the purposes of this section, "law enforcement agency" means any (a) general authority Washington law enforcement agency as defined in RCW 10.93.020; (b) limited authority Washington law enforcement agency as defined in RCW 10.93.020; or (c) equivalent federal, state, or local law enforcement agency in the United States.
- 14 (4) A person who violates this section is guilty of a gross 15 misdemeanor.
- NEW SECTION. Sec. 4. A new section is added to chapter 9.41 RCW to read as follows:
 - (1) The legislature finds that manufacturing, importing, distributing, selling, or offering for sale any assault weapon in violation of section 3 of this act are matters vitally affecting the public interest for the purpose of applying the consumer protection act, chapter 19.86 RCW; are not reasonable in relation to the development and preservation of business; and constitutes an unfair or deceptive act in trade or commerce and an unfair method of competition for the purpose of applying the consumer protection act, chapter 19.86 RCW.
 - (2) A violation of section 3 of this act is an unfair or deceptive act or practice or unfair method of competition in the conduct of trade or commerce for purposes of the consumer protection act, chapter 19.86 RCW.
 - (3) Any person or entity that receives a civil investigative demand issued pursuant to RCW 19.86.110 and that has an objection to answering in whole or in part may avail themselves of the procedural protections afforded in RCW 19.86.110(8). Further, the attorney general shall not share with a law enforcement agency conducting a criminal investigation any materials or information obtained via a response to a civil investigative demand issued pursuant to RCW 19.86.110 unless such information or materials are required to be disclosed pursuant to issuance of a search warrant.

- 1 NEW SECTION. Sec. 5. If any provision of this act or its application to any person or circumstance is held invalid, the 2 remainder of the act or the application of the provision to other 3 persons or circumstances is not affected. 4
- 5 <u>NEW SECTION.</u> **Sec. 6.** This act is necessary for the immediate preservation of the public peace, health, or safety, or support of 6 the state government and its existing public institutions, and takes 7 effect immediately." 8

- On page 1, line 7 of the title, after "inheritors;" strike the 9 remainder of the title and insert "reenacting and amending RCW 10 9.41.010; adding new sections to chapter 9.41 RCW; creating a new 11 section; prescribing penalties; and declaring an emergency." 12
 - EFFECT: Modifies the definition of "import" to exclude situations where an individual possesses an assault weapon when departing and returning to Washington state with the same assault weapon.
