1 On page 14, after line 33, insert the following:

2 "Sec. 5. RCW 43.330A.020 and 2020 c 313 s 3 are each amended to 3 read as follows:

4 (1) The Washington office of firearm safety and violence 5 prevention is created within the department for the purposes of 6 coordinating and promoting effective state and local efforts to 7 reduce firearm violence.

(2) The duties of the office include, but are not limited to:

9 (a) Working with law enforcement agencies, county prosecutors, researchers, and public health agencies throughout the state to 10 identify and improve upon available data sources, data collection 11 methods, and data-sharing mechanisms. The office will also identify 12 13 gaps in available data needed for ongoing analysis, policy 14 development, and the implementation of evidence-based firearm violence intervention and prevention strategies; 15

16 (b) Working with appropriate agencies to collect and annually 17 report data that specifically identifies the firearms used in gun-18 related deaths and injuries in Washington state other than suicide 19 and self-inflicted injuries. Identification should include the 20 specific caliber and type of firearm (e.g. 9 mm pistol, .38 21 revolver, .223 rifle, 12-gauge shotgun);

22 (c) Researching, identifying, and recommending legislative policy 23 options to promote the implementation of statewide evidence-based 24 firearm violence intervention and prevention strategies;

25 (((c))) <u>(d)</u> Researching, identifying, and applying for nonstate 26 funding to aid in the research, analysis, and implementation of 27 statewide firearm violence intervention and prevention strategies;

28 (((d))) <u>(e)</u> Working with the office of crime ((victim[s]))
29 <u>victims</u> advocacy to identify opportunities to better support victims
30 of firearm violence, a population that is currently underrepresented
31 among recipients of victim services;

1 (((e) Contract [Contracting])) <u>(f) Contracting</u> for a statewide 2 helpline, counseling, and referral services for victims, friends, and 3 family members impacted by gun violence and community professionals 4 and providers who engage with them;

5 (((f) Contract [Contracting])) <u>(g) Contracting</u> with the 6 University of Washington to develop a best practice guide for therapy 7 for gun violence victims;

8 (((g))) <u>(h)</u> Administering the Washington firearm violence 9 intervention and prevention grant program as outlined in RCW 10 43.330A.050.

11 (3) ((The)) Except as provided in subsection (2)(b) of this 12 section, the office shall report to the appropriate legislative 13 policy committees by December 1st every odd-numbered year on its 14 progress and findings in analyzing data, developing strategies to 15 prevent firearm violence, and recommendations for additional 16 legislative policy options. The first report must be submitted by 17 December 1, 2021."

18 Renumber the remaining sections consecutively and correct any 19 internal references accordingly.

20 On page 15, line 6, after "insert" insert "amending RCW 21 43.330A.020;"

EFFECT: Requires the Washington office of firearm safety and violence prevention to work with appropriate agencies to collect and annually report data that specifically identifies the firearms used in gun-related deaths and injuries in Washington state other than suicide and self-inflicted injuries.
