Sec. 1. The legislature finds that associate 3 "<u>NEW SECTION.</u> development organizations are critical to Washington state's economic 4 success. Associate development organizations consist of 34 regional 5 organizations servicing all of Washington's 39 counties, underpinning 6 7 Washington state's economic development programs and initiatives across the state. With a mission of confidential and client-based 8 9 economic development, associate development organizations enhance economic development service delivery and results statewide through 10 public-private and state-local partnerships. 11

12 Therefore, the legislature intends by this act to establish a 13 competitive grant program to support innovation, sustainability, 14 partnerships, and equity at associate development organizations with 15 the goal of growing jobs, expanding existing firms, recruiting new 16 businesses, and supporting an equitable economy and inclusive 17 economic development.

18 <u>NEW SECTION.</u> Sec. 2. A new section is added to chapter 43.330
19 RCW to read as follows:

20 (1) Subject to the availability of funds appropriated for this 21 specific purpose, the department shall establish an annual 22 competitive grant program to support and catalyze initiatives to 23 foster innovation, sustainability, partnerships, and equity at 24 associate development organizations. The department shall develop 25 grant award criteria with relevant stakeholders and award funding 26 based on initiatives that are aligned with its work and priorities. 27 Awards must be given equitably across the state.

(2) Grant recipients must provide the following information in their annual reports to the department, as required under RCW 30 43.330.082:

31 (a) Data on the use of the grant funds;

1 (b) Information on how the associate development organization 2 fosters equity, delivers inclusive economic development, and 3 addresses equity gaps in their communities; and

4 (c) Certain demographic data of the businesses and entrepreneurs 5 served including, but not limited to, the number of businesses and 6 entrepreneurs served that are certified by the office of minority and 7 women's business enterprises under chapter 39.19 RCW and businesses 8 and entrepreneurs not yet certified but that self-report as meeting 9 the requirements of certification.

10 (3) In order to receive grant funds, the governing boards of 11 associate development organizations must perform direct and 12 meaningful oversight and monitoring of the organizations' financial 13 activities to safeguard public resources.

14 (4) Beginning December 31, 2026, the department must include 15 information on grant award funding and use in its report to the 16 legislature on associate development organizations contracts.

17 (5) No matching funds shall be required for participation in the 18 grant program.

(6) The department shall adopt rules to implement this section.

20 <u>NEW SECTION.</u> Sec. 3. A new section is added to chapter 43.330 21 RCW to read as follows:

22 development organization innovation, The associate 23 sustainability, partnerships, and equity grant account is created in 24 the state treasury. Moneys in the account may be spent only after 25 appropriation. Revenues to the account consist of appropriations by the legislature, private contributions, and all other sources 26 27 deposited in the account. Expenditures from the account may be used only for an annual grant to associate development organizations to 28 and catalyze initiatives to foster innovation, 29 support 30 sustainability, partnerships, and equity."

<u>EFFECT:</u> (1) Requires grant recipients to provide certain information in their annual reports to the department on:

(a) How the associate development organization fosters equity, delivers inclusive economic development, and addresses equity gaps in their communities; and

(b) Certain demographic data of the businesses and entrepreneurs served including, but not limited to, the number of businesses and entrepreneurs served that are certified by the office of minority and women's business enterprises under chapter 39.19 RCW and businesses and entrepreneurs not yet certified but that self-report as meeting the requirements of certification;

(2) Requires governing boards of associate development organizations perform direct and meaningful oversight and monitoring of the organizations' financial activities to safeguard public resources in order to receive grant funds; and

(3) Establishes that no matching funds are required to participate in the grant program.
