## **ESHB 1853** - S COMM AMD By Committee on Transportation

## ADOPTED AS AMENDED 04/14/2023

- 1 Strike everything after the enacting clause and insert the 2 following:
- "NEW SECTION. Sec. 1. During the regular legislative session of 3 4 2022, the legislature passed Engrossed Substitute Senate Bill No. 5974 (chapter 182, Laws of 2022), a significant transportation 5 resources bill intended to provide needed transportation funding 6 7 throughout the state. However, since the enactment of that act, certain drafting errors and omissions were identified within the act 8 9 resulting in some provisions being enacted contrary to legislative intent. Additionally, some corrective changes were identified that 10 11 would better conform certain provisions with original legislative 12 intent. Therefore, it is the intent of the legislature to simply 13 correct manifest drafting errors and omissions and adopt corrective 14 changes in order to conform certain provisions with the original legislative intent of Engrossed Substitute Senate Bill No. 5974 15 (chapter 182, Laws of 2022). It is not the intent of the legislature 16 17 to alter the intended substantive policy enacted in Engrossed Substitute Senate Bill No. 5974 (chapter 182, Laws of 2022), but 18 rather to make certain corrective changes. 19
- 20 **Sec. 2.** RCW 46.17.015 and 2022 c 182 s 207 are each amended to 21 read as follows:
  - (1) A person who applies for a vehicle registration or for any other right to operate a vehicle on the highways of this state shall pay a 25 cent license plate technology fee in addition to any other fees and taxes required by law. The license plate technology fee must be distributed under RCW 46.68.370.
- (2) A vehicle registered under RCW 46.16A.455 or 46.17.330 is not subject to the license plate technology fee, except for a vehicle ((registered under RCW 46.16A.455(3))) subject to the fee under RCW 46.17.355.

- (1) A person who applies for a vehicle registration or for any other right to operate a vehicle on the highways of this state shall pay a 50 cent license service fee in addition to any other fees and taxes required by law. The license service fee must be distributed under RCW 46.68.220.
- (2) A vehicle registered under RCW 46.16A.455 or 46.17.330 is not subject to the license service fee, except for a vehicle ((registered under RCW 46.16A.455(3))) subject to the fee under RCW 46.17.355.
- 15 (3) The revenue <u>generated</u> from ((the license service fee imposed on vehicles registered under RCW 46.16A.455(3))) subsection (2) of this section must be deposited in the move ahead WA account created in RCW 46.68.510.
- **Sec. 4.** RCW 81.104.170 and 2019 c 273 s 12 are each amended to 20 read as follows:
  - (1) Cities that operate transit systems, county transportation authorities, metropolitan municipal corporations, public transportation benefit areas, high capacity transportation corridor areas, and regional transit authorities may submit an authorizing proposition to the voters and if approved by a majority of persons voting, fix and impose a sales and use tax in accordance with the terms of this chapter, solely for the purpose of providing high capacity transportation service.
  - (2) The tax authorized pursuant to this section is in addition to the tax authorized by RCW 82.14.030 and must be collected from those persons who are taxable by the state pursuant to chapters 82.08 and 82.12 RCW upon the occurrence of any taxable event within the taxing district.
- (a) Except for the tax imposed under (b) of this subsection by regional transit authorities that include a county with a population of more than ((one million five hundred thousand)) 1,500,000, the maximum rate of such tax must be approved by the voters and may not exceed one percent of the selling price (in the case of a sales tax)

- (b) The maximum rate of such tax that may be imposed by a 6 regional transit authority that includes a county with a population 7 of more than ((one million five hundred thousand)) 1,500,000 must be 8 approved by the voters and may not exceed 1.4 percent. If a regional 9 transit authority imposes the tax authorized under this subsection 10 11 (2) (b) in excess of 0.9 percent, the authority may not receive any 12 funds provided in omnibus transportation state grant an appropriations act except transit coordination grants created in 13 chapter 11, Laws of 2015 3rd sp. sess. and regional mobility grant 14 program funds. To be eligible to receive regional mobility grant 15 16 program funds, a regional transit authority must have adopted, at a 17 minimum, a zero-fare policy that allows passengers 18 years of age and younger to ride free of charge on all modes provided by the 18 19 authority by October 1, 2022.

- 28 **Sec. 5.** RCW 81.104.175 and 2018 c 81 s 1 are each amended to 29 read as follows:
  - (1) A regional transit authority that includes a county with a population of more than ((one million five hundred thousand)) 1,500,000 may impose a regular property tax levy in an amount not to exceed ((twenty-five)) 25 cents per ((thousand dollars)) \$1,000 of the assessed value of property in the regional transit authority district in accordance with the terms of this section.
  - (2) Any tax imposed under this section must be used for the purpose of providing high capacity transportation service, as set forth in a proposition that is approved by a majority of the registered voters that vote on the proposition.

- 1 (3) Property taxes imposed under this section may be imposed for 2 the period of time required to pay the cost to plan, design, 3 construct, operate, and maintain the transit facilities set forth in 4 the approved proposition. Property taxes pledged to repay bonds may 5 be imposed at the pledged amount until the bonds are retired. After 6 the bonds are retired, property taxes authorized under this section 7 must be:
- 8 (a) Reduced to the level required to operate and maintain the 9 regional transit authority's transit facilities; or
- 10 (b) Terminated, unless the taxes have been extended by public 11 vote.

- (4) The limitations in RCW 84.52.043 do not apply to the tax authorized in this section.
- 14 (5) The limitation in RCW 84.55.010 does not apply to the first levy imposed under this section.
  - (6) If a regional transit authority imposes the tax authorized under subsection (1) of this section, the authority may not receive any state grant funds provided in an omnibus transportation appropriations act except transit coordination grants created in chapter 11, Laws of 2015 3rd sp. sess. and regional mobility grant program funds. To be eligible to receive regional mobility grant program funds, a regional transit authority must have adopted, at a minimum, a zero-fare policy that allows passengers 18 years of age and younger to ride free of charge on all modes provided by the authority by October 1, 2022.
- 26 (7) Property taxes imposed under this section may not be imposed 27 on less than a whole parcel.
- 28 **Sec. 6.** RCW 47.04.380 and 2022 c 182 s 417 are each amended to 29 read as follows:
  - (1) The legislature finds that many communities across Washington state have not equitably benefited from investments in the active transportation network. The legislature also finds that legacy state transportation facilities designed primarily for vehicle use caused disconnections in safe routes for people who walk, bike, and roll to work and to carry out other daily activities.
- 36 (2) To address these investment gaps, <u>and to honor the legacy of</u>
  37 <u>community advocacy of Sandy Williams</u>, the <u>Sandy Williams</u> connecting
  38 communities program is established within the department. The purpose

- of the program is to improve active transportation connectivity in communities by:
- 3 (a) Providing safe, continuous routes for pedestrians, 4 bicyclists, and other nonvehicle users carrying out their daily 5 activities;
  - (b) Mitigating for the health, safety, and access impacts of transportation infrastructure that bisects communities and creates obstacles in the local active transportation network;
- 9 (c) Investing in greenways providing protected routes for a wide variety of nonvehicular users; and
  - (d) Facilitating the planning, development, and implementation of projects and activities that will improve the connectivity and safety of the active transportation network.
    - (3) The department must select projects to propose to the legislature for funding. In selecting projects, the department must consider, at a minimum, the following criteria:

  - (b) The use of minority and women-owned businesses and community-based organizations in planning, community engagement, design, and construction of the project;

- (i) Overburdened communities as defined in RCW 70A.02.010 to mean a geographic area where vulnerable populations face combined, multiple environmental harms and health impacts, and includes, but is not limited to, highly impacted communities as defined in RCW 19.405.020;

- 4 (d) Environmental health disparities, such as those indicated by 5 the diesel pollution burden portion of the Washington environmental 6 health disparities map developed by the department of health, or 7 other similar indicators;
- 8 (e) Location on or adjacent to tribal lands or locations 9 providing essential services to tribal members;
  - (f) Crash experience involving pedestrians and bicyclists; and
  - (g) Identified need by the community, for example in the state active transportation plan or a regional, county, or community plan.
  - (4) It is the intent of the legislature that the <u>Sandy Williams</u> connecting communities program comply with the requirements of chapter 314, Laws of 2021.

- (3) For the junior high and high school program, the department 9 shall contract with a nonprofit organization with relevant reach and 10 experience, including a statewide footprint; demonstrable experience 11 12 developing and managing youth-based programming serving youth of color in an after-school and/or community setting; and deploying 13 bicycling and road safety education curriculum via a train the 14 trainer model. The selected nonprofit shall use the equity-based 15 16 criteria in subsection (4) of this section to identify target 17 populations and partner organizations including, but not limited to, schools, community-based organizations, housing authorities, and 18 parks and recreation departments, that work with the eligible 19 populations of youth ages 14 to 18. Partner organizations shall 20 21 receive from the nonprofit: Education curriculum, materials, equipment including, but not limited to, bicycles, helmets, locks, 22 and lights, guidance and consultation, and initial instructor/ 23 volunteer training, as well as ongoing support. 24
  - (4) In selecting schools and partner organizations for the school-based bicycle education grant program, the department and nonprofit must consider, at a minimum, the following criteria:
  - (a) Population impacted by poverty, as measured by free and reduced lunch population or 200 percent federal poverty level;
    - (b) People of color;

- (30) "Railroad sign or signal." Any sign, signal, or device erected by authority of a public body or official or by a railroad and intended to give notice of the presence of railroad tracks or the approach of a railroad train;

- (41) "Traffic devices." All signs, signals, markings, and devices not inconsistent with this title placed or erected by authority of a public body or official having jurisdiction, for the purpose of regulating, warning, or guiding traffic;

<u>EFFECT:</u> Clarifies that to qualify for transit support grants, transit agencies may not delay or suspend the collection of certain voter-approved sales taxes.
