superior court judges. A superior court judge's benefits and one-half of the salary are paid by the state. The county pays one-half of the judge's salary.

The Board for Judicial Administration recommends the creation of new superior court judge positions based on workload analyses by the Administrative Office of the Courts.

Clark County is authorized 11 superior court judges, which was set in 2020.

**Summary of Bill:** The authorized number of superior court judges in Clark County is increased from 11 to 12.

**Appropriation:** None.

**Effective Date:** Ninety days after adjournment of session in which bill is passed.

**Staff Summary of Public Testimony (Law & Justice):** PRO: Clark County is the fastest growing county in the state. Its population is nearly equal to Spokane County but it has fewer judges. The Superior Court has made great efforts in improving its facilities and processes, but it is not enough. New laws regarding unlawful detainers and civil protection orders have greatly increased the caseload and the result has been long delays. The County Council has already committed to funding its share of a superior court judge.
