- AN ACT Relating to increasing the supply and affordability of 1 2 condominium units and townhouses as an option for homeownership; amending RCW 64.35.105, 64.50.010, 64.50.020, 64.50.040, 64.50.050, 3 64.90.250, 64.90.605, 64.90.645, 64.90.665, 64.90.670, 64.90.675, 4 5 82.45.010, 82.45.010, 82.02.060, and 58.17.060; reenacting and amending RCW 64.38.010; adding a new section to chapter 19.27 RCW; 6 7 creating a new section; providing an effective date; and providing an 8 expiration date.
- 9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 10 **Sec. 1.** RCW 64.35.105 and 2004 c 201 s 101 are each amended to 11 read as follows:
- The definitions in this section apply throughout this chapter unless the context clearly requires otherwise.
- 14 (1) "Affiliate" has the meaning in RCW 64.34.020 and 64.90.010.
- 15 (2) "Association" has the meaning in RCW 64.34.020 and 64.90.010.
- 16 (3) "Building envelope" means the assemblies, components, and 17 materials of a building that are intended to separate and protect the 18 interior space of the building from the adverse effects of exterior
- 19 climatic conditions.
- 20 (4) "Common element" has the meaning in RCW 64.34.020 and 64.90.010.

- 3 (7) "Conversion condominium" has the meaning in RCW 64.34.020 and 64.90.010.
 - (8) "Declarant" has the meaning in RCW 64.34.020 and 64.90.010.
- 6 (9) "Declarant control" has the meaning in RCW 64.34.020 and 64.90.010.
- 8 (10) "Defect" means any aspect of a condominium unit or common 9 element which constitutes a breach of the implied warranties set 10 forth in RCW 64.34.445 or 64.90.670.

 - (13) "Mediation" means a collaborative process in which two or more parties meet and attempt, with the assistance of a mediator, to resolve issues in dispute between them.
 - (14) "Mediation session" means a meeting between two or more parties to a dispute during which they are engaged in mediation.
 - (15) "Mediator" means a neutral and impartial facilitator with no decision-making power who assists parties in negotiating a mutually acceptable settlement of issues in dispute between them.
 - (16) "Person" has the meaning in RCW 64.34.020 and 64.90.010.
- 27 (17) "Public offering statement" has the meaning in RCW 64.34.410 and in chapter 64.90 RCW.
- 29 (18) "Qualified insurer" means an entity that holds a certificate 30 of authority under RCW 48.05.030, or an eligible insurer under 31 chapter 48.15 RCW.
 - (19) "Qualified warranty" means an insurance policy issued by a qualified insurer that complies with the requirements of this chapter. A qualified warranty includes coverage for repair of physical damage caused by the defects covered by the qualified warranty, except to the extent of any exclusions and limitations under this chapter.
- 38 (20) "Resale certificate" means the statement to be delivered by 39 the association under RCW 64.34.425 or chapter 64.90 RCW.

- 9 (1) "Assessment" means all sums chargeable to an owner by an association in accordance with RCW 64.38.020.
 - (2) "Baseline funding plan" means establishing a reserve funding goal of maintaining a reserve account balance above ((zero dollars)) \$0 throughout the ((thirty-year)) 30-year study period described under RCW 64.38.065.
- 15 (3) "Board of directors" or "board" means the body, regardless of 16 name, with primary authority to manage the affairs of the 17 association.
- 18 (4) "Common areas" means property owned, or otherwise maintained, 19 repaired or administered by the association.
 - (5) "Common expense" means the costs incurred by the association to exercise any of the powers provided for in this chapter.
 - (6) "Contribution rate" means, in a reserve study as described in RCW 64.38.065, the amount contributed to the reserve account so that the association will have cash reserves to pay major maintenance, repair, or replacement costs without the need of a special assessment.
- 27 (7) "Effective age" means the difference between the estimated 28 useful life and remaining useful life.
 - (8) "Electronic transmission" or "electronically transmitted" means any electronic communication not directly involving the physical transfer of a writing in a tangible medium, but that may be retained, retrieved, and reviewed by the sender and the recipient of the communication, and that may be directly reproduced in a tangible medium by a sender and recipient.
 - (9) "Full funding plan" means setting a reserve funding goal of achieving one hundred percent fully funded reserves by the end of the ((thirty-year)) 30-year study period described under RCW 64.38.065, in which the reserve account balance equals the sum of the deteriorated portion of all reserve components.

(10) "Fully funded balance" means the current value of the deteriorated portion, not the total replacement value, of all the reserve components. The fully funded balance for each reserve component is calculated by multiplying the current replacement cost of the reserve component by its effective age, then dividing the result by the reserve component's useful life. The sum total of all reserve components' fully funded balances is the association's fully funded balance.

- (11) "Governing documents" means the articles of incorporation, bylaws, plat, declaration of covenants, conditions, and restrictions, rules and regulations of the association, or other written instrument by which the association has the authority to exercise any of the powers provided for in this chapter or to manage, maintain, or otherwise affect the property under its jurisdiction.
- (12) "Homeowners' association" or "association" means a corporation, unincorporated association, or other legal entity, each member of which is an owner of residential real property located within the association's jurisdiction, as described in the governing documents, and by virtue of membership or ownership of property is obligated to pay real property taxes, insurance premiums, maintenance costs, or for improvement of real property other than that which is owned by the member. "Homeowners' association" does not mean an association created under chapter 64.32 ((er)), 64.34, or 64.90 RCW.
- (13) "Lot" means a physical portion of the real property located within an association's jurisdiction designated for separate ownership.
- (14) "Owner" means the owner of a lot, but does not include a person who has an interest in a lot solely as security for an obligation. "Owner" also means the vendee, not the vendor, of a lot under a real estate contract.
- 31 (15) "Remaining useful life" means the estimated time, in years, 32 before a reserve component will require major maintenance, repair, or 33 replacement to perform its intended function.
 - (16) "Replacement cost" means the current cost of replacing, repairing, or restoring a reserve component to its original functional condition.
- 37 (17) "Reserve component" means a common element whose cost of 38 maintenance, repair, or replacement is infrequent, significant, and 39 impractical to include in an annual budget.

- 1 (18) "Reserve study professional" means an independent person who 2 is suitably qualified by knowledge, skill, experience, training, or 3 education to prepare a reserve study in accordance with RCW 64.38.065 4 and 64.38.070.
- 5 (19) "Residential real property" means any real property, the use 6 of which is limited by law, covenant or otherwise to primarily 7 residential or recreational purposes.

- (20) "Significant assets" means that the current replacement value of the major reserve components is ((seventy-five)) 75 percent or more of the gross budget of the association, excluding the association's reserve account funds.
- 12 (21) "Tangible medium" means a writing, copy of a writing, 13 facsimile, or a physical reproduction, each on paper or on other 14 tangible material.
- 15 (22) "Useful life" means the estimated time, between years, that 16 major maintenance, repair, or replacement is estimated to occur.
- 17 **Sec. 3.** RCW 64.50.010 and 2020 c 18 s 23 are each amended to 18 read as follows:
 - Unless the context clearly requires otherwise, the definitions in this section apply throughout this chapter.
 - (1) "Action" means any civil lawsuit or action in contract or tort for damages or indemnity brought against a construction professional to assert a claim, whether by complaint, counterclaim, or cross-claim, for damage or the loss of use of real or personal property caused by a defect in the construction of a residence or in the substantial remodel of a residence. "Action" does not include any civil action in tort alleging personal injury or wrongful death to a person or persons resulting from a construction defect.
 - (2) "Association" means an association, master association, or subassociation as defined and provided for in RCW 64.34.020(4), 64.34.276, 64.34.278, and 64.38.010(((11))) (12).
 - (3) "Claimant" means a homeowner or association who asserts a claim against a construction professional concerning a defect in the construction of a residence or in the substantial remodel of a residence.

- (5) "Construction professional" means an architect, builder, builder vendor, contractor, subcontractor, engineer, or inspector, including, but not limited to, a dealer as defined in RCW 64.34.020 and a declarant as defined in RCW 64.34.020, performing or furnishing the design, supervision, inspection, construction, or observation of the construction of any improvement to real property, whether operating as a sole proprietor, partnership, corporation, or other business entity.
- (((5))) <u>(6)</u> "Homeowner" means: (a) Any person, company, firm, partnership, corporation, or association who contracts with a construction professional for the construction, sale, or construction and sale of a residence; and (b) an "association" as defined in this section. "Homeowner" includes, but is not limited to, a subsequent purchaser of a residence from any homeowner.
 - ((+6+)) (7) "Residence" means a single-family house, duplex, triplex, quadraplex, or a unit in a multiunit residential structure in which title to each individual unit is transferred to the owner under a condominium or cooperative system, and shall include common elements as defined in RCW 64.34.020 and common areas as defined in RCW 64.38.010(4).
- $((\frac{(7)}{)})$ <u>(8)</u> "Serve" or "service" means personal service or delivery by certified mail to the last known address of the addressee.
- (((8))) <u>(9)</u> "Substantial remodel" means a remodel of a residence, for which the total cost exceeds one-half of the assessed value of the residence for property tax purposes at the time the contract for the remodel work was made.
- 30 **Sec. 4.** RCW 64.50.020 and 2002 c 323 s 3 are each amended to 31 read as follows:
- 32 (1) In every construction defect action brought against a 33 construction professional, the claimant shall, no later than ((forty- 34 five)) <u>45</u> days before filing an action, serve <u>(a)</u> written notice of 35 claim <u>and (b) written defect assessment report</u> on the construction 36 professional.
- 37 <u>(i)</u> The notice of claim shall state that the claimant asserts a construction defect claim against the construction professional and

shall describe the claim in reasonable detail sufficient to determine the general nature of the defect.

- (ii) The report required in this subsection (1)(b) shall be executed under oath by a construction defect professional, or an equivalent reliable source, and shall state with particularity:
- 6 (A) The construction defect professional's qualifications,
 7 training, and experience with construction defect issues;
- 8 <u>(B) The manner and type of inspection forming the basis for the</u> 9 <u>report;</u>
 - (C) A reasonably detailed description sufficient to identify the location and nature of the defect based on the scope of the inspection, and the extent of the defect;
- 13 <u>(D) The recommended repair proposed to correct the observed</u>
 14 <u>defect; and</u>
 - (E) The construction defect professional's opinion as to the applicable code or building standard implicated by the defect.
 - (2) Within ((twenty-one)) <u>21</u> days after service of the notice of claim, the construction professional shall serve a written response on the claimant by registered mail or personal service. The written response shall:
 - (a) Propose to inspect the residence that is the subject of the claim and to complete the inspection within a specified time frame. The proposal shall include the statement that the construction professional shall, based on the inspection, offer to remedy the defect, compromise by payment, or dispute the claim;
 - (b) Offer to compromise and settle the claim by monetary payment without inspection. A construction professional's offer under this subsection (2)(b) to compromise and settle a homeowner's claim may include, but is not limited to, an express offer to purchase the claimant's residence that is the subject of the claim, and to pay the claimant's reasonable relocation costs; or
 - (c) State that the construction professional disputes the claim and will neither remedy the construction defect nor compromise and settle the claim.
 - (3) (a) If the construction professional disputes the claim or does not respond to the claimant's notice of claim within the time stated in subsection (2) of this section, the claimant may bring an action against the construction professional for the claim described in the notice of claim without further notice.

1 (b) If the claimant rejects the inspection proposal or the settlement offer made by the construction professional pursuant to subsection (2) of this section, the claimant shall serve written 3 notice of the claimant's rejection on the construction professional. 4 After service of the rejection, the claimant may bring an action 5 6 against the construction professional for the construction defect claim described in the notice of claim. If the construction 7 professional has not received from the claimant, within ((thirty)) 30 8 days after the claimant's receipt of the construction professional's response, either an acceptance or rejection of the inspection 10 11 proposal or settlement offer, then at anytime thereafter the 12 construction professional may terminate the proposal or offer by serving written notice to the claimant, and the claimant may 13 thereafter bring an action against the construction professional for 14 the construction defect claim described in the notice of claim. 15

- If the claimant elects to allow the construction professional to inspect in accordance with the construction professional's proposal pursuant to subsection (2)(a) of this section, the claimant shall provide the construction professional and its contractors or other agents reasonable access to the claimant's residence during normal working hours to inspect the premises and the claimed defect.
- (b) Within ((fourteen)) 14 days following completion of the inspection, the construction professional shall serve on the claimant:
- (i) A written offer to remedy the construction defect at no cost to the claimant, including a report of the scope of the inspection, the findings and results of the inspection, a description of the additional construction necessary to remedy the defect described in the claim, and a timetable for the completion of such construction;
- (ii) A written offer to compromise and settle the claim by monetary payment pursuant to subsection (2)(b) of this section; or
- (iii) A written statement that the construction professional will not proceed further to remedy the defect.
- (c) If the construction professional does not proceed further to remedy the construction defect within the agreed timetable, or if the construction professional fails to comply with the provisions of (b) of this subsection, the claimant may bring an action against the construction professional for the claim described in the notice of

claim and written defect assessment report under subsection (1) (b) of this section without further notice.

- (d) If the claimant rejects the offer made by the construction professional pursuant to (b)(i) or (ii) of this subsection to either remedy the construction defect or to compromise and settle the claim by monetary payment, the claimant shall serve written notice of the claimant's rejection on the construction professional. After service of the rejection notice, the claimant may bring an action against the construction professional for the construction defect claim described in the notice of claim and written defect assessment report under subsection (1)(b) of this section. If the construction professional has not received from the claimant, within ((thirty)) 30 days after the claimant's receipt of the construction professional's response, either an acceptance or rejection of the offer made pursuant to (b)(i) or (ii) of this subsection, then at anytime thereafter the construction professional may terminate the offer by serving written notice to the claimant.
- (5)(a) Any claimant accepting the offer of a construction professional to remedy the construction defect pursuant to subsection (4)(b)(i) of this section shall do so by serving the construction professional with a written notice of acceptance within a reasonable time period after receipt of the offer, and no later than ((thirty)) 30 days after receipt of the offer. The claimant shall provide the construction professional and its contractors or other agents reasonable access to the claimant's residence during normal working hours to perform and complete the construction by the timetable stated in the offer.
- (b) The claimant and construction professional may, by written mutual agreement, alter the extent of construction or the timetable for completion of construction stated in the offer, including, but not limited to, repair of additional defects.
- (6) Any action commenced by a claimant prior to compliance with the requirements of this section shall be subject to dismissal without prejudice, and may not be recommenced until the claimant has complied with the requirements of this section.
- (7) Nothing in this section may be construed to prevent a claimant from commencing an action on the construction defect claim described in the notice of claim and written defect assessment report under subsection (1)(b) of this section if the construction professional fails to perform the construction agreed upon, fails to

- 3 (8) Prior to commencing any action alleging a construction defect, or after the dismissal of any action without prejudice 4 pursuant to subsection (6) of this section, the claimant may amend 5 6 the notice of claim to include construction defects discovered after the service of the original notice of claim, and must otherwise 7 comply with the requirements of this section for the additional 8 claims including amending the written defect assessment report under 9 subsection (1)(b) of this section. The service of an amended notice 10 of claim shall relate back to the original notice of claim for 11 12 purposes of tolling statutes of limitations and repose. Claims for defects discovered after the commencement or recommencement of an 13 action may be added to such action only after providing notice to the 14 construction professional of the defect, the amended written defect 15 16 assessment report, and allowing for response under subsection (2) of 17 this section.

 - (2) The notice required by this subsection shall be in substantially the following form:
 - CHAPTER 64.50 RCW CONTAINS IMPORTANT REQUIREMENTS YOU MUST FOLLOW BEFORE YOU MAY FILE A LAWSUIT FOR DEFECTIVE CONSTRUCTION AGAINST THE SELLER OR BUILDER OF YOUR HOME. FORTY-FIVE DAYS BEFORE YOU FILE YOUR LAWSUIT, YOU MUST DELIVER TO THE SELLER OR BUILDER A WRITTEN NOTICE OF ANY CONSTRUCTION CONDITIONS YOU ALLEGE ARE DEFECTIVE, A WRITTEN DEFECT NOTICE REPORT PURSUANT TO RCW 64.50.020(1)(b), AND PROVIDE YOUR SELLER OR BUILDER THE OPPORTUNITY TO MAKE AN OFFER TO REPAIR OR PAY FOR THE DEFECTS. (a) If the declarant converts the unit entirely into common elements, the amendment to the declaration must reallocate all the allocated interests of that unit among the other units as if that unit had been taken by condemnation under RCW 64.90.030; or

- (b) If the declarant subdivides the unit into two or more units, whether or not any part of the unit is converted into common elements, the amendment to the declaration must reallocate all the allocated interests of the unit among the units created by the subdivision in any reasonable manner prescribed by the declarant.
- (4) If the declaration provides, pursuant to RCW 64.90.225(1)(h), that all or a portion of the real estate is subject to a right of withdrawal:
 - (a) If all the real estate is subject to withdrawal, and the declaration or map or amendment to the declaration or map does not describe separate portions of real estate subject to that right, none of the real estate may be withdrawn if a unit in that real estate has been conveyed to a purchaser; or
 - (b) If any portion of the real estate is subject to withdrawal as described in the declaration or map or amendment to the declaration or map, none of that portion of the real estate may be withdrawn if a unit in that portion has been conveyed to a purchaser.
