- 1 AN ACT Relating to creating the purple star award; adding a new
- 2 section to chapter 28A.625 RCW; and creating a new section.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- MEW SECTION. Sec. 1. A new section is added to chapter 28A.625 RCW to read as follows:
- 6 The purple star award is created to recognize school 7 districts and schools that demonstrate educational and socialemotional supports to students of military service members as they 8 face transitions to a new school. School districts that earn the 9 10 award will receive a special purple star recognition to display on 11 The office of the superintendent of public instruction may 12 collaborate with a state agency or nonprofit organization that has 13 experience serving the needs of а diverse K-12 population 14 establish and administer the award. A school district must considered for the purple star award if it applies and completes all 15 the required activities and at least one optional activity listed in 16 17 this section.
- 18 (b) A school district must complete the following required 19 activities to be considered to receive the purple star award:
- 20 (i) The school district must have a staff point of contact for 21 military students and families. The staff point of contact must:

1 (A) Work jointly with the state military family education liaison 2 under RCW 28A.705.010, article VIII to serve military families;

- (B) Serve as the primary liaison between military families and the school district;
- 5 (C) Complete professional development on special considerations 6 for military students and families under relevant state and federal 7 law; and
 - (D) Identify and inform teachers of military-connected students in their classrooms and the special considerations military families and students should receive under the interstate compact on educational opportunity for military children under RCW 28A.705.010; and
- 13 (ii) The school district maintains a dedicated page on its 14 website featuring resources for military families.
- 15 (c) A school district must complete at least one of the following 16 optional activities to be considered to receive the purple star 17 award:
- 18 (i) The school district provides professional development for 19 additional staff on special considerations for military students and 20 families;
- 21 (ii) The school district board of directors passes a resolution 22 publicizing the school district's support for military children and 23 families; or
- 24 (iii) The school district hosts a military recognition event that 25 demonstrates a military friendly culture.
 - (2) The office of the superintendent of public instruction must make available on its website:
 - (a) A simple application for a school district to submit for consideration to receive a purple star award. The application must require evidence of meeting each of the required activities under subsection (1)(b) of this section and at least one optional activity under subsection (1)(c) of this section necessary to receive the purple star award;
- 34 (b) A timeline for submittal of an application for consideration 35 and for announcement of the award recipients; and
- 36 (c) The criteria being used to review the applications received 37 and determine which school districts receive the award.
- 38 (3) The purple star award shall be awarded every two years, 39 beginning in 2024.
