1 AN ACT Relating to defining frontier counties; and amending RCW 2 43.160.020, 43.330.010, and 82.02.010.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 Sec. 1. RCW 43.160.020 and 2012 c 225 s 3 are each amended to 5 read as follows:

6 Unless the context clearly requires otherwise, the definitions in 7 this section apply throughout this chapter.

8 9 (1) "Board" means the community economic revitalization board.

(2) "Department" means the department of commerce.

(3) "Frontier county" means a county with a population density of less than 50 persons per square mile as determined by the office of financial management and published each year by the department. Every frontier county is also a rural county under this chapter and eligible for all benefits, services, and programs of a rural county unless a frontier county is specifically excluded in the authorizing statute.

17 <u>(4)</u> "Local government" or "political subdivision" means any port 18 district, county, city, town, special purpose district, and any other 19 municipal corporations or quasi-municipal corporations in the state 20 providing for public facilities under this chapter.

1 ((((++))) (5) "Public facilities" means a project of a local government or a federally recognized Indian tribe for the planning, 2 acquisition, construction, repair, reconstruction, replacement, 3 rehabilitation, or improvement of: Bridges; roads; research, testing, 4 training, and incubation facilities in areas designated as innovation 5 6 partnership zones under RCW 43.330.270; buildings or structures; 7 domestic and industrial water, earth stabilization, sanitary sewer, sewer, railroad, electricity, telecommunications, 8 storm transportation, natural gas, and port facilities; all for the purpose 9 of job creation, job retention, or job expansion. 10

11 (((5))) (6) "Rural county" means a county with a population 12 density of fewer than ((one hundred)) 100 persons per square mile or 13 a county smaller than ((two hundred twenty-five)) 225 square miles, 14 as determined by the office of financial management and published 15 each year by the department for the period July 1st to June 30th.

16 Sec. 2. RCW 43.330.010 and 2021 c 39 s 3 are each amended to 17 read as follows:

18 Unless the context clearly requires otherwise, the definitions in 19 this section apply throughout this chapter.

20 (1) "Associate development organization" means a local economic 21 development nonprofit corporation that is broadly representative of 22 community interests.

(2) "Department" means the department of commerce.

(3) "Director" means the director of the department of commerce.

(4) "Family resource center" means a unified single point of entry where families, individuals, children, and youth in communities can obtain information, an assessment of needs, referral to, or direct delivery of family services in a manner that is welcoming and strength-based.

(a) A family resource center is designed to meet the needs,
cultures, and interests of the communities that the family resource
center serves.

33 (b) Family services may be delivered directly to a family at the 34 family resource center by family resource center staff or by 35 providers who contract with or have provider agreements with the 36 family resource center. Any family resource center that provides 37 family services shall comply with applicable state and federal laws 38 and regulations regarding the delivery of such family services,

unless required waivers or exemptions have been granted by the
appropriate governing body.

3 (c) Each family resource center shall have one or more family 4 advocates who screen and assess a family's needs and strengths. If 5 requested by the family, the family advocate shall assist the family 6 with setting its own goals and, together with the family, develop a 7 written plan to pursue the family's goals in working towards a 8 greater level of self-reliance or in attaining self-sufficiency.

9 (5) "Financial institution" means a bank, trust company, mutual 10 savings bank, savings and loan association, or credit union 11 authorized to do business in this state under state or federal law.

12 (6) <u>"Frontier county" means a county with a population density of</u> 13 less than 50 persons per square mile as determined by the office of 14 financial management and published each year by the department. Every 15 frontier county is also a rural county under this chapter and 16 eligible for all benefits, services, and programs of a rural county 17 unless a frontier county is specifically excluded in the authorizing 18 statute.

19 <u>(7)</u> "Small business" has the same meaning as provided in RCW 20 39.26.010.

21 Sec. 3. RCW 82.02.010 and 2022 c 16 s 137 are each amended to 22 read as follows:

For the purpose of this title, unless the context clearly requires otherwise:

(1) "Cannabis," "cannabis-infused products," and "useable cannabis" have the meanings provided in RCW 69.50.101;

(2) "Department" means the department of revenue of the state ofWashington;

(3) "Director" means the director of the department of revenue ofthe state of Washington;

(4) "Frontier county" means a county with a population density of less than 50 persons per square mile as determined by the office of financial management and published each year by the department. Every frontier county is also a rural county as defined in RCW 82.14.370 and eligible for all benefits, services, and programs unless a frontier county is specifically excluded in the authorizing statute;

37 <u>(5)</u> "Taxpayer" includes any individual, group of individuals, 38 corporation, or association liable for any tax or the collection of 39 any tax hereunder, or who engages in any business or performs any act

1 for which a tax is imposed by this title. "Taxpayer" also includes 2 any person liable for any fee or other charge collected by the 3 department under any provision of law, including registration 4 assessments and delinquency fees imposed under RCW 59.30.050; and

5 (((5))) <u>(6)</u> Words in the singular number include the plural and 6 the plural include the singular. Words in one gender include all 7 other genders.
