AN ACT Relating to administration of the southwest Washington fair by the Lewis county board of county commissioners; and amending RCW 36.90.010, 36.90.020, 36.90.030, 36.90.050, and 36.90.070.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 36.90.010 and 1998 c 107 s 1 are each amended to 6 read as follows:

7 The property of the Southwest Washington Fair Association 8 including the buildings and structures thereon, as constructed or as 9 may be built or constructed from time to time, or any alterations or 10 additions thereto, shall be under the jurisdiction of Lewis county. 11 That property will be under the management and control of the board 12 of county commissioners of Lewis county or that board's designee, for 13 <u>fair and county purposes</u>.

14 Sec. 2. RCW 36.90.020 and 1973 1st ex.s. c 97 s 2 are each 15 amended to read as follows:

16 The southwest Washington fair commission heretofore established 17 and authorized under the provisions of this chapter is abolished and 18 all rights, duties and obligations of such commission is devolved 19 upon the board of county commissioners of Lewis county and title to 20 or all interest in real estate, choses in action and all other assets, including but not limited to assignable contracts, cash, deposits in county funds (including any interest or premiums thereon), equipment, buildings, facilities, and appurtenances thereto held as of the date of passage of this 1973 amendatory act by or for the commission shall, on the effective date of this 1973 amendatory act vest in Lewis county <u>for fair and county purposes</u>.

7 Sec. 3. RCW 36.90.030 and 2009 c 549 s 4149 are each amended to 8 read as follows:

9 The board of county commissioners in the county of Lewis as 10 administrators of all property relating to the southwest Washington 11 fair may elect to appoint either (1) a designee, whose operation and funds the board may control and oversee, to carry out the board's 12 duties and obligations as set forth in RCW 36.90.020, or (2) a 13 commission of citizens to advise and assist in carrying out such 14 15 fair. The chair of the board of county commissioners of Lewis county 16 may elect to serve as chair of any such commission. Such commission may elect a president and secretary and define their duties and fix 17 18 their compensation, and provide for the keeping of its records. The commission may also designate the treasurer of Lewis county as fair 19 treasurer. The funds relating to fair activities ((shall be kept 20 separate and apart from the)) shall be managed and accounted for as 21 22 are other funds of Lewis county((, but shall be deposited in the 23 regular depositaries of Lewis county and all interest earned thereby 24 shall be added to and become a part of the funds. Fair funds shall be 25 audited as are other county funds)).

26 Sec. 4. RCW 36.90.050 and 1998 c 107 s 3 are each amended to 27 read as follows:

The Lewis county board of county commissioners may acquire by 28 29 gift, exchange, devise, lease, or purchase, real property for 30 southwest Washington fair purposes or joint fair and county purposes, 31 and may construct and maintain temporary or permanent improvements suitable and necessary for the purpose of holding and maintaining the 32 southwest Washington fair or other county uses of the fairgrounds. 33 Any such property deemed surplus by the board may be (1) sold at 34 private sale after notice in a local publication of general 35 circulation, or (2) exchanged for other property after notice in a 36 37 local publication of general circulation, under Lewis county property 38 management regulations.

1 Sec. 5. RCW 36.90.070 and 1973 1st ex.s. c 97 s 6 are each 2 amended to read as follows:

3 Upon payment to the state of Washington by Lewis county of the sum of one dollar, which sum shall be deposited in the general fund 4 when received by the treasurer of the state of Washington, such 5 6 treasurer is authorized and directed to certify to the governor and 7 secretary of state that such payment has been made on the following described property presently utilized for southwest Washington fair 8 purposes situated in Lewis county, Washington: "Beginning at the 9 intersection of the south line of section Seventeen (17) Township 10 Fourteen (14) North of Range Two (2) West of W.M. with the West 11 12 right-of-way line of the Somerville consent Road, and running thence North 15 degrees 20 feet East along the West line of said Road, 13 Eleven Hundred Forty-four (1144) feet, thence North 2 degrees 33 feet 14 West along the said west line Seventy-four and four-tenths (74.4) 15 16 feet, thence west on a line parallel with the said south line of said 17 Section Seventeen (17) Eleven Hundred Sixty-seven and two tenths 18 (1167.2) feet to within one hundred fifty (150) feet to the Center 19 line of the Northern Pacific Railroad, thence south 16 degrees 20 feet West on a line parallel with and one hundred fifty (150) feet 20 21 distant Easterly from the Center line of the Northern Pacific Railroad Eleven Hundred and Thirty-five and seven-tenths (1135.7) 22 23 feet, thence East on a line parallel with and Eighty-seven and threetenths (87.3) feet north of the south line of said section seventeen 24 25 (17) eight hundred fifty-seven (857) feet, thence south 74 degrees 40 feet East three hundred thirty (330) feet to the point of beginning, 26 containing thirty (30) acres in Section Seventeen (17) Township 27 Fourteen (14) North of Range Two (2) West of W.M." and the governor 28 is thereby authorized and directed forthwith to execute and the 29 secretary of state is authorized and directed to attest to a deed 30 31 conveying said lands to Lewis county, Washington. The office of the 32 attorney general and the commissioner of public lands shall offer any 33 necessary assistance in carrying out such conveyance. This conveyance shall be understood to have no use restrictions and to give Lewis 34 county control of the property for fair and county purposes as set 35 36 forth in this chapter.
