1 WHEREAS, Former Representative James Carl (Jim) Moeller was a 2 native of Vancouver who spent more than two decades in elected 3 office, serving two terms as a Vancouver City Council member and 14 4 years as a state representative from Washington's 49th legislative 5 district; and

6 WHEREAS, Jim was a proud graduate of Fort Vancouver High School, 7 Washington State University, and the Mark Hatfield School of 8 Government at Portland State University; and

9 WHEREAS, He used his education in a career as a social worker, 10 behavioral health counselor, and chemical dependency counselor, 11 helping others to overcome significant hurdles and lead full, free 12 lives; and

13 WHEREAS, In 2002, as he approached the end of his second fouryear term on the Vancouver City Council, Jim looked north toward 14 Olympia and, after a successful campaign, was sworn in for the first 15 16 of his seven two-year terms representing his southwest Washington 17 friends neighbors in the Washington and State House of 18 Representatives; and

WHEREAS, During the last three of those seven two-year terms in the Legislature, Jim served as Speaker Pro Tempore of the House of Representatives, a leadership position to which he was elected by the full membership of the House; and 1 WHEREAS, In his position as Speaker Pro Tem, he presided over an 2 estimated 80 percent of the House floor debates and votes that 3 occurred from 2011 to 2016, gaining a reputation for wielding the 4 gavel with impartiality, respect for the institution and its elected 5 members, and a deep concern for the integrity of the legislative 6 process; and

7 WHEREAS, In addition to his duties as Speaker Pro Tem, which earned him the affectionate nickname of "Mr. Speaker," Jim played a 8 part in developing and passing some of the most significant pieces of 9 legislation enacted during his tenure in the House, serving as a 10 11 member of the House committees on Rules, Transportation, Labor & 12 Workforce Development, Community and Economic Development & Trade, and, appropriately given his lifelong career, Healthcare & Wellness; 13 14 and

15 WHEREAS, Jim worked throughout much of his legislative tenure to 16 make progress on replacing the aging bridge on Interstate 5 linking 17 Washington and Oregon; and

WHEREAS, His dedication to his community and his state was 18 apparent in countless ways, including service as cochair of the Joint 19 Committee on Veterans & Military Affairs, cochair of the Senate/House 20 Joint Taskforce on Public Health Financing, honorary board member of 21 22 the Big Brothers/Big Sisters, vice chair of the Association of Washington Cities, member of the YWCA Diversity Task Force, founding 23 member of Clark County Pride, and a founding member of Hands Off 24 25 Washington, and many others; and

26 WHEREAS, Jim was a proud gay man who worked tirelessly in the 27 Legislature and in his private life to help Washingtonians realize 28 the goal of marriage equality which became the law of the land on 29 December 6, 2012; and

30 WHEREAS, Jim was himself the target of discrimination based on 31 his choosing to live a life of public service as an out gay man, but 32 never lost his conviction that government was his highest calling, 33 often reminding others of President John F. Kennedy's quote, "Let the 34 public service be a proud and honorable profession"; and

35 WHEREAS, Jim Moeller, "Mr. Speaker," with his ever-present bow 36 tie, gentle smile, and twinkling eye, was himself an institution 37 within the institution of government that he loved, served, and 38 improved in countless ways;
