1 AN ACT Relating to firearm theft; amending RCW 9.94A.515 and
2 9.94A.589; adding a new section to chapter 9A.56 RCW; and prescribing
3 penalties.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 NEW SECTION. **Sec. 1.** A new section is added to chapter 9A.56
6 RCW to read as follows:

7 (1) A person is guilty of theft of a firearm from a residence,
8 store, shop, sales outlet, or vehicle if he or she commits a theft of
9 any firearm from a residence, store, shop, or sales outlet where
10 firearms are sold, or from any vehicle.

11 (2) This section applies regardless of the value of the firearm
12 taken in the theft.

13 (3) Each firearm taken in the theft under this section is a
14 separate offense.

15 (4)(a) For the purposes of this section, "theft" has the same
16 meaning as defined in RCW 9A.56.020.

17 (b) The defense allowed against the prosecution for theft under
18 RCW 9A.56.020 shall apply to the crime of theft of a firearm.

19 (5) For the purposes of this section:

20 (a) "Firearm" means any firearm as defined in RCW 9.41.010.

21 (b) "Vehicle" means any vehicle as defined in RCW 46.04.670.

1 (6) Theft of a firearm from a residence, store, shop, sales
2 outlet, or vehicle is a class B felony.

32 **Sec. 3.** RCW 9.94A.589 and 2020 c 276 s 1 are each amended to
33 read as follows:

34 (1) (a) Except as provided in (b), (c), or (d) of this subsection,
35 whenever a person is to be sentenced for two or more current
36 offenses, the sentence range for each current offense shall be

1 determined by using all other current and prior convictions as if
2 they were prior convictions for the purpose of the offender score:
3 PROVIDED, That if the court enters a finding that some or all of the
4 current offenses encompass the same criminal conduct then those
5 current offenses shall be counted as one crime. Sentences imposed
6 under this subsection shall be served concurrently. Consecutive
7 sentences may only be imposed under the exceptional sentence
8 provisions of RCW 9.94A.535. "Same criminal conduct," as used in this
9 subsection, means two or more crimes that require the same criminal
10 intent, are committed at the same time and place, and involve the
11 same victim. This definition applies in cases involving vehicular
12 assault or vehicular homicide even if the victims occupied the same
13 vehicle.

14 (b) Whenever a person is convicted of two or more serious violent
15 offenses arising from separate and distinct criminal conduct, the
16 standard sentence range for the offense with the highest seriousness
17 level under RCW 9.94A.515 shall be determined using the offender's
18 prior convictions and other current convictions that are not serious
19 violent offenses in the offender score and the standard sentence
20 range for other serious violent offenses shall be determined by using
21 an offender score of zero. The standard sentence range for any
22 offenses that are not serious violent offenses shall be determined
23 according to (a) of this subsection. All sentences imposed under this
24 subsection (1)(b) shall be served consecutively to each other and
25 concurrently with sentences imposed under (a) of this subsection.
26 Even if the court orders the confinement terms to run consecutively
27 to each other, the terms of community custody shall run concurrently
28 to each other, unless the court expressly orders the community
29 custody terms to run consecutively to each other.

30 (c) If an offender is convicted under RCW 9.41.040 for unlawful
31 possession of a firearm in the first or second degree and for ~~((the))~~
32 one or more of the following felony crimes ~~((of theft))~~: (i) Theft of
33 a firearm; or (ii) theft of a firearm from a residence, store, shop,
34 sales outlet, or vehicle (section 1 of this act); or (iii) possession
35 of a stolen firearm, ~~((or both,))~~ the standard sentence range for
36 each of these current offenses shall be determined by using all other
37 current and prior convictions, except other current convictions for
38 the felony crimes listed in this subsection (1)(c), as if they were
39 prior convictions. The offender shall serve consecutive sentences for

1 each conviction of the felony crimes listed in this subsection
2 (1)(c), and for each firearm unlawfully possessed.

3 (d) All sentences imposed under RCW 46.61.502(6), 46.61.504(6),
4 or 46.61.5055(4) shall be served consecutively to any sentences
5 imposed under RCW 46.20.740 and 46.20.750.

6 (2)(a) Whenever a person while under sentence for conviction of a
7 felony commits another felony and is sentenced to another term of
8 confinement, the latter term of confinement shall not begin until
9 expiration of all prior terms of confinement. However, any terms of
10 community custody shall run concurrently to each other, unless the
11 court pronouncing the current sentence expressly orders that they be
12 served consecutively.

13 (b) Whenever a second or later felony conviction results in
14 consecutive community custody with conditions not currently in
15 effect, under the prior sentence or sentences of community custody,
16 the court may require that the conditions of community custody
17 contained in the second or later sentence begin during the immediate
18 term of community custody and continue throughout the duration of the
19 consecutive term of community custody.

20 (3) Subject to subsections (1) and (2) of this section, whenever
21 a person is sentenced for a felony that was committed while the
22 person was not under sentence for conviction of a felony, the
23 sentence shall run concurrently with any felony sentence which has
24 been imposed by any court in this or another state or by a federal
25 court subsequent to the commission of the crime being sentenced
26 unless the court pronouncing the current sentence expressly orders
27 that the confinement terms be served consecutively to each other.
28 Even if the court orders the confinement terms to run consecutively
29 to each other, the terms of community custody shall run concurrently
30 to each other, unless the court expressly orders the community
31 custody terms to run consecutively to each other.

32 (4) Whenever any person granted probation under RCW 9.95.210 or
33 9.92.060, or both, has the probationary sentence revoked and a prison
34 sentence imposed, that sentence shall run consecutively to any
35 sentence imposed pursuant to this chapter, unless the court
36 pronouncing the subsequent sentence expressly orders that they be
37 served concurrently.

38 (5) In the case of consecutive sentences, all periods of total
39 confinement shall be served before any partial confinement, community
40 restitution, community supervision, or any other requirement or

1 conditions of any of the sentences. Except for exceptional sentences
2 as authorized under RCW 9.94A.535, if two or more sentences that run
3 consecutively include periods of community supervision, the aggregate
4 of the community supervision period shall not exceed twenty-four
5 months.
