1 AN ACT Relating to establishing the office of career connect
2 Washington; amending RCW 28C.30.020, 28C.30.030, 28C.30.040,
3 28C.30.050, 28C.30.060, 28C.30.070, and 28B.77.005; adding a new
4 chapter to Title 28B RCW; and recodifying RCW 28C.30.020, 28C.30.030,
5 28C.30.040, 28C.30.050, 28C.30.060, and 28C.30.070.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7 NEW SECTION. **Sec. 1.** (1) The office of career connect
8 Washington is created within the student achievement council.

9 (2) The purpose of the office is to:

10 (a) Advance, promote, and oversee implementation of the career
11 connect Washington vision to create and sustain a statewide system
12 for career connected learning that is demand-driven and leads
13 Washington's residents towards a career pathway, and ensures
14 residents obtain a postsecondary credential, economic self-
15 sufficiency, and fulfillment;

16 (b) Lead and staff the career connected learning cross-agency
17 work group established in RCW 28C.30.030 (as recodified by this act);

18 (c) Measure performance of career connected activities and ensure
19 funding dedicated to career connected learning is increasing student
20 enrollment, retention, completion, successful postcompletion

1 outcomes, including employment status, wage levels, ongoing education
2 enrollment, and degree completion, and closing equity gaps.

3 **Sec. 2.** RCW 28C.30.020 and 2019 c 406 s 57 are each amended to
4 read as follows:

5 The definitions in this section apply throughout this chapter
6 unless the context clearly requires otherwise.

7 (1) "~~Career ((awareness and exploration" means programs,))~~
8 explore" are programs, activities, and events that provide early
9 exposure to jobs and industries. (~~"Career awareness and exploration"~~
10 ~~are~~) Examples of "career explore" include structured programs that
11 include job fairs, guest speakers, job shadows, jobsite tours, and
12 other similar activities.

13 (2) "Career connected learning" (~~means~~) is a learning
14 experience that is integrated with work-related content and skills in
15 the following three categories: (a) Career (~~awareness and~~
16 ~~exploration~~) explore; (b) career (~~preparation~~) prep; and (c)
17 career launch. "Career connected learning" includes work-integrated
18 learning and work-integrated experiences.

19 (3) "Career connected learning coordinators" are the full-time
20 equivalent employees in each of the nine educational service
21 districts to support the expansion of career connected learning
22 opportunities.

23 (4)(a) "~~Career launch((programs" means))~~" are registered
24 apprenticeships and programs that combine the following three
25 elements:

26 (i) Supervised paid work experience;

27 (ii) Aligned classroom learning to academic and employer
28 standards. For career launch (~~programs~~) involving the K-12 system,
29 aligned classroom learning must meet educational requirements and
30 standards of the office of the superintendent of public instruction;
31 and

32 (iii) Culmination in a valuable credential beyond a high school
33 diploma or (~~forty-five~~) 45 college credits towards a two-year or
34 four-year postsecondary credential and preparation for employment.

35 (b) "Career launch (~~programs~~)" includes the elements in (a) of
36 this subsection and may be achieved through, but are not limited to,
37 one or more of the following:

1 (i) Registered apprenticeships as approved by the Washington
2 state apprenticeship and training council at the department of labor
3 and industries;

4 (ii) A state-approved career and technical education sequence of
5 courses or program of study that include requirements in alignment
6 with RCW 28A.700.030;

7 ~~((iii))~~ (iii) A qualifying degree or credential earned through a
8 community or technical college or university.

9 (c) "Career launch ~~((programs))~~" may be initiated in a secondary
10 education system and completed in a postsecondary education system,
11 or first year of paid employment, as long as all parties jointly plan
12 the program.

13 (d) "Career launch ~~((programs))~~" must be endorsed through the
14 process created under RCW 28C.30.040(1)(a) (as recodified by this
15 act).

16 ~~((4))~~ (5) "Career ~~((preparation programs"~~ means programs that
17 ~~give students hands-on skills and knowledge experience within a~~
18 ~~particular business, career track, or industry, and help prepare~~
19 ~~students to work in a professional setting)) prep" are programs that
20 provide students with introductory knowledge, skills, and/or
21 abilities specific to high-demand industry sectors or career
22 pathways; educate students on the necessary training or process
23 required to enter entry-level positions or complete further training
24 or education within the industry sector or pathway; and ensure
25 students can make an informed decision about whether to continue
26 training within the industry sector or pathway. "Career ~~((preparation~~
27 ~~programs)) prep"~~ includes career and technical education courses, on-
28 site internships, preapprenticeship programs, and other similar
29 opportunities.~~

30 ~~((5))~~ (6) "Complete Washington" means the program established
31 in the 2018 omnibus operating appropriations act, section 117,
32 chapter 299, Laws of 2018, for the purpose of connecting prior
33 learning with postsecondary degree completion.

34 ~~((6))~~ (7) "Industry sector leaders" may include industry
35 associations, centers of excellence, workforce development
36 organizations, community-based organizations, and other entities that
37 demonstrate the ability to implement career connected activities
38 within a targeted industry sector.

39 (8) "Office" means the office of career connect Washington
40 created in section 1 of this act.

1 (9) "Work group" means the career connected learning cross-agency
2 work group established in RCW 28C.30.030 (as recodified by this act).

3 ~~((7))~~ (10) "Work-integrated learning" has the meaning provided
4 in RCW 28A.630.135.

5 **Sec. 3.** RCW 28C.30.030 and 2019 c 406 s 54 are each amended to
6 read as follows:

28 up and expand high quality career connected learning opportunities in
29 communities across the state; and

30 (d) Implement strategies to ensure career connected pathways are
31 accessible and equitable.

32 (2) The office shall staff the work group.

33 (3) The work group must consist of, but is not limited to,
34 representatives from the following offices and agencies:

35 (a) The department of labor and industries in consultation with
36 the regulatory apprenticeship council under RCW 49.04.010;

37 (b) The department of social and health services, including the
38 division of vocational rehabilitation;

1 (c) The work-integrated learning advisory committee established
2 in RCW 28A.300.196 or its successor;

3 (d) The education research and data center at the office of
4 financial management;

5 (e) The employment security department;

6 (f) The office of the superintendent of public instruction;

7 (g) The state board of education;

8 (h) The state board for community and technical colleges;

11 ~~((k))~~ (j) One representative of the public baccalaureate

27 establish subcommittees of the work group to plan and execute the

31 (a) Coordinate its strategies and actions related to the common
32 schools with the recommendations of the work-integrated learning
33 advisory committee;

34 (b) Support and coordinate the work of the career connected
35 learning coordinators;

36 (c) Prepare an annual work plan for each office or state agency
37 in the work group that includes intended goals and indicators to
38 measure progress as it relates to increasing career connected
39 learning access and completion. Each office or state agency shall

1 share relevant data and work plans, and report on progress to the
2 office and the work group;

3 (d) Meet at least ((six)) four times during the calendar year;
4 and

5 ((e)) (e) Report progress to the governor and appropriate
6 committees of the legislature by ((September 1st)) November 1st
7 annually.

12 programs, or college credit in postsecondary programs and registered
13 apprenticeships, and work to expand the portability of credits to the
14 maximum extent possible;

15 ~~((j))~~ (k) With respect to the portability of credit for the
16 purposes of postsecondary degree attainment, the career connected
17 learning ~~((cross-agency))~~ cross-agency work group shall coordinate
18 when appropriate with the complete Washington program;

19 ~~((k))~~ (l) Establish clear targets for equity to guide state
20 data development and action by regional partners related to program
21 design and expansion, including specific equity-focused criteria
22 within grant funding processes and strategies; and

23 ~~((l))~~ (m) Develop data systems and protocols for career
24 connected learning planning and evaluation purposes;

25 (2) By September 1, 2019, and by each September 1st thereafter,
26 make budget recommendations to the office of financial management, to
27 direct resources to education programs for career connected learning
28 as follows:

29 (a) Support the K-12 system and the office of the superintendent
30 of public instruction to increase student participation in career
31 connected learning and work-integrated learning programs that include
32 career ~~((awareness and exploration))~~ explore, career ~~((preparation))~~
33 prep, and career launch;

34 (b) Support expansion of innovative program design in registered
35 apprenticeships, year-round and summer programs, and equitable access
36 to dual credit;

37 (c) Support two-year and four-year institutions of higher
38 education to expand career connected learning enrollments, and
39 specifically:

1 (i) Build capacity at community and technical colleges to support
2 innovative design in career launch (~~((and registered apprenticeship~~
3 ~~programs))~~), as well as program participation by high school graduates
4 or out-of-school youth;

5 (ii) Align the use of work-study to support career launch (~~((and~~
6 ~~registered apprenticeship programs))~~); and

7 (iii) Clarify financial aid eligibility and exclusions from
8 financial aid caps for career launch (~~((and registered apprenticeship~~
9 ~~programs))~~);

10 (d) Promote innovation in equivalency and credentialing within
11 endorsed career launch (~~((and registered apprenticeship programs))~~);

12 (e) Expand the number of portable credits and credit for prior
13 learning to ensure that career launch (~~((programs))~~) transfer for high
14 school or college credit to the maximum extent possible; and

15 (f) Support the registered apprenticeship system and the
16 department of labor and industries to build capacity to expand
17 registered apprenticeship and preapprenticeship programs;

18 (3) Support regional leadership, (~~((program intermediaries))~~)
19 industry sector leaders, and career connected learning and work-
20 integrated learning navigation and coordination to expand
21 participation in career connected learning and work-integrated
22 learning opportunities and the implementation of the career connected
23 learning grant program established in RCW 28C.30.050 (as recodified
24 by this act);

25 (4) Support the formation and operation of regional networks in
26 both rural and urban areas to guide career connected learning and
27 work-integrated learning opportunities that are both tailored to the
28 local needs of students and employers, and designed for portable
29 credentials across education settings and across an industry; and

30 (5) Develop and maintain a data enclave for career connected
31 learning and work-integrated learning to measure progress and ensure
32 equity of opportunity for career connected learning and work-
33 integrated learning, (~~((led))~~) hosted and maintained by the education
34 research and data center at the office of financial management, as
35 follows:

36 (a) Develop (~~((program codes for career connected learning and~~
37 ~~work-integrated learning opportunities in K-12 and postsecondary~~
38 ~~education in order to track those programs that are designated as~~
39 ~~career connected learning programs for each of the three categories~~

1 ~~set forth in the definition of "career connected learning" in RCW~~

10 (b) Collect student identification information, that includes
11 student access, enrollment, persistence, and completion metrics, and
12 demographic data that includes, but is not limited to, race, gender,
13 income, rurality, disability, foster youth, homeless youth, and
14 English language learner;

15 (c) Develop and maintain a public facing dashboard updated each
16 year by January 10th to ensure transparency and access regarding
17 program outcomes, regional impact, and progress towards statewide
18 enrollment and completion goals;

19 (d) Oversee and administer or develop an interagency agreement
20 with any state agency to administer any work stream associated with
21 implementation of career connect Washington including the career
22 connected learning grant program established in RCW 28C.30.050 (as
23 recodified by this act); and

24 (e) Lead and staff the career connected learning cross-agency
25 work group established in RCW 28C.30.030 (as recodified by this act).

26 The office may consult or contract with entities with expertise
27 in industry and education partnerships to provide strategic guidance
28 and staffing support necessary to carry out these duties. The office
29 may convene additional ad hoc committees that include industry sector
30 advisory groups and leaders including, but not limited to, high-level
31 representatives from education, industry, philanthropy, as well as
32 students, parents, and community partners.

15 integrated learning networks in both rural and urban areas under

19 employers, labor partners, and educational institutions, work with
20 K-12 and postsecondary career representatives to develop curricula
21 for new and innovative programs, and scale existing career

23 and endorsed career launch ~~((programs))~~; and

24 (c) Support industry sector leaders that will identify employers'
25 workforce needs and in collaboration with career connected learning

27 (4) The program administrator shall ~~((consult with the governor's~~
28 ~~office and the career connected learning cross-agency work group~~
29 ~~established in RCW 28C.30.030 to develop a formal request for~~
30 ~~proposal for both the regional career connected learning and work-~~
31 ~~integrated learning networks and the program intermediaries))~~ make
32 competitive awards for career connected learning programs and other
33 activities.

34 (5) (a) Proposals for regional career connected learning and work-
35 integrated learning networks ~~((and intermediaries))~~ may be sought
36 from applicants within the geographic areas of the nine educational
37 service districts. Successful applicants shall convene and manage
38 regional, cross-industry networks that will lead to the expansion of
39 career connected learning opportunities.

1 (b) Regional career connected learning and work-integrated
2 learning network applicants must demonstrate regional knowledge and
3 status as a trusted partner of industry and education stakeholders, a
4 track record of success with career connected learning and aligned
5 initiatives, and a commitment to equity. Regional career connected
6 learning networks may include, but are not limited to, regional
7 education networks, school districts, educational service districts,
8 higher education institutions, workforce development councils,
9 chambers of commerce, industry associations, joint labor management
10 councils, multiemployer training partnerships, economic development
11 councils, and nonprofit organizations.

12 (6)(a) Eligible program (~~(intermediary)~~) builder applicants may
13 include, but are not limited to, new or existing industry
14 associations, joint labor management councils, regional networks,
15 career technical student organizations, postsecondary education and
16 training institutions working with multiple employer partners, state
17 agencies, and other community-based organizations and expanded
18 learning partners.

19 (~~(7)~~) (b) Program (~~(intermediaries)~~) builders must work with
20 appropriate faculty and staff at the state universities, the regional
21 universities, (~~and~~) the state college, other postsecondary
22 representatives, and K-12 education representatives, to expand the
23 number of career launch (~~(program)~~) credits that may be articulated
24 and transferred to postsecondary degree programs.

25 (~~(8)~~) (7) Eligible industry sector leaders must demonstrate
26 strong employer relationships and engagement and show knowledge of
27 industry sector needs as it relates to career connected learning
28 pathways including, but not limited to:

29 (a) Identification of specific occupations in demand and
30 anticipated to be in demand in the future;

31 (b) Identification of specific skills, education, training, or
32 credentials needed for occupations; and

33 (c) Identification of or development of specific programs needed
34 to provide the necessary skills, education, training, or credentials.

35 (8) Eligible industry sector leader applicants may include, but
36 are not limited to, industry associations, joint labor management
37 councils, multiemployer training partnerships, higher education
38 institutions, and centers of excellence established pursuant to RCW
39 28B.50.902.

1 (9) Subject to the availability of amounts appropriated for this
2 specific purpose, the employment security department, as the
3 administrator of the program, has the authority to utilize funds
4 deposited in the career connected learning account for the purposes
5 of the program.

6 (~~(9) During the 2019-2021 fiscal biennium, the employment~~
7 ~~security department must provide sufficient funding from amounts~~
8 ~~appropriated for the program to the office of the superintendent of~~
9 ~~public instruction to provide a grant to each of the nine educational~~
10 ~~service districts for costs of employing one full-time equivalent~~
11 ~~employee to support the expansion of career connected learning~~
12 ~~opportunities.))~~

13 **Sec. 6.** RCW 28C.30.060 and 2019 c 406 s 59 are each amended to
14 read as follows:

15 The career connected learning account is created in the state
16 treasury. All receipts from (~~public or~~) private sources provided
17 for the purpose of funding grants under RCW 28C.30.050 (as recodified
18 by this act) must be deposited into the account. Moneys in the
19 account may be spent only after appropriation. Expenditures from the
20 account may be used only for career connected learning grants.

21 **Sec. 7.** RCW 28C.30.070 and 2019 c 406 s 58 are each amended to
22 read as follows:

23 Where applicable, career (~~(awareness and exploration)~~) explore,
24 career connected learning, career launch (~~(programs)~~), and career
25 (~~(preparation programs)~~) prep are subject to RCW 49.12.121 and
26 49.12.123 regarding employing minors.

27 **Sec. 8.** RCW 28B.77.005 and 2021 c 134 s 1 are each amended to
28 read as follows:

29 (1) The student achievement council is created.

30 (2) The council is composed of (~~(10)~~) 14 voting members as
31 provided in this subsection.

32 (a) (~~(Six)~~) Ten citizen members shall be appointed by the
33 governor with the consent of the senate. One of the citizen members
34 shall be an undergraduate student and one shall be a graduate
35 student. One citizen member shall be representative of worker
36 representatives and one citizen member shall be representative of the
37 business community. At least one citizen member shall represent a

1 local community or region dedicated to career connected learning
2 pathways and one citizen member shall be a tribal representative. The
3 citizen members shall be selected based on their knowledge of or
4 experience in higher education. At least two of the citizen members
5 shall have direct experience with career connected learning programs
6 and/or pathways, including registered apprenticeship. In making
7 appointments to the council, the governor shall give consideration to
8 citizens representing (~~(labor, business,)~~) women(~~(r)~~) and racial and
9 ethnic minorities, as well as geographic representation, to ensure
10 that the council's membership reflects the state's diverse
11 (~~(population)~~) communities. The citizen members shall serve for four-
12 year terms except for each of the student members, who shall serve
13 for two years; however, the terms of the initial members and the
14 undergraduate and graduate student members shall be staggered.

15 (b) A representative of an independent nonprofit higher education
16 institution as defined in RCW 28B.07.020, selected by an association
17 of independent nonprofit baccalaureate degree-granting institutions.
18 The representative appointed under this subsection (2)(b) shall
19 excuse himself or herself from voting on matters relating primarily
20 to public institutions of higher education.

21 (c) Chosen for their recognized ability and innovative leadership
22 experience in broad education policy and system design, a
23 representative of each of the following shall be selected by the
24 respective organizations, who shall serve at the pleasure of the
25 appointing organizations:

26 (i) A representative of the four-year institutions of higher
27 education as defined in RCW 28B.10.016, selected by the presidents of
28 those institutions;

29 (ii) A representative of the state's community and technical
30 college system, selected by the state board for community and
31 technical colleges; and

32 (iii) A representative of the state's K-12 education system,
33 selected by the superintendent of public instruction in consultation
34 with the department of children, youth, and families and the state
35 board of education. The representative appointed under this
36 subsection (2)(c)(iii) shall excuse himself or herself from voting on
37 matters relating primarily to institutions of higher education.

38 (3) The chair shall be selected by the council from among the
39 citizen members appointed to the council. The chair shall serve a

1 one-year term but may serve more than one term if selected to do so
2 by the membership.

3 (4) The council may create advisory committees on an ad hoc basis
4 for the purpose of obtaining input from students, faculty, and higher
5 education experts and practitioners, citizens, business and industry,
6 and labor, and for the purpose of informing their research, policy,
7 and programmatic functions. Ad hoc advisory committees addressing
8 secondary to postsecondary transitions and university and college
9 admissions requirements must include K-12 sector representatives
10 including teachers, school directors, principals, administrators, and
11 others as the council may direct, in addition to higher education
12 representatives. The council shall maintain a contact list of K-12
13 and higher education stakeholder organizations to provide notices to
14 stakeholders regarding the purposes of ad hoc advisory committees,
15 timelines for planned work, means for participation, and a statement
16 of desired outcomes.

17 (5) Any vacancies on the council shall be filled in the same
18 manner as the original appointments. Appointments to fill vacancies
19 shall be only for such terms as remain unexpired. Any vacancies among
20 council members appointed by the governor shall be filled by the
21 governor subject to confirmation by the senate and shall have full
22 authority to act before the time the senate acts on their
23 confirmation.
