## SENATE BILL 5558

State of Washington 68th Legislature 2023 Regular Session

Read first time 01/25/23. Referred to Committee on Early Learning & K-12 Education.

- AN ACT Relating to the fundamental right of parents and guardians
- to direct the upbringing and education of their children; adding a new section to chapter 28A.605 RCW; and creating a new section.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- NEW SECTION. Sec. 1. (1) The legislature acknowledges that children are naturally incapable of exercising self-government until the age of majority. The legislature recognizes that parents are the best protectors of their children and have the natural right and duty to care for them.
- 10 (2) The legislature acknowledges that the United States supreme 11 court has repeatedly recognized and protected the rights of parents 12 and guardians and stressed the importance of family. For example, in Pierce v. Society of Sisters, 268 U.S. 510 (1925), the supreme court 13 held that a state law that required children to attend public schools 14 "unreasonably interfere[d] with the liberty of parents and guardians 15 16 to direct the upbringing and education of children under their 17 control." In Wisconsin v. Yoder 406 U.S. 205 (1972), the supreme court explained, "The history and culture of Western civilization 18 reflect a strong tradition of parental concern for the nurture and 19 upbringing of children. This primary role of the parents in the 20 upbringing of their children is now established beyond debate as an 21

- 1 enduring American tradition." In Moore v. City of East Cleveland 431
- 2 U.S. 494 (1977), the supreme court explained that its decisions
- 3 "establish that the Constitution protects the sanctity of the family
- 4 precisely because the institution of the family is deeply rooted in
- 5 this Nation's history and tradition. It is through the family that we
- 6 inculcate and pass down many of our most cherished values, moral and
- 7 cultural."
- 8 (3) The legislature intends to codify parents and guardians'
- 9 fundamental right to direct the upbringing and education of their
- 10 children to help protect this right from governmental encroachment on
- 11 parental authority in public schools.
- 12 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 28A.605
- 13 RCW to read as follows:
- 14 (1) The legislature declares that the laws of the state of
- 15 Washington regarding education shall recognize the fundamental right
- 16 of parents and guardians to direct the upbringing and education of
- 17 their children.
- 18 (2) This fundamental right includes choosing the type of
- 19 education their child will receive, as recognized by RCW 28A.225.010,
- 20 and making reasonable choices related to their child's education.
- 21 (3) No state law regarding education shall infringe on this
- 22 fundamental right without demonstrating that the state law is
- 23 furthering a compelling governmental interest and is narrowly
- 24 tailored to achieve that interest.
- 25 (4) This fundamental right shall not be construed to apply to a
- 26 parental action or decision that would end life.
