- 1 AN ACT Relating to establishing behavioral health support
- 2 specialists; amending RCW 18.130.040 and 18.130.040; adding a new
- 3 section to chapter 48.43 RCW; adding a new chapter to Title 18 RCW;
- 4 providing an effective date; and providing an expiration date.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 <u>NEW SECTION.</u> **Sec. 1.** The legislature finds that a behavioral
- 7 health support specialist is a new member of the workforce in
- 8 Washington state trained in the competencies developed by the
- 9 University of Washington behavioral health support specialist
- 10 clinical training program. The behavioral health support specialist

clinical training program is characterized by brief, evidence-based

- 12 interventions delivered to the intensity and expected duration of the
- 13 behavioral health problem. The approach features routine outcome
- 14 monitoring and regular, outcome-focused supervision. Use of
- 15 behavioral health support specialists in Washington is expected to
- 16 improve access to behavioral health services and ease workforce
- 17 shortages while helping behavioral health professionals work at the
- 18 top of their scope of practice.

- NEW SECTION. Sec. 2. The definitions in this section apply throughout this chapter unless the context clearly requires otherwise.
  - (1) "Adult" means a person 18 years of age or older.

- 5 (2) "Applicant" means a person who completes the required 6 application, pays the required fee, is at least 18 years of age, and 7 meets any background check requirements and uniform disciplinary act 8 requirements.
  - (3) "Behavioral health" is a term that encompasses mental health, substance use, and co-occurring disorders.
    - (4) "Behavioral health support specialist" means a person certified to deliver brief, evidence-based interventions with a scope of practice that includes behavioral health under the supervision of a Washington state credentialed provider who has the ability to assess, diagnose, and treat identifiable mental and behavioral health conditions as part of their scope of practice. A behavioral health support specialist does not have within their scope of practice the ability to make diagnoses but does track and monitor treatment response and outcomes using measurement-based care.
- 20 (5) "Department" means the department of health.
- 21 (6) "Registered apprenticeship" means an apprenticeship program 22 approved by the Washington state apprenticeship and training council 23 according to chapter 49.04 RCW.
- 24 (7) "Secretary" means the secretary of health or the secretary's designee.
- <u>NEW SECTION.</u> **Sec. 3.** The department shall collaborate with the 26 27 University of Washington department of psychiatry and behavioral sciences and consult with other stakeholders to develop rules to 28 implement this chapter by January 1, 2025, which shall be consistent 29 30 the University of Washington behavioral health 31 specialist clinical training program guidelines, and shall include appropriate standards for approval of educational programs for 32 behavioral health support specialists, which shall include a 33 practicum component and may be integrated into a bachelor's degree 34 program or structured as a postbaccalaureate continuing education 35 program or registered apprenticeship in combination with an approved 36 37 bachelor's degree or postbaccalaureate certificate.

- 1 <u>NEW SECTION.</u> **Sec. 4.** A person may not represent themself as a
- 2 behavioral health support specialist without being certified by the
- 3 department.
- 4 <u>NEW SECTION.</u> **Sec. 5.** Nothing in this chapter shall be construed
- 5 to prohibit or restrict delivery of behavioral health interventions
- 6 by an individual otherwise regulated under this title and performing
- 7 services within their authorized scope of practice.
- 8 <u>NEW SECTION.</u> **Sec. 6.** In addition to any other authority
- 9 provided by law, the secretary has the authority to:
- 10 (1) Adopt rules under chapter 34.05 RCW necessary to implement
- 11 this chapter. Any rules adopted shall be in consultation with the
- 12 University of Washington;
- 13 (2) Establish all certification, examination, and renewal fees in
- 14 accordance with RCW 43.70.250;
- 15 (3) Establish forms and procedures necessary to administer this
- 16 chapter;
- 17 (4) Issue certifications to applicants who have met the
- 18 education, which may include registered apprenticeships, practicum,
- 19 and examination requirements for certification and to deny a
- 20 certification to applicants who do not meet the requirements;
- 21 (5) Develop, administer, and supervise the grading and taking of
- 22 an examination for applicants for certification;
- 23 (6) Adopt rules requiring completion of 20 hours of continuing
- 24 education every two years after initial certification for
- 25 certification renewal;
- 26 (7) Maintain the official record of all applicants and
- 27 certification holders; and
- 28 (8) Establish by rule the procedures for an appeal of an
- 29 examination failure.
- 30 <u>NEW SECTION.</u> **Sec. 7.** The uniform disciplinary act, chapter
- 31 18.130 RCW, governs uncertified practice, the issuance and denial of
- 32 certification, and the discipline of persons certified under this
- 33 chapter. The secretary shall be the disciplinary authority under this
- 34 chapter.

- NEW SECTION. Sec. 8. The secretary shall issue a certification to any applicant who demonstrates to the satisfaction of the secretary that the applicant meets the following requirements:
  - (1) Graduation from a bachelor's degree program;

- (2) Successful completion of a behavioral health support specialist program that is approved to meet standards consistent with the University of Washington behavioral health support specialist clinical training program guidelines, including a supervised clinical practicum with demonstrated clinical skills in core competencies; and
- 10 (3) Successful completion of an approved jurisprudential 11 examination.
- NEW SECTION. Sec. 9. (1) The date and location of examinations shall be established by the secretary. Applicants who have been found by the secretary to meet the other requirements for certification shall be scheduled for the next examination following the filing of the application. The secretary shall establish by rule the examination application deadline.
- 18 (2) The secretary or the secretary's designee shall examine each applicant, by means determined to be most effective, on subjects appropriate to the scope of practice, as applicable. Such examinations shall be limited to the purpose of determining whether the applicant possesses the minimum skill and knowledge necessary to practice competently.
  - (3) The examination papers, all grading of the papers, and the grading of any practical work shall be preserved for a period of not less than one year after the secretary has made and published the decisions. All examinations shall be conducted using fair and wholly impartial methods.
- 29 (4) The secretary may approve an examination prepared or 30 administered by a private testing agency or association of licensing 31 agencies for use by an applicant in meeting the certification 32 requirements.
- NEW SECTION. Sec. 10. Applications for certification shall be submitted on forms provided by the secretary. The secretary may require any information and documentation which reasonably relates to the need to determine whether the applicant meets the criteria for certification provided for in this chapter and chapter 18.130 RCW.

- 2 43.70.250. The fee shall accompany the application.
