1 AN ACT Relating to off-duty employment of fish and wildlife 2 officers; adding a new section to chapter 77.15 RCW; and adding a new 3 section to chapter 4.92 RCW.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 <u>NEW SECTION.</u> Sec. 1. A new section is added to chapter 77.15 6 RCW to read as follows:

Washington fish and wildlife officers may engage in private law 7 8 enforcement off-duty employment, in uniform or in plainclothes for private benefit, subject to guidelines adopted by the chief of fish 9 10 and wildlife enforcement. These guidelines must ensure that the 11 integrity and professionalism of the Washington fish and wildlife 12 enforcement is preserved. Use of Washington fish and wildlife 13 officer's uniforms shall be considered de minimis use of state 14 property. For any employment authorized under this section that 15 occurs on reservation, trust, or allotted lands of a federally-16 recognized Indian tribe, a Washington fish and wildlife officer must 17 have taken the violence de-escalation and mental health training 18 provided by the criminal justice training commission, including the 19 curriculum of the history of police interactions with Native American 20 communities; and the private employer must have obtained permission 21 from the affected federally recognized Indian tribe.

1 <u>NEW SECTION.</u> Sec. 2. A new section is added to chapter 4.92 RCW
2 to read as follows:

3 (1) The state is not liable for tortious conduct by department of 4 fish and wildlife officers that occurs while such officers are 5 engaged in private law enforcement off-duty employment.

6 (2) Upon petition of the state any suit, for which immunity is 7 granted to the state under subsection (1) of this section, shall be 8 dismissed.

9 (3) Department of fish and wildlife officers engaged in private 10 law enforcement off-duty employment shall notify, in writing, prior 11 to such employment, anyone who employs department of fish and 12 wildlife officers in private off-duty employment of the specific 13 provisions of subsections (1) and (2) of this section.
