Background:

The Seattle Seahawks (Seahawks) are a professional football team based in Seattle. The

Seahawks first played in 1976 and have played their home games at Lumen Field in Seattle's SoDo neighborhood since 2002. The Seahawks have won 11 division titles and three conference championships. The Seahawks defeated the Denver Broncos 43 to 8 at Super Bowl XLVIII.

Seahawks fans are collectively known as the "12s." Formerly, Seahawks fans were known as the "12th Man." The "12th Man" refers to fans being the twelfth player in a maximum 11-a-side game. Seahawks fans twice set the Guinness World Record for the loudest crowd noise at a sporting event within the span of a few months. In 1984 the Seahawks retired the number 12 in honor of the "12th Man."

State Holidays and Legislatively Recognized Days.

Washington recognizes 11 specific days as paid state legal holidays: New Year's Day, Martin Luther King Jr. Day, Presidents' Day, Memorial Day, Independence Day, Juneteenth, Labor Day, Veterans Day, Thanksgiving Day, Native American Heritage Day, and Christmas Day.

Another 20 specific days are recognized by the Legislature, but they are not considered legal holidays. Some of those days commemorate specific events, such as Welcome Home Vietnam Veterans Day. Other days commemorate groups of people, such as Korean-American Day, or certain ideas, such as Human Trafficking Awareness Day and Public Lands Day.

Summary of Bill:

December 12 is designated as the Day of the 12s, a legislatively recognized day.

Appropriation: None.

Fiscal Note: Not requested.

Effective Date: The bill takes effect 90 days after adjournment of the session in which the bill is passed.

Staff Summary of Public Testimony:
