1 AN ACT Relating to motor vehicle chop shops; reenacting and  
2 amending RCW 9.94A.515; adding a new section to chapter 9A.56 RCW;  
3 creating a new section; prescribing penalties; and declaring an  
4 emergency.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 NEW SECTION. **Sec. 1.** The legislature finds that Washington  
7 state is in the top rankings for auto thefts in the nation. The  
8 legislature further finds that chop shops are prevalent and  
9 flourishing, and Washington state does not currently provide law  
10 enforcement adequate tools to stop the illegal destruction of cars  
11 that profit criminals. The legislature further finds that automobile  
12 insurance rates have increased for everyone due to the criminal  
13 activity in the state.

14 Therefore, the legislature intends to implement new provisions to  
15 hold criminals accountable and to provide restitution to the victims  
16 of these crimes.

17 NEW SECTION. **Sec. 2.** A new section is added to chapter 9A.56  
18 RCW to read as follows:

19 (1) Except as provided in subsection (8) of this section, it is  
20 unlawful for any person to knowingly own, operate, or conduct a chop

1 shop, or to knowingly aid and abet another person in owning,  
2 operating, or conducting a chop shop.

3 (2) (a) Except as provided in (b) of this subsection, a person who  
4 violates this section is guilty of a class B felony punishable  
5 according to chapter 9A.20 RCW.

6 (b) A person who commits a second or subsequent violation of this  
7 section is guilty of a class A felony punishable according to chapter  
8 9A.20 RCW.

9 (3) A person who is convicted of violating this section, in  
10 addition to any other punishment, shall be ordered to make  
11 restitution to the lawful owner of the stolen motor vehicle, major  
12 component part, or other part, or to the owner's insurer if the owner  
13 has already been compensated for the loss by the insurer, for any  
14 financial loss sustained as a result of the theft of the motor  
15 vehicle or part, any environmental clean-up costs stemming from the  
16 illegal activity, and any other related costs as authorized by RCW  
17 9.94A.750. Restitution shall be imposed in addition to any  
18 imprisonment or penalty imposed, but not in lieu thereof.

19 (4) The following may be seized and are subject to forfeiture  
20 pursuant to RCW 10.105.010:

21 (a) Any stolen motor vehicle found at the site of a chop shop, or  
22 any part of a motor vehicle found at the site of a chop shop for  
23 which there is probable cause to believe that the part is stolen,  
24 even if the lawful owner of the part cannot be identified;

25 (b) Any engine, tool, machine, implement, device, chemical, or  
26 substance used or designed for altering, dismantling, reassembling,  
27 or in any other way concealing or disguising the identity of a stolen  
28 motor vehicle or its parts;

29 (c) A wrecker, car hauler, or other motor vehicle that is being  
30 used or has been used to convey or transport a stolen motor vehicle  
31 or parts from a stolen motor vehicle; and

32 (d) To the extent authorized by law, any other personal or real  
33 property used in furtherance of violating this section.

34 (5) For the purposes of this section, "chop shop" means any  
35 business, building, lot, facility, location, or other structure or  
36 premise where one or more persons engage in receiving, concealing,  
37 destroying, disassembling, dismantling, reassembling, or storing any  
38 stolen motor vehicle or motor vehicle part which has been unlawfully  
39 obtained in order to alter, counterfeit, deface, destroy, disguise,  
40 falsify, forge, obliterate, or remove the identity, including the

1 vehicle identification number or derivative thereof, of such vehicle  
2 or vehicle part and to distribute, sell, repurpose, or dispose of  
3 such vehicle or vehicle part.

4 (6) For the purposes of this section, "major component part" has  
5 the same meaning as defined in RCW 46.80.010.

6 (7) For the purposes of this section, "motor vehicle" includes  
7 watercrafts.

8 (8) The provisions of this section do not apply to:

9 (a) A vehicle wrecker licensed pursuant to chapter 46.80 RCW, or  
10 a hulk hauler or scrap processor licensed pursuant to chapter 46.79  
11 RCW, who unknowingly in the normal course of business and in good  
12 faith processes a stolen motor vehicle or its parts, unless law  
13 enforcement proves a pattern of conduct composing many transactions  
14 involving stolen vehicles or parts over a period of time where the  
15 licensee's business practices were conducive to accepting stolen  
16 vehicles and parts; or

17 (b) The lawful owner or any other authorized possessor of a motor  
18 vehicle or motor vehicle part that has been recovered by law  
19 enforcement authorities after having been stolen.

20 **Sec. 3.** RCW 9.94A.515 and 2024 c 301 s 29 and 2024 c 55 s 1 are
