1 AN ACT Relating to snowmobile registration fees; amending RCW  
2 46.17.350; and creating a new section.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 46.17.350 and 2019 c 44 s 4 are each amended to read  
5 as follows:

6 (1) Before accepting an application for a vehicle registration,  
7 the department, county auditor or other agent, or subagent appointed  
8 by the director shall require the applicant, unless specifically  
9 exempt, to pay the following vehicle license fee by vehicle type:
