17 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

18 NEW SECTION. **Sec. 1.** A supplemental capital budget is hereby  
19 adopted and, subject to the provisions set forth in this act, the  
20 several dollar amounts hereinafter specified, or so much thereof as  
21 shall be sufficient to accomplish the purposes designated, are hereby

1 appropriated and authorized to be incurred for capital projects  
2 during the period beginning with the effective date of this act and  
3 ending June 30, 2027, out of the several funds specified in this act.

5 **FOR THE DEPARTMENT OF COMMERCE**

6 2025-27 Behavioral Health Facilities (40000667)

7 The appropriation in this section is subject to the following  
8 conditions and limitations:

9 (1) The appropriation in this section is provided solely for the  
10 department to issue grants to community hospitals or other community  
11 providers to expand and establish new and preserve existing capacity  
12 for behavioral health services in communities. The department must  
13 consult an advisory group consisting of representatives from the  
14 department of social and health services, the health care authority,  
15 one representative from a managed care organization, one  
16 representative from an accountable care organization, and one  
17 representative from the association of county human services. The  
18 amounts provided in this section may be used for construction and  
19 equipment costs associated with establishment or preservation of the  
20 facilities. The department may approve funding for the acquisition of  
21 a facility if the project will result in increased behavioral health  
22 capacity. Amounts provided in this section may not be used for  
23 operating costs associated with the treatment of patients using these  
24 services.

25 (2) The department must establish criteria for the issuance of  
26 the grants, which must include:

27 (a) Evidence that the application was developed in collaboration  
28 with one or more regional behavioral health entities that administer  
29 the purchasing of services;

30 (b) Evidence that the applicant has assessed and would meet gaps  
31 in the geographical availability and service needs of behavioral  
32 health services in their region;

33 (c) Evidence that the applicant is able to meet applicable  
34 licensing and certification requirements in the facility that will be  
35 used to provide services;

36 (d) A commitment by applicants to serve persons who are publicly  
37 funded and persons detained for involuntary commitment, as applicable  
38 by facility type, under chapter 71.05 RCW;

1 (e) A commitment by the applicant to maintain and operate the  
2 beds or facility for a time period commensurate to the state  
3 investment, but for at least a 10-year period;

4 (f) The date upon which structural modifications or construction  
5 would begin and the anticipated date of completion of the project;

6 (g) A detailed estimate of the costs associated with opening the  
7 beds;

8 (h) A financial plan demonstrating the applicant's ability to  
9 maintain and operate the facility; and

10 (i) The applicant's commitment to work with local courts and  
11 prosecutors as applicable to ensure that prosecutors and courts in  
12 the area served by the hospital or facility will be available to  
13 conduct involuntary commitment hearings and proceedings under chapter  
14 71.05 RCW.

15 (3) In awarding funding for projects in subsection (5) of this  
16 section, the department, in consultation with the advisory group  
17 established in subsection (1) of this section, must strive for  
18 geographic distribution and to allocate funding based on population  
19 and service needs of an area. The department must consider current  
20 services available, anticipated services available based on projects  
21 underway, and the service delivery needs of an area.

22 (4) The department must prioritize projects that increase  
23 capacity in unserved and underserved areas of the state.

24 (5) (~~(\$70,000,000)~~) \$66,700,000 of the state building  
25 construction account—state appropriation in this section is provided  
26 solely for competitive community behavioral health grants to address  
27 regional needs and noncompetitive closure prevention grants. Closure  
28 prevention grants must be awarded on a first-come, first-served  
29 basis. For competitive regional needs grants, priority must be given  
30 to: Youth and adult bed capacity with consideration given to gaps  
31 identified in the 2024 behavioral health capital grant facility  
32 funding report; and facilities that serve specialized populations,  
33 including, but not limited to, services for individuals with  
34 traumatic brain injury, dementia, and cooccurring complex needs of  
35 youth. Additional categories of facilities may be funded based on  
36 identified needs of a region. Eligible facilities include, but are  
37 not limited to:

38 (a) Crisis relief centers and stabilization facilities that offer  
39 access to mental health and substance use care for no more than 23  
40 hours and 59 minutes per patient, at a time, and are not subject to

1 federal funding restrictions that apply to institutions of mental  
2 diseases;

3 (b) Mental health peer respite centers that are not subject to  
4 federal funding restrictions that apply to institutions of mental  
5 diseases. No more than one mental health peer respite center should  
6 be funded in each of the 10 regions;

7 (c) Grants to community providers to increase long-term intensive  
8 inpatient psychiatric treatment services and capacity for children  
9 and minor youth including, but not limited to, services for substance  
10 use disorder treatment, sexual assault and traumatic stress, anxiety,  
11 or depression, and interventions for children exhibiting aggressive  
12 or depressive behaviors in facilities that are not subject to federal  
13 funding restrictions;

14 (d) Grants to community hospitals, freestanding evaluation and  
15 treatment providers, or freestanding psychiatric hospitals to develop  
16 capacity for beds to serve individuals on 90-day or 180-day civil  
17 commitments as an alternative to treatment in the state hospitals. In  
18 awarding this funding, the department must coordinate with the  
19 department of social and health services, the health care authority,  
20 and the department of health and must only select facilities that  
21 meet the following conditions:

22 (i) The funding must be used to increase capacity related to  
23 serving individuals who will be transitioned from or diverted from  
24 the state hospitals;

25 (ii) The facility is not subject to federal funding restrictions  
26 that apply to institutions of mental diseases;

27 (iii) The provider has submitted a proposal for operating the  
28 facility to the health care authority;

29 (iv) The provider has demonstrated to the department of health  
30 and the health care authority that it is able to meet the applicable  
31 licensing and certification requirements for the facility that will  
32 be used to provide services; and

33 (v) The health care authority has confirmed that it intends to  
34 contract with the facility for operating costs within funds provided  
35 in the operating budget for these purposes;

36 (e) Enhanced adult residential care facilities for long-term  
37 dementia placements discharged or diverted from the state psychiatric  
38 hospitals and are not subject to federal funding restrictions that  
39 apply to institutions of mental diseases;

1 (f) Facilities that provide substance use disorder intervention,  
2 assessment, and treatment services with secure withdrawal management  
3 and stabilization treatment beds that are not subject to federal  
4 funding restrictions that apply to institutions of mental diseases;  
5 and

6 (g) Facilities where behavioral health supportive services, such  
7 as harm reduction and physical health services, are offered within  
8 the same facility as behavioral health services and that are not  
9 subject to federal funding restrictions that apply to institutions of  
10 mental diseases.

11 (6) \$10,000,000 of the state building construction account—state  
12 appropriation in this section is provided solely for one crisis  
13 stabilization facility in the King county region consistent with the  
14 settlement agreement in *A.B., by and through Trueblood, et al., v.*  
15 *DSHS, et al.*, No. 15-35462, that is not subject to federal funding  
16 restrictions that apply to institutions of mental disease. In  
17 awarding this funding, the department must coordinate with the health  
18 care authority and the King county behavioral health administrative  
19 service organization and must only select a facility that has been  
20 selected by King county's crisis care centers initiative as the  
21 crisis care center for the south King county region.

37 (9) During the 2025-2027 fiscal biennium, where the department  
38 has awarded a grant for the operation of a crisis diversion or  
39 stabilization facility located in Pierce county that is not subject

1 to federal funding restrictions that apply to institutions of mental  
2 diseases, the department may amend the contract associated with the  
3 grant in order to authorize the facility to be used for any community  
4 development block grant national objective.

5 (10) The department shall notify all applicants that they may be  
6 required to have a construction review performed by the department of  
7 health.

8 (11) To accommodate the emergent need for behavioral health  
9 services, the department and the department of health, in  
10 collaboration with the health care authority and the department of  
11 social and health services, must establish a concurrent and expedited  
12 process to assist grant applicants in meeting any applicable  
13 regulatory requirements necessary to operate inpatient psychiatric  
14 beds, freestanding evaluation and treatment facilities, enhanced  
15 services facilities, triage facilities, crisis stabilization  
16 facilities, or secure detoxification/secure withdrawal management and  
17 stabilization facilities.

18 (12) In contracts for grants authorized under this section, the  
19 department must include provisions that require that the grantee or  
20 successor hold the capital improvements for at least a 10-year  
21 period. The provisions must require the facility to be used for  
22 behavioral health services, but may allow the facility to change  
23 ownership or facility type during the commitment period. The  
24 department shall monitor the activities of recipients of grants under  
25 this program to determine compliance with the terms and conditions  
26 set forth in its contract.

27 (13) The department must provide a progress report to the  
28 appropriate committees of the legislature by November 1, 2026. The  
29 report must include:

30 (a) The total number of applications and amount of funding  
31 requested;

32 (b) A list and description of the projects approved for funding  
33 including state funding, total project cost, services anticipated to  
34 be provided, bed capacity, and anticipated completion date;

35 (c) A statewide map of new capacity since 2018, including  
36 projected bed capacity and opening dates;

37 (d) A status report of projects that received funding in prior  
38 funding rounds, including details about the project completion and  
39 the date the facility began providing services; and

1 (e) Recommendations for statutory language that would codify the  
2 grant program on an ongoing basis including:

3 (i) Evaluation and prioritization criteria;

4 (ii) Monitoring and compliance requirements;

5 (iii) Preconstruction and technical assistance services; and

6 (iv) Data needed to determine the service needs by area of the  
7 state.

8 (14) The department must coordinate with the health care  
9 authority and department of health to submit capital budget requests  
10 to fund behavioral health community capacity grants for the 2027-2029  
11 biennial budget by the due date established by the office of

25 The appropriation in this section is subject to the following  
26 conditions and limitations:

27 (1)(a) The appropriation in this section is provided solely for  
28 grants or deferred loans to local governments and public utility  
29 districts to defray the cost of waiving a portion of or all of the  
30 fees normally applied to developers for utility connection charges  
31 and related street improvements related to new affordable housing  
32 projects for low- and moderate-income households.

33 (b) Where applicable, the utility extension and related street  
34 improvements must be consistent with the approved comprehensive plans  
35 under the growth management act and must be within the established  
36 boundaries of the urban growth area as set forth in the approved  
37 comprehensive plans. Street improvements are eligible if the  
38 improvements are related directly to the utility extension or

1 connection and are adjacent to the new housing units being  
2 constructed.

3 (c) Projects must be located within a jurisdiction that imposes a  
4 sales and use tax under RCW 82.14.530(1)(a)(ii) or (b)(i)(B),  
5 82.14.540, or 84.52.105.

6 (2)(a) \$30,000,000 of the state building construction account—  
7 state appropriation is provided solely for grants or deferred loans  
8 for system development charges, utility improvements, and street  
9 improvements associated with utility infrastructure for affordable  
10 housing projects serving low-income households located within a city  
11 or county with a population of 150,000 or fewer persons.

12 (b) \$5,000,000 of the state building construction account—state  
13 appropriation in this section is provided for the department for  
14 pilot grants for system development charges, utility improvements,  
15 and street improvements associated with utility infrastructure for  
16 affordable housing projects serving moderate-income households. The  
17 pilot program must be offered in three counties located in the north  
18 central region of the state. The counties must share borders with one  
19 another, be located east of the crest of the Cascade mountains, and  
20 each have a population of 85,000 persons or fewer. By June 1, 2027,  
21 the department must submit a report to the office of financial  
22 management and to the appropriate committees of the legislature that:

23 (i) Summarizes the results of the pilot program, including an  
24 analysis of the need for infrastructure assistance for local  
25 governments to support the development of housing affordable to  
26 moderate-income households, and the benefits to communities that may  
27 result from increasing economic diversity in housing that is made  
28 more affordable through infrastructure subsidies;

29 (ii) Describes the number and total dollar amount of application  
30 requests and funding awards; and

31 (iii) Makes recommendations regarding continuation or expansion  
32 of the pilot program and recommended future funding levels.

33 (3) To be eligible for funding under this section, an applicant  
34 must demonstrate, at minimum:

35 (a) That affordable housing development will begin construction  
36 within 24 months of the grant or loan award; and

37 (b) A strong probability of serving the original target group or  
38 income level for a period of at least 25 years.

39 (4) For purposes of this section, the following definitions  
40 apply.

1 (a) "Affordable housing" means residential housing that requires  
2 payment of monthly housing costs, including utilities other than  
3 telephone, of no more than 30 percent of the household's income.

4 (b) "Low-income household" has the same meaning as in RCW  
5 43.185A.010.

6 (c) "Moderate-income household" means: For purposes of the pilot  
7 program authorized in this section, a single person, family, or  
8 unrelated persons living together whose adjusted income is above 80  
9 percent of the median household income adjusted for family size, for  
10 the county where the affordable housing project is located, but less  
11 than the state median income, as reported by the United States  
12 department of housing and urban development.

13 (d) "System development charges" means charges for new utility  
14 improvements.

15 (e) "Utility improvements" means drinking water, wastewater, or  
16 stormwater utility improvements.

17 (5) \$10,000,000 of the appropriation in this section is provided  
18 solely for the Fort Lawton redevelopment project. The funding  
19 provided in this subsection is not subject to the provisions of  
20 subsection (3) of this section. The legislature intends to provide  
21 funds in the amount of \$10,000,000 in the 2027-2029 fiscal biennium  
22 to the Fort Lawton redevelopment project.

23 (6) The appropriation in this section is subject to the  
24 provisions of section 8018 of this act.

37 construction account—state and (~~(\$402,000,000)~~) \$530,730,000 of the

1 state taxable building construction account—state appropriations are  
2 provided solely for the new construction, acquisition, or acquisition  
3 and rehabilitation of affordable housing projects that serve and  
4 benefit low-income and special needs populations including, but not  
5 limited to, people with chronic mental illness or behavioral health  
6 conditions, farmworkers, people who are homeless, and people in need  
7 of permanent supportive housing. The department shall strive to  
8 invest at least 20 percent of the appropriation provided under this  
9 section with by and for organizations, as defined by the office of

18 (b) \$50,000,000 of the state taxable building construction  
19 account—state appropriation is provided solely for affordable housing  
20 projects that serve and benefit low-income people with developmental  
21 or intellectual disabilities. The department must use a separate  
22 application form and evaluation criteria for applications under this  
23 subsection. The department must coordinate with the department of  
24 social and health services regarding any needed supportive services  
25 and make efforts to enact the recommendations of the housing needs  
26 study for individuals with intellectual and developmental  
27 disabilities, as provided in section 1068(6), chapter 332, Laws of  
28 2021. The department must consider prioritizing funding under this  
29 subsection for housing that serves individuals who are exiting  
30 residential habilitation centers or facilities.

31 (c) \$100,000,000 of the state taxable building construction
