1 AN ACT Relating to establishing a tourism self-supported
2 assessment program to fund statewide tourism promotion; amending RCW
3 43.384.010, 43.384.020, and 43.384.030; amending 2025 c 189 s 3
4 (uncodified); reenacting and amending RCW 42.56.270; adding a new
5 chapter to Title 43 RCW; and providing an expiration date.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7 NEW SECTION. **Sec. 1.** INTENT. (1) The legislature finds that the
8 history, economy, culture, and future of Washington state are
9 inextricably linked to a vibrant and healthy visitor economy. In
10 order to develop, manage, and promote statewide tourism as part of an
11 existing comprehensive effort to market Washington as a premier
12 travel destination, the legislature declares:

13 (a) That it is vital to the continued economic well-being and
14 general welfare of the citizens of this state that the tourism
15 industry be supported by:

16 (i) Enabling the tourism industry to help themselves through an
17 organized, year-around, statewide assessment program designed to
18 support fair, efficient, and sustained promotion and management of
19 Washington as a visitor destination; and

20 (ii) Enhancing tourism market opportunities and strengthening the
21 industry's long-term competitiveness by increasing travel to and

1 within Washington across leisure, business, and international
2 markets;

3 (b) That tourism-dependent businesses, including lodging, food
4 and beverage, attractions, recreation, cultural institutions, and
5 retail, operate in a regulatory and funding environment that limits
6 marketing autonomy, creates fragmented promotion efforts, and
7 contributes to Washington's declining market share in a highly
8 competitive global visitor economy;

9 (c) That it is in the overriding public interest to clearly
10 express support for the tourism sector and its coordinated and
11 orderly growth; to give adequate recognition and operational
12 resources to tourism as a vital component of Washington's export
13 economy and value-added service sector; and to promote, develop, and
14 manage tourism as an essential statewide industry in order to:

15 (i) Enhance the reputation and image of Washington as a travel
16 destination;

17 (ii) Increase visitor spending from domestic and international
18 markets; strategically positioning the destination and optimizing the
19 benefits of visitation;

20 (iii) Protect the public interest by providing destination
21 development that benefits communities, small businesses, tribes, and
22 other stakeholders and educating travelers about responsible and
23 sustainable visitation to communities and public and tribal lands;

24 (iv) Expand tourism-driven economic opportunities, development
25 resources, and community benefits in urban and rural regions alike;

26 (v) Support and engage in programs and partnerships that benefit
27 the development, management, marketing, and sustainability of tourism
28 across Washington; and

29 (vi) Expand the communication, cooperation, and partnership
30 between the public and private sectors to more effectively meet the
31 needs of both; and

32 (d) That a stable and predictable funding mechanism, developed
33 and governed by the industry through a self-supported assessment, can
34 generate substantial economic returns for the state and empower local
35 businesses, destinations, and communities to compete on a level
36 playing field with neighboring states and national leaders such as
37 California, Oregon, and British Columbia.

38 (2) The legislature intends that any rules adopted to implement
39 this chapter should be guided by the recommendations developed under
40 section 3, chapter 189, Laws of 2025.

1 NEW SECTION. **Sec. 2.** DEFINITIONS. The definitions in this
2 section apply throughout this chapter unless the context clearly
3 requires otherwise.

4 (1) "Assessment" means the annual fee levied on tourism
5 businesses to fund tourism promotion under this chapter.

6 (2) "Authority" means the Washington tourism marketing authority
7 created in RCW 43.384.020.

8 (3) "Ratepayer oversight board" means the board of
9 representatives from businesses subject to the assessment.

10 (4) "Tourism business" means businesses that derive a significant
11 portion of revenue from tourism activity in Washington in the
12 following sectors: (a) Lodging; (b) travel services; (c) attractions;
13 (d) recreation; (e) beverage producers; (f) full-service restaurant
14 locations with revenues exceeding \$5,000,000 per year; and (g)
15 retailer locations with revenues exceeding \$5,000,000 per year.

16 NEW SECTION. **Sec. 3.** ESTABLISHMENT OF PROGRAM. (1) The
17 legislature authorizes the authority to establish a tourism
18 assessment program, subject to tourism business sector ratification.

19 (2) No assessments shall be collected until the referendum
20 process in section 5 of this act is completed and approved by the
21 affected tourism business sector.

22 (3) The authority shall adopt rules as necessary to carry out the
23 purpose and intent of this chapter. The authority shall give
24 substantial weight to the recommendations made under section 3,
25 chapter 189, Laws of 2025, and the design developed under section 5
26 of this act, when developing rules under this chapter.

27 (4) Rules promulgated by the authority shall not apply to any
28 federally recognized Indian tribe, any business owned or operated by
29 a federally recognized Indian tribe, any tribal-owned enterprise, or
30 any business operating on land owned in fee or in trust by a tribe or
31 tribal member, unless the tribe or tribal member has officially opted
32 to participate in the tourism assessment program under section 5 of
33 this act.

34 NEW SECTION. **Sec. 4.** RATEPAYER OVERSIGHT BOARD. (1) The
35 authority shall appoint, from the list of nominees prepared under
36 subsection (2) of this section, a ratepayer oversight board
37 consisting of a minimum of 10 members, with at least two

1 representatives from each sector identified in section 2(4) of this
2 act, reflecting geographic and business diversity.

3 (2) (a) For the initial board, the tourism self-supported
4 assessment advisory group created by section 3, chapter 189, Laws of
5 2025 shall prepare a list of nominees for appointment to the
6 ratepayer oversight board. All nominees for membership on the
7 ratepayer oversight board must be employees or officers of businesses
8 subject to the assessment imposed under section 5 of this act,
9 pursuant to assessment ratification procedures established under
10 section 6 of this act.

11 (b) Initial board members shall serve for six months or until
12 completion of initial referendum, and vacancies shall be filled by
13 appointment for the unexpired term.

14 (c) Subsequent appointments shall be made under the process
15 developed under section 5 of this act and ratified under section 6 of
16 this act.

17 (d) The authority may remove any appointed member of the
18 ratepayer oversight board for inefficiency, neglect of duty,
19 malfeasance, or four unexcused absences in one year.

20 (3) The ratepayer oversight board shall provide oversight of
21 tourism assessment funds and programming and:

22 (a) Approve an annual budget and expenditure plan;

23 (b) Provide an annual report to the authority and the
24 legislature; and

25 (c) Monitor program effectiveness and recommend adjustments.

26 (4) The ratepayer oversight board shall elect a chair and meet at
27 least quarterly.

28 NEW SECTION. **Sec. 5.** ASSESSMENTS. (1) The ratepayer oversight
29 board shall design the proposed assessment program, including:

30 (a) Sector-specific classifications;

31 (b) Assessment methodology and the rates for each business
32 sector;

33 (c) A referendum process for ratification;

34 (d) Opt-out provisions, if applicable;

35 (e) Revenue thresholds for businesses assessed in each sector,
36 where applicable;

37 (f) Program term length; and

38 (g) The appointment process for the ratepayer oversight board
39 following the initial appointments made in section 4(2) of this act.

1 The appointment process designed under this subsection (1)(g) is
2 subject to ratification under section 6 of this act.

3 (2) Pursuant to approval by ratification in accordance with
4 section 6 of this act, there shall be levied, and the authority shall
5 collect, upon all participating tourism businesses in this state, an
6 annual assessment to be calculated as a percentage of gross revenue.

7 (3) An assessment shall not be applied to any federally
8 recognized Indian tribe, any business owned or operated by a
9 federally recognized Indian tribe, any tribal-owned enterprise, or
10 any business operating on land owned in fee or in trust by a tribe or
11 tribal member, unless the tribe or tribal member has officially opted
12 to participate in the tourism assessment program under this section.

13 NEW SECTION. **Sec. 6.** RATIFICATION MECHANISM. (1)(a) Within
14 three years of the effective date of this section, the ratepayer
15 oversight board shall conduct a referendum among affected businesses
16 to ratify the proposed assessment program. In the case of a failed
17 ratification, the board may continue to resubmit the same proposal or
18 a modified proposal beyond the three-year limitation.

19 (b) Each assessed business is entitled to a weighted vote in each
20 referendum. In calculating weighted votes, each assessed business
21 receives a vote equal to the projected assessment paid by that
22 business. The initial referendum must be approved by a majority of
23 the weighted votes cast at the referendum.

24 (c) For purposes of voting in any referendum, each assessed
25 business is part of one industry sector and one sector-segment, and
26 for voting purposes only, a business with revenue in more than one
27 industry sector or sector-segment shall only be included in the
28 sector and segment in which it earns the most gross revenue.

29 (d) A sector's assessment may be approved only by a majority of
30 weighted votes from businesses within that same sector. Votes from
31 other sectors are not counted for or against another industry's
32 assessment.

33 (2) Assessments may begin once ratified by vote and shall be
34 collected on an annual basis.

35 (3) The cost of any referendum under this section shall be paid
36 by the authority and reimbursed by the fund established in section 7
37 of this act.

1 NEW SECTION. **Sec. 7.** COLLECTION AND ACCOUNTING. (1) The
2 authority shall collect assessments annually from participating
3 businesses.

4 (2) The authority shall deposit assessment moneys collected in a
5 separate account, named the tourism assessment account, in any bank
6 that is a state depository. Assessments collected under the program
7 are not considered state money, common cash, or revenue to the state,
8 and are not subject to legislative appropriation. All expenditures
9 and disbursements made from this account under this chapter may be
10 made without the necessity of a specific legislative appropriation.
11 None of the provisions of RCW 43.01.050 apply to this account or to
12 the moneys received, collected, or expended as provided. Funds in the
13 account:

14 (a) Must be used solely for tourism promotion as defined in the
15 ratified program; and

16 (b) Must be used to cover administrative and enforcement costs.

17 NEW SECTION. **Sec. 8.** NONPAYMENT AND ENFORCEMENT. A due and
18 payable assessment levied in such specified amount as determined by
19 the authority constitutes a personal debt of every person so assessed
20 or who otherwise owes the assessment, and the assessment is due and
21 payable to the authority when payment is called for by the authority.
22 If a person fails to pay the authority the full amount of the
23 assessment by the date due, the authority may add to the unpaid
24 assessment an amount not exceeding 10 percent of the assessment to
25 defray the cost of enforcing its collection. If the person fails to
26 pay any such due and payable assessment or other such sum, the
27 authority may bring a civil action for collection against the person
28 or persons in a court of competent jurisdiction. The action shall be
29 tried and judgment rendered as in any other cause of action for a
30 debt due and payable.

31 NEW SECTION. **Sec. 9.** RECORDS AND CONFIDENTIALITY. (1) Financial
32 and commercial information submitted to the authority and the
33 ratepayer oversight board under this chapter is confidential and
34 exempt from public inspection and copying under chapter 42.56 RCW.

35 (2) This section does not apply to general statistical summaries
36 that do not identify individual businesses.

1 **Sec. 10.** 2025 c 189 s 3 (uncodified) is amended to read as
2 follows:

3 (1) The chair of the board of directors of the tourism marketing
4 authority must appoint a tourism self-supported assessment advisory
5 group no later than two weeks following the effective date of this
6 section. The advisory group must evaluate the viability of an
7 industry self-supported assessment to fund statewide tourism
8 promotion and recommend procedures to establish the self-supported
9 assessment.

10 (2) The tourism self-supported assessment advisory group must
11 consist of at least eight members that represent sectors of the
12 tourism industry that may be considered for the self-supported
13 assessment, including:

- 14 (a) Two members representing the lodging sector;
- 15 (b) One member representing the beverage sector;
- 16 (c) One member representing the arts and culture sector;
- 17 (d) One member representing the tour operators sector;
- 18 (e) One member representing the attractions sector;
- 19 (f) One member representing the transportation sector; and
- 20 (g) One member representing a statewide Washington tourism
21 promotion nonprofit.

22 (3) The tourism self-supported assessment advisory group must
23 make recommendations for the following:

- 24 (a) The classification of businesses proposed to be included in
25 the self-supported assessment;
- 26 (b) The self-supported assessment methodology including the
27 petition process for businesses to approve the self-supported
28 assessment;
- 29 (c) The rate of self-supported assessment for each business
30 classification;
- 31 (d) The characteristics of a business within a classification
32 that will benefit from the self-supported assessment;
- 33 (e) The time period or duration of the self-supported assessment;
34 and
- 35 (f) The establishment of an oversight board for ratepayers
36 representing businesses by self-supported assessments.

37 (4) The board of directors of the tourism marketing authority
38 must comply with the requirements of RCW 43.18A.020 in making
39 appointments provided in this section. The department of commerce
40 must provide the report required in RCW 43.18A.020.

1 (5) The tourism self-supported assessment advisory group must
2 submit its recommendations in writing to the legislature by November
3 1, 2025.

4 (6) This section expires June 1, (~~2026~~) 2027.

5 **Sec. 11.** RCW 43.384.010 and 2018 c 275 s 2 are each amended to
6 read as follows:

7 The definitions in this section apply throughout this chapter
8 unless the context clearly requires otherwise.

9 (1) "Authority" means the Washington tourism marketing authority
10 created in RCW 43.384.020.

11 (2) "Board" means the Washington tourism marketing authority
12 board of directors.

13 (3) "Department" means the department of commerce.

14 (4) "Director" means the director of the department of commerce.

15 (5) "Ratepayer oversight board" has the meaning defined in
16 section 2 of this act.

17 (6) "Statewide tourism marketing account" means the account
18 created pursuant to RCW 43.384.040.

19 **Sec. 12.** RCW 43.384.020 and 2018 c 275 s 3 are each amended to
20 read as follows:

21 (1) The Washington tourism marketing authority is established as
22 a public body constituting an instrumentality of the state of
23 Washington.

24 (2) The authority is responsible for contracting for statewide
25 tourism marketing services that promote tourism on behalf of the
26 citizens of the state, and for managing the authority's financial
27 resources.

28 (3) The authority is responsible for administering a tourism
29 assessment program as set forth in chapter 43.--- RCW (the new
30 chapter created in section 15 of this act). The authority's primary
31 activities of administering government tax funds shall be governed by
32 the authority. The authority's activities with respect to the tourism
33 assessment program shall be governed by the ratepayer oversight
34 board.

35 (4) The department provides administrative assistance to the
36 authority and serves as the fiscal agent of the authority for moneys
37 appropriated for purposes of the authority.

1 ~~((4))~~ (5) The authority must create a private local account to
2 receive nonstate funds and state funds, other than general fund state
3 funds, contributed to the authority for purposes of this chapter.

4 **Sec. 13.** RCW 43.384.030 and 2025 c 189 s 2 are each amended to
5 read as follows:

6 (1) The authority must be governed by a board of directors. The
7 board of directors must consist of:

8 (a) Two members and two alternates from the house of
9 representatives, with one member and one alternate appointed from
10 each of the two major caucuses of the house of representatives by the
11 speaker of the house of representatives;

12 (b) Two members and two alternates from the senate, with one
13 member and one alternate appointed from each of the two major
14 caucuses of the senate by the president of the senate; and

15 (c) ~~((Nine))~~ Thirteen representatives ~~((with expertise in the
16 tourism industry and related businesses including, but not limited
17 to, hotel, restaurant, outdoor recreation, attractions, retail, and
18 rental car))~~ of tourism businesses appointed by the governor as
19 provided in this subsection (1)(c). Appointments by the governor must
20 reflect diversity in geography, size of business, gender, and
21 ethnicity. No county may have more than ~~((two))~~ four appointments

23 (i) Eight members representing businesses paying the assessments
24 ratified under section 6 of this act, and nominated by the ratepayer
25 oversight board, except that the initial members shall be nominated
26 by the tourism self-supported assessment advisory group created in
27 section 3, chapter 189, Laws of 2025;

28 (ii) Two members representing destination marketing
29 organizations; and

30 (iii) Three members representing tourism businesses.

31 (2) There must be a nonvoting advisory committee to the board.
32 The advisory committee must consist of:

33 (a) One ex officio representative from the department, state
34 parks and recreation commission, department of transportation, and
35 other state agencies as the authority deems appropriate; and

36 (b) One member from a federally recognized Indian tribe appointed
37 by the director of the department.

38 (3) All appointments must be for four years.

1 (4) The board must select from its membership the chair of the
2 board and such other officers as it deems appropriate. The chair of
3 the board must be a member from the tourism industry or related
4 businesses.

5 (5) A majority of the board constitutes a quorum.

6 (6) The board must create its own bylaws in accordance with the
7 laws of the state of Washington.

8 (7) Any member of the board may be removed for misfeasance,
9 malfeasance, or willful neglect of duty after notice and a public
10 hearing, unless the notice and hearing are expressly waived in
11 writing by the affected member.

12 (8) If a vacancy occurs on the board, a replacement must be
13 appointed for the unexpired term.

14 (9) The members of the board serve without compensation but are
15 entitled to reimbursement, solely from the funds of the authority,
16 for expenses incurred in the discharge of their duties.

17 (10) The board must meet at least quarterly.

18 (11) No board member of the authority may serve on the board of
19 an organization that could be considered for a contract authorized
20 under RCW 43.384.050.

21 **Sec. 14.** RCW 42.56.270 and 2025 c 419 s 9, 2025 c 176 s 1, and
22 2025 c 81 s 1 are each reenacted and amended to read as follows:

37 private persons pertaining to export services provided under chapters
38 43.163 and 53.31 RCW, and by persons pertaining to export projects
39 under RCW 43.23.035;

1 (4) Financial and commercial information and records supplied by
2 businesses or individuals during application for loans or program
3 services provided by chapters 43.325, 43.163, 43.160, 43.330, 43.168,
4 and 43.181 RCW and RCW 43.155.160, or during application for economic
5 development loans or program services provided by any local agency;

6 (5) Financial information, business plans, examination reports,
7 and any information produced or obtained in evaluating or examining a
8 business and industrial development corporation organized or seeking
9 certification under chapter 31.24 RCW;

10 (6) Financial and commercial information supplied to the state
11 investment board by any person when the information relates to the
12 investment of public trust or retirement funds and when disclosure
13 would result in loss to such funds or in private loss to the
14 providers of this information;

15 (7) Financial and valuable trade information under RCW 51.36.120;

16 (8) Financial, commercial, operations, and technical and research
17 information and data submitted to or obtained by the clean Washington
18 center in applications for, or delivery of, program services under
19 chapter 70.95H RCW;

20 (9) Financial and commercial information requested by the public
21 stadium authority from any person or organization that leases or uses
22 the stadium and exhibition center as defined in RCW 36.102.010;

23 (10)(a) Financial information, including but not limited to
24 account numbers and values, and other identification numbers supplied
25 by or on behalf of a person, firm, corporation, limited liability
26 company, partnership, or other entity related to an application for a
27 horse racing license submitted pursuant to RCW 67.16.260(1)(b),
28 cannabis producer, processor, or retailer license, liquor license,
29 gambling license, or lottery retail license;

30 (b) Proprietary financial and security information submitted to
31 or obtained by the gambling commission from and on behalf of license
32 applicants, licensees, gaming facilities, or a tribe pursuant to an
33 approved tribal/state compact. Proprietary financial and security
34 information includes, but is not limited to, the following:

35 (i) Financial statements and transactions including but not
36 limited to independent auditors' reports and financial statements
37 with any supporting documents, bank account records, player tracking
38 records, bond issuances, loan agreements, purchase agreements, and
39 stock buyouts. However, quarterly license reports are not exempt;

1 (ii) Information that describes the internal operational system
2 or internal procedures of the gaming facility designed to promote
3 efficiency, safeguard assets, and avoid fraud and error, including
4 but not limited to records pertaining to security camera technical
5 specifications, operation, and placement; cash out procedures and
6 locations; cage security information; building access controls; and
7 personally identifiable information control procedures;

8 (iii) Gaming facility security information, including but not
9 limited to descriptions of facility layout and schematics, firewall
10 configurations, network topologies, source code, software files,
11 cryptographic hashes of software files, risk and security assessment
12 reports, disaster recovery plans, incident response plans, and any
13 other sensitive information that may negatively impact the security
14 of the facility if released; and

15 (iv) Gaming equipment information, including but not limited to
16 related hardware, software, and security information, such as
17 firewall configurations, field testing data and results from testing,
18 network topologies or diagrams, source code, software files,
19 cryptographic hashes of software files, schematics, user credentials,
20 system components, and any other sensitive information about the
21 equipment that may compromise the security and integrity of the
22 equipment if released;

23 (c) Valuable formulae or financial or proprietary commercial
24 information records received during a consultative visit or while
25 providing consultative services to a licensed cannabis business in
26 accordance with RCW 69.50.561;

27 (11) Proprietary data, trade secrets, or other information that
28 relates to: (a) A vendor's unique methods of conducting business; (b)
29 data unique to the product or services of the vendor; or (c)
30 determining prices or rates to be charged for services, submitted by
31 any vendor to the department of social and health services or the
32 health care authority for purposes of the development, acquisition,
33 or implementation of state purchased health care as defined in RCW
34 41.05.011;

35 (12)(a) When supplied to and in the records of the department of
36 commerce:

37 (i) Financial and proprietary information collected from any
38 person and provided to the department of commerce pursuant to RCW
39 43.330.050(8);

1 (ii) Financial or proprietary information collected from any
2 person and provided to the department of commerce or the office of
3 the governor in connection with the siting, recruitment, expansion,
4 retention, or relocation of that person's business and until a siting
5 decision is made, identifying information of any person supplying
6 information under this subsection and the locations being considered
7 for siting, relocation, or expansion of a business; and

8 (iii) Financial or proprietary information collected from any
9 person and provided to the department of commerce pursuant to RCW
10 43.31.625 (3) (b) and (4);

11 (b) When developed by the department of commerce based on
12 information as described in (a) (i) of this subsection, any work
13 product is not exempt from disclosure;

14 (c) For the purposes of this subsection, "siting decision" means
15 the decision to acquire or not to acquire a site;

16 (d) If there is no written contact for a period of 60 days to the
17 department of commerce from a person connected with siting,
18 recruitment, expansion, retention, or relocation of that person's
19 business, information described in (a) (ii) of this subsection will be
20 available to the public under this chapter;

21 (13) Financial and proprietary information submitted to or
22 obtained by the department of ecology or the authority created under
23 chapter 70A.500 RCW to implement chapter 70A.500 RCW;

24 (14) Financial, commercial, operations, and technical and
25 research information and data submitted to or obtained by the life
26 sciences discovery fund authority in applications for, or delivery
27 of, grants under RCW 43.330.502, to the extent that such information,
28 if revealed, would reasonably be expected to result in private loss
29 to the providers of this information;

30 (15) Financial and commercial information provided as evidence to
31 the department of licensing as required by RCW 19.112.110 or
32 19.112.120, except information disclosed in aggregate form that does
33 not permit the identification of information related to individual
34 fuel licensees;

35 (16) Any production records, mineral assessments, and trade
36 secrets submitted by a permit holder, mine operator, or landowner to
37 the department of natural resources under RCW 78.44.085;

38 (17) (a) Farm plans developed by conservation districts, unless
39 permission to release the farm plan is granted by the landowner or

1 operator who requested the plan, or the farm plan is used for the
2 application or issuance of a permit;

3 (b) Farm plans developed under chapter 90.48 RCW and not under
4 the federal clean water act, 33 U.S.C. Sec. 1251 et seq., are subject
5 to RCW 42.56.610 and 90.64.190;

6 (18) Financial, commercial, operations, and technical and
7 research information and data submitted to or obtained by a health
8 sciences and services authority in applications for, or delivery of,
9 grants under RCW 35.104.010 through 35.104.060, to the extent that
10 such information, if revealed, would reasonably be expected to result
11 in private loss to providers of this information;

12 (19) Information gathered under chapter 19.85 RCW or RCW
