1 AN ACT Relating to common interest communities; amending RCW
2 64.32.250, 64.32.260, 64.34.076, 64.38.095, 64.90.010, 64.90.015,
3 64.90.210, 64.90.300, 64.90.360, 64.90.365, 64.90.405, 64.90.410,
4 64.90.435, 64.90.445, 64.90.455, 64.90.475, 64.90.480, 64.90.485,
5 64.90.513, 64.90.525, 64.90.530, 64.90.535, 64.90.580, 64.90.600,

12 **Sec. 1.** RCW 64.32.250 and 1963 c 156 s 25 are each amended to
13 read as follows:

14 (1) All apartment owners, tenants of such owners, employees of
15 such owners and tenants, and any other person that may in any manner
16 use the property or any part thereof submitted to the provisions of
17 this chapter, shall be subject to this chapter and to the declaration
18 and bylaws of the association of apartment owners adopted pursuant to
19 the provisions of this chapter.

20 (2) All agreements, decisions and determinations made by the
21 association of apartment owners under the provisions of this chapter,

1 the declaration, or the bylaws and in accordance with the voting
2 percentages established in this chapter, the declaration, or the
3 bylaws, shall be deemed to be binding on all apartment owners.

4 (3) In case of any conflict between Title 23B RCW or chapter
5 23.86, 24.03A, 24.06, or 25.15 RCW and this chapter, this chapter
6 controls.

1 **Sec. 6.** RCW 64.90.010 and 2024 c 321 s 301 are each amended to
2 read as follows:

3 The definitions in this section apply throughout this chapter
4 unless the context clearly requires otherwise.

5 (1) "Affiliate of a declarant" means any person who controls, is
6 controlled by, or is under common control with a declarant. For
7 purposes of this subsection:

8 (a) A person controls a declarant if the person:

9 (i) Is a general partner, managing member, officer, director, or
10 employer of the declarant;

11 (ii) Directly or indirectly or acting in concert with one or more
12 other persons, or through one or more subsidiaries, owns, controls,
13 holds with power to vote, or holds proxies representing more than 20
14 percent of the voting interest in the declarant;

15 (iii) Controls in any manner the election or appointment of a
16 majority of the directors, managing members, or general partners of
17 the declarant; or

18 (iv) Has contributed more than 20 percent of the capital of the
19 declarant.

20 (b) A person is controlled by a declarant if the declarant:

21 (i) Is a general partner, managing member, officer, director, or
22 employer of the person;

23 (ii) Directly or indirectly or acting in concert with one or more
24 other persons, or through one or more subsidiaries, owns, controls,
25 holds with power to vote, or holds proxies representing more than 20
26 percent of the voting interest in the person;

27 (iii) Controls in any manner the election or appointment of a
28 majority of the directors, managing members, or general partners of
29 the person; or

30 (iv) Has contributed more than 20 percent of the capital of the
31 person.

32 (c) Control does not exist if the powers described in this
33 subsection (1) are held solely as security for an obligation and are
34 not exercised.

35 (2) "Allocated interests" means the following interests allocated
36 to each unit:

37 (a) In a condominium, the undivided interest in the common
38 elements, the common expense liability, and votes in the association;

39 (b) In a cooperative, the common expense liability, the ownership
40 interest, and votes in the association; and

1 (c) In a plat community and miscellaneous community, the common
2 expense liability and the votes in the association, and also the
3 undivided interest in the common elements if owned in common by the
4 unit owners rather than an association.

5 (3) "Assessment" means all sums chargeable by the association
6 against a unit, including any assessments levied pursuant to RCW
7 64.90.480, fines or fees levied or imposed by the association
8 pursuant to this chapter or the governing documents, interest and
9 late charges on any delinquent account, and all costs of collection
10 incurred by the association in connection with the collection of a
11 delinquent owner's account, including reasonable attorneys' fees.

12 (4) "Association" or "unit owners association" means the unit
13 owners association organized under RCW 64.90.400 and, to the extent
14 necessary to construe sections of this chapter made applicable to
15 common interest communities pursuant to RCW 64.90.365, 64.90.090, or
16 64.90.370, the association organized or created to administer such
17 common interest communities.

18 (5) "Ballot" means a record designed to cast or register a vote
19 or consent in a form provided or accepted by the association.

20 (6) "Board" means the body, regardless of name, designated in the
21 declaration, map, or organizational documents, with primary authority
22 to manage the affairs of the association.

23 (7) "Common elements" means:

24 (a) In a condominium or cooperative, all portions of the common
25 interest community other than the units;

26 (b) In a plat community or miscellaneous community, any real
27 estate other than a unit within a plat community or miscellaneous
28 community that is owned or leased either by the association or in
29 common by the unit owners rather than an association; and

30 (c) In all common interest communities, any other interests in
31 real estate for the benefit of any unit owners that are subject to
32 the declaration.

33 (8) "Common expense" means ~~((any expense of the association,~~
34 ~~including allocations to reserves, allocated to all of the unit~~
35 ~~owners in accordance with common expense liability)) expenditures~~
36 made by, or financial liabilities of, the association, together with
37 any allocations to reserves.

38 (9) "Common expense liability" means the liability for common
39 expenses allocated to each unit pursuant to RCW 64.90.235.

1 (10) "Common interest community" means real estate described in a
2 declaration with respect to which a person, by virtue of the person's
3 ownership of a unit, is obligated to pay for a share of real estate
4 taxes, insurance premiums, maintenance, or improvement of, or
5 services or other expenses related to, common elements, other units,
6 or other real estate described in the declaration. "Common interest
7 community" does not include an arrangement described in RCW 64.90.110
8 or 64.90.115. A common interest community may be a part of another
9 common interest community.

10 (11) "Condominium" means a common interest community in which
11 portions of the real estate are designated for separate ownership and
12 the remainder of the real estate is designated for common ownership
13 solely by the owners of those portions. A common interest community
14 is not a condominium unless the undivided interests in the common
15 elements are vested in the unit owners.

16 (12) "Condominium notice" means the notice given to tenants
17 pursuant to subsection (13)(c) of this section.

18 (13)(a) "Conversion building" means a building:

19 (i) That at any time before creation of the common interest
20 community was lawfully occupied wholly or partially by a tenant or
21 subtenant for residential purposes pursuant to a rental agreement,
22 oral or written, express or implied, who did not receive a
23 (~~condominium~~) notice pursuant to (c) of this subsection prior to
24 entering into the rental agreement or lawfully taking occupancy,
25 whichever event occurred first; or

26 (ii) That at any time within the 12 months preceding the first
27 acceptance of an agreement with the declarant to convey, or the first
28 conveyance of, any unit in the building, whichever event occurred
29 first, to any person who was not a declarant or dealer, or affiliate
30 of a declarant or dealer, was lawfully occupied wholly or partially
31 by a tenant or subtenant for residential purposes pursuant to a
32 rental agreement, oral or written, express or implied, who did not
33 receive a condominium notice prior to entering into the rental
34 agreement or lawfully taking occupancy, whichever event occurred
35 first.

36 (b) A building in a common interest community is a conversion
37 building only if:

38 (i) The building contains more than two attached dwelling units
39 as defined in RCW 64.55.010(1); and

1 (ii) Acceptance of an agreement to convey, or conveyance of, any
2 unit in the building to any person who was not a declarant or dealer,
3 or affiliate of a declarant or dealer, did not occur prior to July 1,
4 2018.

5 (c) The notice referred to in (a)(i) and (ii) of this subsection
6 must be in writing and must state: "The unit you will be occupying
7 is, or may become, part of a common interest community and subject to
8 sale."

9 (14) "Convey" or "conveyance" means, with respect to a unit, any
10 transfer of ownership of the unit, including a transfer by deed or by
11 real estate contract and, with respect to a unit in a leasehold
12 common interest community or a proprietary lease in a cooperative, a
13 transfer by lease or assignment of the unit, but does not include the
14 creation, transfer, or release of a security interest.

15 (15) "Cooperative" means a common interest community in which the
16 real estate is owned by an association, each member of which is
17 entitled by virtue of the member's ownership interest in the
18 association and by a proprietary lease to exclusive possession of a
19 unit.

20 (16) "Dealer" means a person who, together with such person's
21 affiliates, owns or has a right to acquire either six or more units
22 in a common interest community or 50 percent or more of the units in
23 a common interest community containing more than two units.

24 (17) "Declarant" means:

25 (a) Any person who executes as declarant a declaration;

26 (b) Any person who reserves or succeeds to any special declarant
27 right in a declaration;

28 (c) Any person who exercises special declarant rights or to whom
29 special declarant rights are transferred of record. The holding or
30 exercise of rights to maintain sales offices, signs advertising the
31 common interest community, and models, and related right of access,
32 does not confer the status of being a declarant; or

33 (d) Any person who is the owner of a fee interest in the real
34 estate that is subjected to the declaration at the time of the
35 recording of an instrument pursuant to RCW 64.90.425 and who directly
36 or through one or more affiliates is materially involved in the
37 construction, marketing, or sale of units in the common interest
38 community created by the recording of the instrument.

39 (18) "Declarant control" means the right of the declarant or
40 persons designated by the declarant to appoint or remove any officer

1 or board member of the association or to veto or approve a proposed
2 action of any board or association, pursuant to RCW 64.90.415(1) (a).

3 (19) "Declaration" means the instrument, however denominated,
4 that creates a common interest community, including any amendments to
5 the instrument.

6 (20) "Development rights" means any right or combination of
7 rights reserved by a declarant in the declaration to:

8 (a) Add real estate or improvements to a common interest
9 community;

10 (b) Create units, common elements, or limited common elements
11 within a common interest community;

12 (c) Subdivide or combine units or convert units into common
13 elements;

14 (d) Withdraw real estate from a common interest community; or

15 (e) Reallocate limited common elements with respect to units that
16 have not been conveyed by the declarant.

17 (21) "Effective age" means the difference between the useful life
18 and remaining useful life.

19 (22) "Electronic" means relating to technology having electrical,
20 digital, magnetic, wireless, optical, electromagnetic, or similar
21 capabilities.

22 (23) "Electronic transmission" or "electronically transmitted"
23 means any electronic communication (a) not directly involving the
24 physical transfer of a record in a tangible medium and (b) that may
25 be retained, retrieved, and reviewed by the sender and the recipient
26 of the communication, and that may be directly reproduced in a
27 tangible medium by a sender and recipient.

28 (24) "Eligible mortgagee" means the holder of a security interest
29 on a unit that has filed with the secretary of the association a
30 written request that it be given copies of notices of any action by
31 the association that requires the consent of mortgagees.

32 (25) "Foreclosure" means a statutory forfeiture or a judicial or
33 nonjudicial foreclosure of a security interest or a deed or other
34 conveyance in lieu of a security interest.

35 (26) "Full funding plan" means a reserve funding goal of
36 achieving 100 percent fully funded reserves by the end of the 30-year
37 study period described under RCW 64.90.550, in which the reserve
38 account balance equals the sum of the estimated costs required to
39 maintain, repair, or replace the deteriorated portions of all reserve
40 components.

1 (27) "Fully funded balance" means the current value of the
2 deteriorated portion, not the total replacement value, of all the
3 reserve components. The fully funded balance for each reserve
4 component is calculated by multiplying the current replacement cost
5 of that reserve component by its effective age, then dividing the
6 result by that reserve component's useful life. The sum total of all
7 reserve components' fully funded balances is the association's fully
8 funded balance.

9 (28) "Governing documents" means the organizational documents,
10 map, declaration, rules, or other written instrument by which the
11 association has the authority to exercise any of the powers provided
12 for in this chapter or to manage, maintain, or otherwise affect the
13 property under its jurisdiction.

14 (29) "Identifying number" means a symbol or address that
15 identifies only one unit or limited common element in a common
16 interest community.

17 (30) "Leasehold common interest community" means a common
18 interest community in which all or a portion of the real estate is
19 subject to a lease the expiration or termination of which will
20 terminate the common interest community or reduce its size.

21 (31) "Limited common element" means a portion of the common
22 elements allocated by the declaration or by operation of RCW
23 64.90.210 (1)(b) or (3) for the exclusive use of one or more, but
24 fewer than all, of the unit owners.

25 (32) "Map" means: (a) With respect to a plat community, the plat
26 as defined in RCW 58.17.020 and complying with the requirements of
27 Title 58 RCW, and (b) with respect to a condominium, cooperative, or
28 miscellaneous community, a map prepared in accordance with the
29 requirements of RCW 64.90.245.

30 (33) "Master association" means:

31 (a) A unit owners association that serves more than one common
32 interest community; or

33 (b) An organization that holds a power delegated under RCW
34 64.90.300(1)(a).

35 (34) "Miscellaneous community" means a common interest community
36 in which units are lawfully created in a manner not inconsistent with
37 chapter 58.17 RCW and that is not a condominium, cooperative, or plat
38 community.

39 (35) "Nominal reserve costs" means that the current estimated
40 total replacement costs of the reserve components are less than 50

1 percent of the annual budgeted expenses of the association, excluding
2 contributions to the reserve fund, for a condominium or cooperative
3 containing horizontal unit boundaries, and less than 75 percent of
4 the annual budgeted expenses of the association, excluding
5 contributions to the reserve fund, for all other common interest
6 communities.

7 (36) "Organizational documents" means the instruments filed with
8 the secretary of state to create an entity and the instruments
9 governing the internal affairs of the entity including, but not
10 limited to, any articles of incorporation, certificate of formation,
11 bylaws, and limited liability company or partnership agreement.

12 (37) "Person" means an individual, corporation, business trust,
13 estate, the trustee or beneficiary of a trust that is not a business
14 trust, partnership, limited liability company, association, joint
15 venture, public corporation, government, or governmental subdivision,
16 agency, or instrumentality, or any other legal entity.

17 (38) "Plat community" means a common interest community in which
18 units have been created by subdivision or short subdivision as both
19 are defined in RCW 58.17.020 and in which the boundaries of units are
20 established pursuant to chapter 58.17 RCW.

21 (39) "Proprietary lease" means a written and recordable lease
22 that is executed and acknowledged by the association as lessor and
23 that otherwise complies with requirements applicable to a residential
24 lease of more than one year and pursuant to which a member is
25 entitled to exclusive possession of a unit in a cooperative. A
26 proprietary lease governed under this chapter is not subject to
27 chapter 59.18 RCW except as provided in the declaration.

28 (40) "Purchaser" means a person, other than a declarant or a
29 dealer, which by means of a voluntary transfer acquires a legal or
30 equitable interest in a unit other than as security for an
31 obligation.

32 (41) "Qualified financial institution" means a bank, savings
33 association, or credit union whose deposits are insured by the
34 federal government.

35 (42) "Real estate" means any leasehold or other estate or
36 interest in, over, or under land, including structures, fixtures, and
37 other improvements and interests that by custom, usage, or law pass
38 with a conveyance of land though not described in the contract of
39 sale or instrument of conveyance. "Real estate" includes parcels with

1 or without upper or lower boundaries and spaces that may be filled
2 with air or water.

3 (43) "Real estate contract" has the same meaning as defined in
4 RCW 61.30.010.

5 (44) "Record," when used as a noun, means information inscribed
6 on a tangible medium or contained in an electronic transmission.

7 (45) "Remaining useful life" means the estimated time, in years,
8 before a reserve component will require major maintenance, repair, or
9 replacement to perform its intended function.

10 (46) "Replacement cost" means the estimated total cost to
11 maintain, repair, or replace a reserve component to its original
12 functional condition.

13 (47) "Reserve component" means a physical component of the common
14 interest community which the association is obligated to maintain,
15 repair, or replace, which has an estimated useful life of less than
16 30 years, and for which the cost of such maintenance, repair, or
17 replacement is infrequent, significant, and impractical to include in
18 an annual budget.

19 (48) "Reserve study professional" means an independent person who
20 is suitably qualified by knowledge, skill, experience, training, or
21 education to prepare a reserve study in accordance with RCW 64.90.545
22 and 64.90.550. For the purposes of this subsection, "independent"
23 means a person who is not an employee, officer, or director, and has
24 no pecuniary interest in the declarant, association, or any other
25 party for whom the reserve study is prepared.

26 (49) "Residential purposes" means use for dwelling or
27 recreational purposes, or both.

28 (50) "Rule" means a policy, guideline, restriction, procedure, or
29 regulation of an association, however denominated, that is not set
30 forth in the declaration or organizational documents.

31 (51) "Security interest" means an interest in real estate or
32 personal property, created by contract or conveyance that secures
33 payment or performance of an obligation. "Security interest" includes
34 a lien created by a mortgage, deed of trust, real estate contract,
35 lease intended as security, assignment of lease or rents intended as
36 security, pledge of an ownership interest in an association, and any
37 other consensual lien or title retention contract intended as
38 security for an obligation.

39 (52) "Special declarant rights" means rights reserved for the
40 benefit of a declarant to:

1 (a) Complete any improvements the declarant is not obligated to
2 make that are indicated on the map or described in the declaration or
3 the public offering statement;

4 (b) Exercise any development right, pursuant to RCW 64.90.250;

5 (c) Maintain sales offices, management offices, signs advertising
6 the common interest community, and models, pursuant to RCW 64.90.275;

7 (d) Use easements through the common elements for the purpose of
8 making improvements within the common interest community or within
9 real estate that may be added to the common interest community,
10 pursuant to RCW 64.90.280;

11 (e) Make the common interest community subject to a master
12 association, pursuant to RCW 64.90.300;

13 (f) Merge or consolidate a common interest community with another
14 common interest community, pursuant to RCW 64.90.310;

15 (g) Appoint or remove any officer or board member of the
16 association or any master association or to veto or approve a
17 proposed action of any board or association, pursuant to RCW
18 64.90.415(1);

19 (h) Control any construction, design review, or aesthetic
20 standards committee or process, pursuant to RCW 64.90.505(3);

21 (i) Attend meetings of the unit owners and, except during an
22 executive session, the board, pursuant to RCW 64.90.445;

23 (j) Have access to the records of the association to the same
24 extent as a unit owner, pursuant to RCW 64.90.495.

25 (53) "Specially allocated expense" means any common expense of
26 the association, including allocations to reserves, allocated on a
27 basis other than the common expense liability pursuant to RCW
28 64.90.480.

29 (54) "Survey" has the same meaning as defined in RCW 58.09.020.

30 (55) "Tangible medium" means a writing, copy of a writing,
31 facsimile, or a physical reproduction, each on paper or on other
32 tangible material.

33 (56) "Timeshare" has the same meaning as defined in RCW
34 64.36.010.

35 (57) "Transition meeting" means the meeting held pursuant to RCW
36 64.90.415(4).

37 (58) (a) "Unit" means a physical portion of the common interest
38 community designated for separate ownership or occupancy, the
39 boundaries of which are described pursuant to RCW 64.90.225(1)(d).

1 (b) If a unit in a cooperative is owned by a unit owner or is
2 sold, conveyed, voluntarily or involuntarily encumbered, or otherwise
3 transferred by a unit owner, the interest in that unit that is owned,
4 sold, conveyed, encumbered, or otherwise transferred is the right to
5 possession of that unit under a proprietary lease, coupled with the
6 allocated interests of that unit, and the association's interest in
7 that unit is not affected.

8 (c) Except as provided in the declaration, a mobile home or
9 manufactured home for which title has been eliminated pursuant to
10 chapter 65.20 RCW is part of the unit described in the title
11 elimination documents.

12 (59)(a) "Unit owner" means (i) a declarant or other person that
13 owns a unit or (ii) a lessee of a unit in a leasehold common interest
14 community whose lease expires simultaneously with any lease the
15 expiration or termination of which will remove the unit from the
16 common interest community, but does not include a person having an
17 interest in a unit solely as security for an obligation.

18 (b) "Unit owner" also means the vendee, not the vendor, of a unit
19 under a recorded real estate contract.

20 (c) In a condominium, plat community, or miscellaneous community,
21 the declarant is the unit owner of any unit created by the
22 declaration. In a cooperative, the declarant is treated as the unit
23 owner of any unit to which allocated interests have been allocated
24 until that unit has been conveyed to another person.

25 (60) "Useful life" means the estimated time during which a
26 reserve component is expected to perform its intended function
27 without major maintenance, repair, or replacement.

28 (61) "Writing" does not include an electronic transmission.

29 (62) "Written" means embodied in a tangible medium.

30 **Sec. 7.** RCW 64.90.015 and 2018 c 277 s 103 are each amended to
31 read as follows:

32 (1) Except as expressly provided in this chapter, the effect of
33 the provisions of this chapter may not be varied by agreement((7));
34 the governing documents may not vary a provision of this chapter that
35 gives a right to or imposes an obligation or liability on a unit
36 owner, declarant, association, or board; and rights conferred by this
37 chapter may not be waived. Except as provided otherwise in RCW

13 (B) Recording date of the trust deed or mortgage;

14 (C) Recording information;

15 (D) Name of (~~condominium~~) common interest community, unit
16 owner, and unit designation stated in the declaration or applicable
17 supplemental declaration;

18 (E) Amount of unpaid assessment; and

19 (F) A statement that failure to, within 60 days of the written
20 notice, submit the association payment of six months of assessments
21 as described in (a)(i) of this subsection will result in the priority
22 of the amounts described in (a)(ii) of this subsection; and

23 (iv) Upon payment of the amounts described in (a)(i) and (ii) of
24 this subsection by the holder of a security interest, the
25 association's lien described in this subsection (3)(a) shall
26 thereafter be fully subordinated to the lien of such holder's
27 security interest on the unit.

28 (b) For the purposes of this subsection:

29 (i) "Institution of proceedings" means either:

30 (A) The date of recording of a notice of trustee's sale by a deed
31 of trust beneficiary;

32 (B) The date of commencement, pursuant to applicable court rules,
33 of an action for judicial foreclosure either by the association or by
34 the holder of a recorded security interest; or

35 (C) The date of recording of a notice of intention to forfeit in
36 a real estate contract forfeiture proceeding by the vendor under a
37 real estate contract.

38 (ii) "Capital improvements" does not include making, in the
39 ordinary course of management, repairs to common elements or
40 replacements of the common elements with substantially similar items,

1 subject to: (A) Availability of materials and products, (B)
2 prevailing law, or (C) sound engineering and construction standards
3 then prevailing.

4 (c) The adoption of a periodic budget that purports to allocate
5 to a unit any fines, late charges, interest, attorneys' fees and
6 costs incurred for services unrelated to the foreclosure of the
7 association's lien, other collection charges, or specially allocated
8 assessments assessed under RCW 64.90.480(6) (~~or (7)~~) does not cause
9 any such items to be included in the priority amount affecting such
10 unit.

11 (4) Subsections (2) and (3) of this section do not affect the
12 priority of mechanics' or material suppliers' liens to the extent
13 that law of this state other than chapter 277, Laws of 2018 gives
14 priority to such liens, or the priority of liens for other
15 assessments made by the association.

16 (5) A lien under this section is not subject to chapter 6.13 RCW.

17 (6) If the association forecloses its lien under this section
18 nonjudicially pursuant to chapter 61.24 RCW, as provided under
19 subsection (13) of this section, the association is not entitled to
20 the lien priority provided for under subsection (3) of this section,
21 and is subject to the limitations on deficiency judgments as provided
22 in chapter 61.24 RCW.

23 (7) Unless the declaration provides otherwise, if two or more
24 associations have liens for assessments created at any time on the
25 same property, those liens have equal priority as to each other, and
26 any foreclosure of one such lien shall not affect the lien of the
27 other.

28 (8) Recording of the declaration constitutes record notice and
29 perfection of the statutory lien created under this section. Further
30 notice or recordation of any claim of lien for assessment under this
31 section is not required, but is not prohibited.

32 (9) A lien for unpaid assessments and the personal liability for
33 payment of those assessments are extinguished unless proceedings to
34 enforce the lien or collect the debt are instituted within six years
35 after the full amount of the assessments sought to be recovered
36 becomes due.

37 (10) This section does not prohibit actions against unit owners
38 to recover sums for which subsection (1) of this section creates a
39 lien or prohibit an association from taking a deed in lieu of
40 foreclosure.

1 (11) The association upon written request must furnish to a unit
2 owner or a mortgagee a statement signed by an officer or authorized
3 agent of the association setting forth the amount of unpaid
4 assessments or the priority amount against that unit, or both. The
5 statement must be furnished within 15 days after receipt of the
6 request and is binding on the association, the board, and every unit
7 owner unless, and to the extent, known by the recipient to be false.
8 The liability of a recipient who reasonably relies upon the statement
9 must not exceed the amount set forth in any statement furnished
10 pursuant to this section or RCW 64.90.640(1)(b).

11 (12) In a cooperative, upon nonpayment of an assessment on a
12 unit, the unit owner may be evicted in the same manner as provided by
13 law in the case of an unlawful holdover by a commercial tenant, and
14 the lien may be foreclosed as provided under this section.

15 (13) The association's lien may be foreclosed in accordance with
16 (a) and (b) of this subsection.

17 (a) In a common interest community other than a cooperative, the
18 association's lien may be foreclosed judicially in accordance with
19 chapter 61.12 RCW, subject to any rights of redemption under chapter
20 6.23 RCW.

21 (b) The lien may be enforced nonjudicially in the manner set
22 forth in chapter 61.24 RCW for nonjudicial foreclosure of deeds of
23 trust if the declaration: Contains a grant of the common interest
24 community in trust to a trustee qualified under RCW 61.24.010 to
25 secure the obligations of the unit owners to the association for the
26 payment of assessments, contains a power of sale, provides in its
27 terms that the units are not used principally for agricultural
28 purposes, and provides that the power of sale is operative in the
29 case of a default in the obligation to pay assessments. The
30 association or its authorized representative may purchase the unit at
31 the foreclosure sale and acquire, hold, lease, mortgage, or convey
32 the unit. Upon an express waiver in the complaint of any right to a
33 deficiency judgment in a judicial foreclosure action, the period of
34 redemption is eight months.

35 (c) In a cooperative in which the unit owners' interests in the
36 units are real estate, the association's lien must be foreclosed in
37 like manner as a mortgage on real estate or by power of sale under
38 (b) of this subsection.

39 (d) In a cooperative in which the unit owners' interests in the
40 units are personal property, the association's lien must be

1 foreclosed in like manner as a security interest under chapter 62A.9A
2 RCW.

3 (e) No member of the association's board, or their immediate
4 family members or affiliates, are eligible to bid for or purchase,
5 directly or indirectly, any interest in a unit at a foreclosure of
6 the association's lien. For the purposes of this subsection,
7 "immediate family member" includes spouses, domestic partners,
8 children, siblings, parents, parents-in-law, and stepfamily members;
9 and "affiliate" of a board member includes any person controlled by
10 the board member, including any entity in which the board member is a
11 general partner, managing member, majority member, officer, or
12 director. Nothing in this subsection prohibits an association from
13 bidding for or purchasing interest in a unit at a foreclosure of the
14 association's lien.

15 (14) If the unit owner's interest in a unit in a cooperative is
16 real estate, the following requirements apply:

17 (a) The association, upon nonpayment of assessments and
18 compliance with this subsection, may sell that unit at a public sale
19 or by private negotiation, and at any time and place. The association
20 must give to the unit owner and any lessee of the unit owner
21 reasonable notice in a record of the time, date, and place of any
22 public sale or, if a private sale is intended, of the intention of
23 entering into a contract to sell and of the time and date after which
24 a private conveyance may be made. Such notice must also be sent to
25 any other person that has a recorded interest in the unit that would
26 be cut off by the sale, but only if the recorded interest was on
27 record seven weeks before the date specified in the notice as the
28 date of any public sale or seven weeks before the date specified in
29 the notice as the date after which a private sale may be made. The
30 notices required under this subsection may be sent to any address
31 reasonable in the circumstances. A sale may not be held until five
32 weeks after the sending of the notice. The association may buy at any
33 public sale and, if the sale is conducted by a fiduciary or other
34 person not related to the association, at a private sale.

35 (b) Unless otherwise agreed to or as stated in this section, the
36 unit owner is liable for any deficiency in a foreclosure sale.

37 (c) The proceeds of a foreclosure sale must be applied in the
38 following order:

39 (i) The reasonable expenses of sale;

1 (ii) The reasonable expenses of securing possession before sale;
2 the reasonable expenses of holding, maintaining, and preparing the
3 unit for sale, including payment of taxes and other governmental
4 charges and premiums on insurance; and, to the extent provided for by
5 agreement between the association and the unit owner, reasonable
6 attorneys' fees, costs, and other legal expenses incurred by the
7 association;

8 (iii) Satisfaction of the association's lien;

9 (iv) Satisfaction in the order of priority of any subordinate
10 claim of record; and

11 (v) Remittance of any excess to the unit owner.

12 (d) A good-faith purchaser for value acquires the unit free of
13 the association's debt that gave rise to the lien under which the
14 foreclosure sale occurred and any subordinate interest, even though
15 the association or other person conducting the sale failed to comply
16 with this section. The person conducting the sale must execute a
17 conveyance to the purchaser sufficient to convey the unit and stating
18 that it is executed by the person after a foreclosure of the
19 association's lien by power of sale and that the person was empowered
20 to make the sale. Signature and title or authority of the person
21 signing the conveyance as grantor and a recital of the facts of
22 nonpayment of the assessment and of the giving of the notices
23 required under this subsection are sufficient proof of the facts
24 recited and of the authority to sign. Further proof of authority is
25 not required even though the association is named as grantee in the
26 conveyance.

27 (e) At any time before the association has conveyed a unit in a
28 cooperative or entered into a contract for its conveyance under the
29 power of sale, the unit owners or the holder of any subordinate
30 security interest may cure the unit owner's default and prevent sale
31 or other conveyance by tendering the performance due under the
32 security agreement, including any amounts due because of exercise of
33 a right to accelerate, plus the reasonable expenses of proceeding to
34 foreclosure incurred to the time of tender, including reasonable
35 attorneys' fees and costs of the creditor.

36 (15) In an action by an association to collect assessments or to
37 foreclose a lien on a unit under this section, the court may appoint
38 a receiver to collect all sums alleged to be due and owing to a unit
39 owner before commencement or during pendency of the action. The
40 receivership is governed under chapter 7.60 RCW. During pendency of

1 the action, the court may order the receiver to pay sums held by the
2 receiver to the association for any assessments against the unit. The
3 exercise of rights under this subsection by the association does not
4 affect the priority of preexisting liens on the unit.

5 (16) Except as provided in subsection (3) of this section, the
6 holder of a mortgage or other purchaser of a unit who obtains the
7 right of possession of the unit through foreclosure is not liable for
8 assessments or installments of assessments that became due prior to
9 such right of possession. Such unpaid assessments are deemed to be
10 common expenses collectible from all the unit owners, including such
11 mortgagee or other purchaser of the unit. Foreclosure of a mortgage
12 does not relieve the prior unit owner of personal liability for
13 assessments accruing against the unit prior to the date of such sale
14 as provided in this subsection.

15 (17) In addition to constituting a lien on the unit, each
16 assessment is the joint and several obligation of the unit owner of
17 the unit to which the same are assessed as of the time the assessment
18 is due. A unit owner may not exempt himself or herself from liability
19 for assessments. In a voluntary conveyance other than by foreclosure,
20 the grantee of a unit is jointly and severally liable with the
21 grantor for all unpaid assessments against the grantor up to the time
22 of the grantor's conveyance, without prejudice to the grantee's right
23 to recover from the grantor the amounts paid by the grantee. Suit to
24 recover a personal judgment for any delinquent assessment is
25 maintainable in any court of competent jurisdiction without
26 foreclosing or waiving the lien securing such sums.

27 (18) The association may from time to time establish reasonable
28 late charges and a rate of interest to be charged, not to exceed the
29 maximum rate calculated under RCW 19.52.020, on all subsequent
30 delinquent assessments or installments of assessments. If the
31 association does not establish such a rate, delinquent assessments
32 bear interest from the date of delinquency at the maximum rate
33 calculated under RCW 19.52.020 on the date on which the assessments
34 became delinquent.

35 (19) The association is entitled to recover any costs and
36 reasonable attorneys' fees incurred in connection with the collection
37 of delinquent assessments, whether or not such collection activities
38 result in a suit being commenced or prosecuted to judgment. The
39 prevailing party is also entitled to recover costs and reasonable

1 attorneys' fees in such suits, including any appeals, if it prevails
2 on appeal and in the enforcement of a judgment.

3 (20) To the extent not inconsistent with this section, the
4 declaration may provide for such additional remedies for collection
5 of assessments as may be permitted by law.

6 (21)(a) When the association mails to the unit owner by first-
7 class mail the first notice of delinquency for past due assessments
8 to the unit address and to any other address that the owner has
9 provided to the association, the association shall include a first
10 preforeclosure notice that states as follows:

11 **THIS IS A NOTICE OF DELINQUENCY FOR PAST DUE ASSESSMENTS**
12 **FROM THE UNIT OWNERS ASSOCIATION TO WHICH YOUR HOME BELONGS.**
13 **THIS NOTICE IS ONE STEP IN A PROCESS THAT COULD RESULT IN YOUR LOSING**
14 **YOUR HOME.**
15 **CONTACT A HOUSING COUNSELOR OR AN ATTORNEY LICENSED IN WASHINGTON NOW**
16 to assess your situation and refer you to mediation if you might
17 benefit. **DO NOT DELAY.**

35 information from the department of commerce for inclusion in the
36 notice.

37 (b) If, when a delinquent account is referred to an association's
38 attorney, the first preforeclosure notice required under (a) of this
39 subsection has not yet been mailed to the unit owner, the association

1 or the association's attorney shall mail the first preforeclosure
2 notice to the unit owner in order to satisfy the requirement in (a)
3 of this subsection.

4 (c) Mailing the first preforeclosure notice pursuant to (a) of
5 this subsection does not satisfy the requirement in subsection
6 (22)(b) of this section to mail a second preforeclosure notice at or
7 after the date that assessments have become past due for at least 90
8 days. The second preforeclosure notice may not be mailed sooner than
9 60 days after the first preforeclosure notice is mailed.

10 (22) An association may not commence an action to foreclose a
11 lien on a unit under this section unless:

12 (a) The unit owner, at the time the action is commenced, owes at
13 least a sum equal to the greater of:

14 (i) Three months or more of assessments, not including fines,
15 late charges, interest, attorneys' fees, or costs incurred by the
16 association in connection with the collection of a delinquent owner's
17 account; or

18 (ii) \$2,000 of assessments, not including fines, late charges,
19 interest, attorneys' fees, or costs incurred by the association in
20 connection with the collection of a delinquent owner's account;

21 (b) At or after the date that assessments have become past due
22 for at least 90 days, but no sooner than 60 days after the first
23 preforeclosure notice required in subsection (21)(a) of this section
24 is mailed, the association has mailed, by first-class mail, to the
25 owner, at the unit address and to any other address which the owner
26 has provided to the association, a second notice of delinquency,
27 which must include a second preforeclosure notice that contains the
28 same information as the first preforeclosure notice provided to the
29 owner pursuant to subsection (21)(a) of this section. The second
30 preforeclosure notice may not be mailed sooner than 60 days after the
31 first preforeclosure notice required in subsection (21)(a) of this
32 section is mailed;

33 (c) At least 90 days have elapsed from the date the minimum
34 amount required in (a) of this subsection has accrued; and

35 (d) The board approves commencement of a foreclosure action
36 specifically against that unit.

37 (23) Every aspect of a collection, foreclosure, sale, or other
38 conveyance under this section, including the method, advertising,
39 time, date, place, and terms, must be commercially reasonable.

1 **Sec. 20.** RCW 64.90.513 and 2022 c 27 s 4 are each amended to
2 read as follows:

3 (1)(a) A unit owners association may not adopt or enforce a
4 restriction, covenant, condition, bylaw, rule, regulation, provision
5 of a governing document, or master deed provision that:

6 (i) Effectively prohibits or unreasonably restricts the
7 installation or use of an electric vehicle charging station in
8 compliance with the requirements of this section and for the personal
9 noncommercial use of a unit owner, within the boundaries of a unit or
10 in a designated parking space; or

11 (ii) Is in conflict with the provisions of this section.

12 (b) Nothing in this section prohibits an association from
13 imposing reasonable restrictions on electric vehicle charging
14 stations. However, it is the policy of the state to promote,

17 (c) Notwithstanding (a) or (b) of this subsection, an association
18 of single-family homes, site condominiums, or a planned use

23 (ii) Is connected to a common electrical power supply; or

28 an application for approval for the installation of an electric
29 vehicle charging station before installing the charging station

33 electric vehicle charging station subject to subsection (2) of this
34 section, the application for approval must be processed and approved
35 in the same manner as an application for approval of an architectural
36 modification.

37 (b) The approval or denial of an application must be in writing
38 and must not be willfully avoided or delayed.

39 (c) If an application is not denied in writing within 60 days
40 from the date of receipt of the application, the application is

1 deemed approved, unless that delay is the result of a reasonable
2 request for additional information.

3 (d) An association may not assess or charge a unit owner a fee
4 for the placement of an electric vehicle charging station. An
5 association may charge a reasonable fee for processing the
6 application to approve the installation of an electric vehicle
7 charging station, but only if such a fee exists for all applications
8 for approval of architectural modifications.

9 (4) If approval is required for the installation or use of an
10 electric vehicle charging station subject to subsection (2) of this
11 section, a unit owners association must approve the installation
12 within the boundaries of a unit or in a designated parking space if
13 the installation is reasonably possible and the unit owner agrees in

15 (a) Comply with the association's reasonable architectural
16 standards applicable to the installation of the electric vehicle
17 charging station;

18 (b) Engage an electrical contractor familiar with the standards

20 existing infrastructure necessary to support the proposed electric
21 vehicle charging station, identify additional infrastructure needs,
22 and install the electric vehicle charging station;

23 (c)(i) Provide, within the time specified in (c)(ii) of this
24 subsection, a certificate of insurance naming the association as an
25 additional insured on the unit owner's insurance policy for any claim
26 related to the installation, inspection, maintenance, or use of the
27 electric vehicle charging station in a common interest community
28 other than an association of single-family homes, site condominiums,
29 or a planned use development where the units are not immediately
30 adjacent;

31 (ii) A certificate of insurance required under (c)(i) of this
32 subsection must be provided within 14 days after the association
33 approves the installation of the electric vehicle charging station.
34 Reimbursement for an increased insurance premium amount under (c)(i)
35 of this subsection must be provided within 14 days after the unit
36 owner receives the association's invoice for the amount attributable
37 to the charging station;

38 (d) Register the electric vehicle charging station with the
39 association within 30 days after installation;

1 (e) Pay for the electricity usage associated with the electric
2 vehicle charging station and the required means to facilitate payment
3 for the electricity; and

4 (f) Comply with the requirements of this section.

5 (5)(a) A unit owner must obtain any permit or approval for an
6 electric vehicle charging station as required by the local government
7 in which the common interest community is located and comply with all
8 relevant building codes and safety standards.

9 (b) An electric vehicle charging station must meet all applicable
10 health and safety standards and requirements imposed by national,
11 state, or local authorities, and all other applicable zoning, land
12 use or other ordinances, building codes, or land use permits.

13 (6)(a) Unless otherwise agreed to by written contract with the
14 unit owners association, a unit owner is responsible for the costs of
15 installing an electric vehicle charging station.

16 (b) Electric vehicle charging station equipment that is installed
17 at the unit owner's cost and is removable without damage to the
18 property owned by others may be removed at the unit owner's cost.
19 Nothing in this subsection requires the association to purchase the
20 electric vehicle charging station.

21 (7) ((A)) When an installed electric vehicle charging station is
22 not exempt from restrictions pursuant to subsection (1)(c) of this
23 section, a unit owner must disclose to any prospective buyers of the

25 (a) The existence of an electric vehicle charging station and the
26 related responsibilities of the owner under this section; and

27 (b) Whether the electric vehicle charging station is removable
28 and whether the owner intends to remove the charging station.

31 into service and the location of any components thereof, the owner
32 and each successive owner of an electric vehicle charging station
33 exclusively serving the owner's unit is responsible for:

34 (a) Costs for the inspection, maintenance, repair, and
35 replacement of the electric vehicle charging station up until the
36 station is removed;

37 (b) Costs for damage to the electric vehicle charging station,
38 any unit, common element, or limited common element resulting from
39 the installation, use, inspection, maintenance, repair, removal, or
40 replacement of the electric vehicle charging station;

1 (c) The cost of electricity associated with the electric vehicle
2 charging station;

3 (d) Obtaining and maintaining an insurance policy that meets the
4 requirements in subsection (4) (c) of this section;

5 (e) If the owner decides to remove the electric vehicle charging
6 station, costs for the removal and the restoration of the common
7 element or limited common element after the removal; and

8 (f) Removing the electric vehicle charging station if reasonably
9 necessary for the inspection, repair, maintenance, or replacement of
10 the common element or limited common element.

11 (9) A unit owners association may install an electric vehicle
12 charging station in the common elements for the use of all unit
13 owners and, in that case, the association must develop appropriate
14 terms of use for the charging station.

15 (10)(a) A unit owners association that willfully violates this
16 section is liable to the unit owner for actual damages, and shall pay
17 a civil penalty to the unit owner in an amount not to exceed \$1,000.

18 (b) In any action by a unit owner requesting to have an electric
19 vehicle charging station installed and seeking to enforce compliance
20 with this section, the court shall award reasonable attorneys' fees
21 and costs to any prevailing unit owner.

22 (11) The definitions in this subsection apply throughout this
23 section unless the context clearly requires otherwise.

24 (a) "Designated parking space" means a parking space that is
25 specifically designated for use by a particular unit owner, including
26 a garage, a deeded parking space, and a parking space in a limited
27 common element that is restricted for use by one or more unit owners.

28 (b) "Electric vehicle charging station" means a station that
29 delivers electricity from a source outside an electric vehicle into
30 one or more electric vehicles. An electric vehicle charging station
31 may include several charge points simultaneously connecting several

34 (c) "Reasonable restriction" means a restriction that does not

1 (1) (a) Within thirty days after adoption of any proposed budget
2 for the common interest community, the board must provide a copy of
3 the budget to all the unit owners and set a date for a meeting of the

27 (f) The current deficiency or surplus in reserve funding

29 (3) The board, at any time, may propose a special assessment. The
30 assessment is effective only if the board follows the procedures for
31 ratification of a budget described in subsection (1) of this section
32 and the unit owners do not reject the proposed assessment. The board
33 may provide that the special assessment may be due and payable in
34 installments over any period it determines and may provide a discount

2 or any of the common elements contained in the governing documents;

4 (iv) Any restriction on the amount for which a unit may be sold

8 (y) Any current or expected fees or charges not included in the

20 (kk) Any liens on real estate to be conveyed to the association

22 (ll) A list of any physical hazards known to the declarant that
23 particularly affect the common interest community or the immediate
24 vicinity in which the common interest community is located and which
25 are not readily ascertainable by the purchaser;

26 (mm) Any building code violation of which the declarant has
27 actual knowledge and which has not been corrected;

28 (nn) If the common interest community contains one or more
29 conversion buildings, the information required under RCW 64.90.620
30 and 64.90.655(6)(a);

31 (oo) If the public offering statement is related to conveyance of
32 a unit in a multiunit residential building as defined in RCW
33 64.55.010, for which the final certificate of occupancy was issued
34 more than 60 calendar months prior to the preparation of the public
35 offering statement either: A copy of a report prepared by an
36 independent, licensed architect or engineer or a statement by the
37 declarant based on such report that describes, to the extent
38 reasonably ascertainable, the present condition of all structural
39 components and mechanical and electrical installations of the

29 (i) "QUALIFIED WARRANTY. Your unit [is] [is not] covered by a

5 already obtained sufficient proof of the borrower's death, it may
6 proceed by acknowledging the claimant's notice in writing and issuing
7 a request under (b) of this subsection.

8 (b) If the mortgage servicer or trustee obtains or receives
9 written documentation of the death of the borrower or grantor from
10 the claimant, or otherwise independently confirms the death of the
11 borrower or grantor, then the servicer or trustee must request in
12 writing documentation from the claimant demonstrating the ownership
13 interest of the claimant in the real property. A claimant has 60 days
14 from the date of the request to present this documentation.
15 Documentation demonstrating the ownership interest of the claimant in
16 the real property includes, but is not limited to, one of the
17 following:

18 (i) Excerpts of a trust document noting the claimant as a
19 beneficiary of a trust with title to the real property;

20 (ii) A will of the borrower or grantor listing the claimant as an
21 heir or devisee with respect to the real property;

22 (iii) A probate order or finding of heirship issued by any court
23 documenting the claimant as an heir or devisee or awarding the real
24 property to the claimant;

25 (iv) A recorded lack of probate affidavit signed by any heir
26 listing the claimant as an heir of the borrower or grantor pursuant
27 to the laws of intestacy;

28 (v) A deed, such as a personal representative's deed, trustee's
29 deed issued on behalf of a trust, statutory warranty deed, transfer
30 on death deed, or other deed, giving any ownership interest to the
31 claimant resulting from the death of the borrower or grantor or
32 executed by the borrower or grantor for estate planning purposes; and

33 (vi) Other proof documenting the claimant as an heir of the
34 borrower or grantor pursuant to state rules of intestacy set forth in
35 chapter 11.04 RCW.

36 (c) If the mortgage servicer or trustee receives written
37 documentation demonstrating the ownership interest of the claimant
38 prior to the expiration of the 60 days provided in (b) of this
39 subsection, then the servicer or trustee must, within 20 days of
40 receipt of proof of ownership interest, provide the claimant with, at

1 a minimum, the loan balance, interest rate and interest reset dates
2 and amounts, balloon payments if any, prepayment penalties if any,
3 the basis for the default, the monthly payment amount, reinstatement
4 amounts or conditions, payoff amounts, and information on how and
5 where payments should be made. The mortgage servicers shall also
6 provide the claimant application materials and information, or a
7 description of the process, necessary to request a loan assumption
8 and modification.

9 (d) Upon receipt by the trustee or the mortgage servicer of the
10 documentation establishing claimant's ownership interest in the real
11 property, that claimant shall be deemed a "successor in interest" for
12 the purposes of this section.

13 (e) There may be more than one successor in interest to the
14 borrower's property rights. The trustee and mortgage servicer shall
15 apply the provisions of this section to each successor in interest.
16 In the case of multiple successors in interest, where one or more do
17 not wish to assume the loan as coborrowers or coapplicants, a
18 mortgage servicer may require any nonapplicant successor in interest
19 to consent in writing to the application for loan assumption.

20 (f) The existence of a successor in interest under this section
21 does not impose an affirmative duty on a mortgage servicer or alter
22 any obligation the mortgage servicer has to provide a loan
23 modification to the successor in interest. If a successor in interest
24 assumes the loan, he or she may be required to otherwise qualify for
25 available foreclosure prevention alternatives offered by the mortgage
26 servicer.

27 (g) (c), (e), and (f) of this subsection (11) do not apply to
28 association beneficiaries subject to chapter 64.32, 64.34, (~~(e)~~)
29 64.38, or 64.90 RCW; and

30 (12) Nothing in this section shall prejudice the right of the
31 mortgage servicer or beneficiary from discontinuing any foreclosure
32 action initiated under the deed of trust act in favor of other
33 allowed methods for pursuit of foreclosure of the security interest
34 or deed of trust security interest.
