15 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

16 <u>NEW SECTION.</u> Sec. 1. It is the intent of the legislature to 17 reorganize chapter 41.56 RCW into subchapters to simplify navigation 18 of the statute. The legislature does not intend to make, and no 19 provision of this act may be construed as making, a substantive 20 change to the provisions of chapter 41.56 RCW. Additionally, the subchapter headings and captions used in this act may not be
 construed as any part of the law.

24 <u>NEW SECTION.</u> Sec. 3. The following acts or parts of acts are 25 each repealed:
