## SUBSTITUTE SENATE BILL 5436

- AN ACT Relating to interfering with access to a place of religious worship; adding a new chapter to Title 9A RCW; and prescribing penalties.

- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 NEW SECTION. Sec. 1. The legislature finds that access to 6 places of worship is imperative to the free exercise of religion in 7 the state of Washington and that impaired access to places of worship raises substantial concerns regarding public safety and congestion of 8 9 public thoroughfares. Ensuring the safety and unimpeded access of 10 individuals entering and exiting places of worship is therefore a 11 compelling government interest and essential for the 12 preservation of public peace, health, and safety. Toward that end, 13 this chapter is aimed at making unlawful conduct that would interfere 14 with a person's lawful exercise of that person's religious freedom 15 under the state Constitution and United States Constitution. 16 legislature further finds that the protection of such persons from 17 accomplished without interference can be infringing 18 constitutionally protected speech or activity and affirms that its 19 intent is to not seek to favor one viewpoint over another or to limit 20 speech regarding any specific topic.

- NEW SECTION. Sec. 2. The definitions in this section apply throughout this chapter unless the context clearly requires otherwise.
  - (1) "Aggrieved person" means any of the following:

- (a) A person, physically present at the premises of a place of worship when the prohibited actions occur, whose access to the premises is or is about to be obstructed or impeded;
- (b) A person, physically present at the premises of a place of worship when the prohibited actions occur, whose exercise of their freedom of religion is or is about to be disrupted;
- 11 (c) The religious organization or its employees or agents who 12 control or maintain the place of worship where the prohibited actions 13 occur; or
- 14 (d) The owner of the premises of the place of worship where the prohibited actions occur.
  - (2) "Harass" has the same meaning as RCW 9A.46.020.
- 17 (3) "Interfere with" means to stop or to restrict a person's 18 freedom of movement.
- 19 (4) "Law enforcement officer" has the meaning given that term in 20 RCW 9A.76.020.
- 21 (5) "Place of worship" means a location wherein persons regularly 22 assemble for religious worship and which is maintained or controlled 23 by a religious organization.
  - (6) "Premises of a place of worship" means any building that is used as a place of worship and is maintained or controlled by a religious organization.
- 27 (7) "Prohibited actions" mean any conduct referenced in section 3 28 of this act.
  - (8) "Religious organizations" include, but are not limited to, churches, mosques, synagogues, gurudwara, temples, nondenominational ministries, interdenominational and ecumenical organizations, mission organizations, faith-based social agencies, and other entities whose principal purpose is the study, practice, or advancement of religion.
- 34 (9) "Religious service" means a gathering of people organized by 35 a religious organization for the purpose of worship, religious 36 teaching, or other religious activities.
- NEW SECTION. Sec. 3. It is unlawful for a person except as otherwise protected by state or federal law, alone or in concert with others, to willfully or recklessly interfere with access to or from a

place of worship immediately prior to, during, or immediately after religious services or willfully or recklessly disrupt the normal functioning of the religious services of a place of worship by:

- (1) Physically obstructing or impeding the free passage of a person seeking to enter or depart from a place of worship or from the common areas of the real property upon which the place of worship is located;
- (2) Trespassing on the place of worship or the common areas of the real property upon which the facility is located;
- (3) Telephoning the place of worship repeatedly or causing electronic communications to be sent to the place of worship repeatedly, or knowingly permitting any telephone or electronic communication device under his or her control to be used for such purpose; or
- (4) Threatening to inflict injury on the owners, agents, attendees, employees, or property of the place of worship or knowingly permitting any telephone or electronic communication devices under his or her control to be used for such purpose.
  - (5) A violation of this section is a gross misdemeanor.
- NEW SECTION. Sec. 4. (1) An aggrieved person may seek civil damages from those who committed the actions prohibited by section 3 of this act and those acting in concert with them. A plaintiff in an action brought under this chapter shall not recover more than the plaintiff's actual damages and additional sums authorized in section 5 of this act. Once a plaintiff recovers the plaintiff's actual damages and any additional sums authorized under this chapter, additional damages shall not be recovered. A person does not have to be criminally convicted of violating section 3 of this act to be held civilly liable under this section. It is not necessary to prove actual damages to recover the additional sums authorized under section 5 of this act, costs, and attorneys' fees. The prevailing party is entitled to recover costs and attorneys' fees.
  - (2) The superior courts of this state shall have authority to grant temporary, preliminary, and permanent injunctive relief to enjoin violations of this chapter.
  - (3) In appropriate circumstances, any superior court having personal jurisdiction over one or more defendants may issue injunctive relief that shall have binding effect on the original

- 1 defendants and persons acting in concert with the original 2 defendants, in any county in the state.
- 3 (4) Due to the nature of the harm involved, injunctive relief may 4 be issued without bond in the discretion of the court, 5 notwithstanding any other requirement imposed by statute.
- 6 (5) The state and its political subdivisions shall cooperate in 7 the enforcement of court injunctions that seek to protect against 8 acts prohibited by this chapter.
- 9 <u>NEW SECTION.</u> **Sec. 5.** In a civil action brought under this chapter, an individual plaintiff aggrieved by the actions prohibited by section 3 of this act may be entitled to recover up to \$500 for each day that the prohibited actions occurred, or up to \$5,000 for each day that the actions occurred if the plaintiff aggrieved by the actions prohibited under section 3 of this act is a place of worship.
- NEW SECTION. Sec. 6. Nothing in section 3 of this act shall prohibit either lawful picketing or other publicity for the purpose of providing the public with information.
- NEW SECTION. Sec. 7. Nothing in this chapter shall be construed to limit the right to seek other available criminal or civil remedies. The remedies provided in this chapter are cumulative, not exclusive.
- NEW SECTION. Sec. 8. A court having jurisdiction over a criminal or civil proceeding under this chapter shall take all steps reasonably necessary to safeguard the individual privacy and prevent harassment of the agents or employees of a religious organization who are a party or witness in a proceeding, including granting protective orders and orders in limine.
- NEW SECTION. Sec. 9. Sections 1 through 8 of this act constitute a new chapter in Title 9A RCW.
- 30 <u>NEW SECTION.</u> **Sec. 10.** If any provision of this act or its application to any person or circumstance is held invalid, the
