1 AN ACT Relating to rights of individuals to bear arms; reenacting
2 and amending RCW 9.41.010; creating a new section; repealing RCW
3 9.41.390, 9.41.395, and 7.48.330; and repealing 2023 c 162 s 1 and
4 2023 c 163 s 1 (uncodified).

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 NEW SECTION. **Sec. 1.** The legislature finds that both the Second
7 Amendment to the United States Constitution, and Article 1, section
8 24 of the Washington state Constitution, protect the right of
9 individuals to bear arms in defense of themselves and shall not be
10 impaired. As such, any law adopted by the state that creates firearms
11 industry members' liability, or that bans a particular type of
12 firearm is deemed unconstitutional. Such laws are held ineffective,
13 void, and unenforceable.

14 **Sec. 2.** RCW 9.41.010 and 2024 c 289 s 1 and 2024 c 62 s 32 are
15 each reenacted and amended to read as follows:

16 Unless the context clearly requires otherwise, the definitions in
17 this section apply throughout this chapter.

18 (1) "Antique firearm" means a firearm or replica of a firearm not
19 designed or redesigned for using rim fire or conventional center fire
20 ignition with fixed ammunition and manufactured in or before 1898,

1 including any matchlock, flintlock, percussion cap, or similar type
2 of ignition system and also any firearm using fixed ammunition
3 manufactured in or before 1898, for which ammunition is no longer
4 manufactured in the United States and is not readily available in the
5 ordinary channels of commercial trade.

~~(iii) A conversion kit, part, or combination of parts, from which an assault weapon can be assembled or from which a firearm can be converted into an assault weapon if those parts are in the possession or under the control of the same person; or~~

~~(iv) A semiautomatic, center fire rifle that has the capacity to accept a detachable magazine and has one or more of the following:~~

~~(A) A grip that is independent or detached from the stock that protrudes conspicuously beneath the action of the weapon. The addition of a fin attaching the grip to the stock does not exempt the grip if it otherwise resembles the grip found on a pistol;~~

~~(B) Thumbhole stock;~~

~~(C) Folding or telescoping stock;~~

~~(D) Forward pistol, vertical, angled, or other grip designed for use by the nonfiring hand to improve control;~~

~~(E) Flash suppressor, flash guard, flash eliminator, flash hider, sound suppressor, silencer, or any item designed to reduce the visual or audio signature of the firearm;~~

~~(F) Muzzle brake, recoil compensator, or any item designed to be affixed to the barrel to reduce recoil or muzzle rise;~~

~~(I) A shroud that encircles either all or part of the barrel designed to shield the bearer's hand from heat, except a solid forearm of a stock that covers only the bottom of the barrel;~~

~~(v) A semiautomatic, center fire rifle that has a fixed magazine with the capacity to accept more than 10 rounds;~~

~~(vi) A semiautomatic pistol that has the capacity to accept a detachable magazine and has one or more of the following:~~

~~(A) A threaded barrel, capable of accepting a flash suppressor, forward handgrip, or silencer;~~

22 ~~(c) "Assault weapon" does not include antique firearms, any~~

25 ~~(3)) "Assemble" means to fit together component parts.~~
26 ~~((4))~~ (3) "Barrel length" means the distance from the bolt face
27 of a closed action down the length of the axis of the bore to the
28 crown of the muzzle, or in the case of a barrel with attachments to
29 the end of any legal device permanently attached to the end of the
30 muzzle.
31 ~~((5))~~ (4) "Bump-fire stock" means a butt stock designed to be
32 attached to a semiautomatic firearm with the effect of increasing the
33 rate of fire achievable with the semiautomatic firearm to that of a
34 fully automatic firearm by using the energy from the recoil of the
35 firearm to generate reciprocating action that facilitates repeated
36 activation of the trigger.
37 ~~((6))~~ (5) "Conviction" or "convicted" means, whether in an
38 adult court or adjudicated in a juvenile court, that a plea of guilty
39 has been accepted or a verdict of guilty has been filed, or a finding
40 of guilt has been entered, notwithstanding the pendency of any future

1 proceedings including, but not limited to, sentencing or disposition,
2 posttrial or post-fact-finding motions, and appeals. "Conviction"
3 includes a dismissal entered after a period of probation, suspension,
4 or deferral of sentence, and also includes equivalent dispositions by
5 courts in jurisdictions other than Washington state.

7 (a) Any of the following felonies, as now existing or hereafter
8 amended: Any felony defined under any law as a class A felony or an
9 attempt to commit a class A felony, criminal solicitation of or
10 criminal conspiracy to commit a class A felony, manslaughter in the
11 first degree, manslaughter in the second degree, indecent liberties
12 if committed by forcible compulsion, kidnapping in the second degree,
13 arson in the second degree, assault in the second degree, assault of
14 a child in the second degree, extortion in the first degree, burglary
15 in the second degree, residential burglary, and robbery in the second
16 degree;

17 (b) Any conviction for a felony offense in effect at any time
18 prior to June 6, 1996, which is comparable to a felony classified as
19 a crime of violence in (a) of this subsection; and

20 (c) Any federal or out-of-state conviction for an offense
21 comparable to a felony classified as a crime of violence under (a) or
22 (b) of this subsection.

24 27 C.F.R. Sec. 478.11.

25 ~~((9))~~ (8) "Dealer" means a person engaged in the business of
26 selling firearms at wholesale or retail who has, or is required to
27 have, a federal firearms license under 18 U.S.C. Sec. 923(a). A
28 person who does not have, and is not required to have, a federal
29 firearms license under 18 U.S.C. Sec. 923(a), is not a dealer if that
30 person makes only occasional sales, exchanges, or purchases of
31 firearms for the enhancement of a personal collection or for a hobby,
32 or sells all or part of his or her personal collection of firearms.

33 ~~((10) "Detachable magazine" means an ammunition feeding device
34 that can be loaded or unloaded while detached from a firearm and
35 readily inserted into a firearm.~~

36 ~~(11))~~ (9) "Distribute" means to give out, provide, make
37 available, or deliver a firearm or large capacity magazine to any
38 person in this state, with or without consideration, whether the
39 distributor is in-state or out-of-state. "Distribute" includes, but
40 is not limited to, filling orders placed in this state, online or

1 otherwise. "Distribute" also includes causing a firearm or large
2 capacity magazine to be delivered in this state.

3 ~~((12))~~ (10) "Domestic violence" has the same meaning as
4 provided in RCW 10.99.020.

5 ~~((13))~~ (11) "Family or household member" has the same meaning
6 as in RCW 7.105.010.

7 ~~((14))~~ (12) "Federal firearms dealer" means a licensed dealer
8 as defined in 18 U.S.C. Sec. 921(a)(11).

9 ~~((15))~~ (13) "Federal firearms importer" means a licensed
10 importer as defined in 18 U.S.C. Sec. 921(a)(9).

11 ~~((16))~~ (14) "Federal firearms manufacturer" means a licensed
12 manufacturer as defined in 18 U.S.C. Sec. 921(a)(10).

13 ~~((17))~~ (15) "Felony" means any felony offense under the laws of
14 this state or any federal or out-of-state offense comparable to a
15 felony offense under the laws of this state.

16 ~~((18))~~ (16) "Felony firearm offender" means a person who has
17 previously been convicted or found not guilty by reason of insanity
18 in this state of any felony firearm offense. A person is not a felony
19 firearm offender under this chapter if any and all qualifying
20 offenses have been the subject of an expungement, pardon, annulment,
21 certificate, or rehabilitation, or other equivalent procedure based
22 on a finding of the rehabilitation of the person convicted or a
23 pardon, annulment, or other equivalent procedure based on a finding
24 of innocence.

25 ~~((19))~~ (17) "Felony firearm offense" means:

26 (a) Any felony offense that is a violation of this chapter;

27 (b) A violation of RCW 9A.36.045;

28 (c) A violation of RCW 9A.56.300;

29 (d) A violation of RCW 9A.56.310;

30 (e) Any felony offense if the offender was armed with a firearm
31 in the commission of the offense.

32 ~~((20))~~ (18) "Firearm" means a weapon or device from which a
33 projectile or projectiles may be fired by an explosive such as
34 gunpowder. For the purposes of RCW 9.41.040, "firearm" also includes
35 frames and receivers. "Firearm" does not include a flare gun or other
36 pyrotechnic visual distress signaling device, or a powder-actuated
37 tool or other device designed solely to be used for construction
38 purposes.

39 ~~((21))~~ (19)(a) "Frame or receiver" means a part of a firearm
40 that, when the complete firearm is assembled, is visible from the

1 exterior and provides housing or a structure designed to hold or
2 integrate one or more fire control components, even if pins or other
3 attachments are required to connect the fire control components. Any
4 such part identified with a serial number shall be presumed, absent
5 an official determination by the bureau of alcohol, tobacco,
6 firearms, and explosives or other reliable evidence to the contrary,
7 to be a frame or receiver.

8 (b) For purposes of this subsection, "fire control component"
9 means a component necessary for the firearm to initiate, complete, or
10 continue the firing sequence, including any of the following: Hammer,
11 bolt, bolt carrier, breechblock, cylinder, trigger mechanism, firing
12 pin, striker, or slide rails.

13 ~~((22))~~ (20) "Gun" has the same meaning as firearm.

14 ~~((23))~~ (21) "Import" means to move, transport, or receive an
15 item from a place outside the territorial limits of the state of
16 Washington to a place inside the territorial limits of the state of
17 Washington. "Import" does not mean situations where an individual
18 possesses a large capacity magazine (~~(or assault weapon)~~) when
19 departing from, and returning to, Washington state, so long as the
20 individual is returning to Washington in possession of the same large
21 capacity magazine (~~(or assault weapon)~~) the individual transported
22 out of state.

23 ~~((24))~~ (22) "Intimate partner" has the same meaning as provided
24 in RCW 7.105.010.

25 ~~((25))~~ (23) "Large capacity magazine" means an ammunition
26 feeding device with the capacity to accept more than 10 rounds of
27 ammunition, or any conversion kit, part, or combination of parts,
28 from which such a device can be assembled if those parts are in
29 possession of or under the control of the same person, but shall not
30 be construed to include any of the following:

31 (a) An ammunition feeding device that has been permanently
32 altered so that it cannot accommodate more than 10 rounds of
33 ammunition;

34 (b) A 22 caliber tube ammunition feeding device; or

35 (c) A tubular magazine that is contained in a lever-action
36 firearm.

37 ~~((26))~~ (24) "Law enforcement officer" includes a general
38 authority Washington peace officer as defined in RCW 10.93.020, or a
39 specially commissioned Washington peace officer as defined in RCW
40 10.93.020. "Law enforcement officer" also includes a limited

1 authority Washington peace officer as defined in RCW 10.93.020 if
2 such officer is duly authorized by his or her employer to carry a
3 concealed pistol.

4 ~~((27))~~ (25) "Lawful permanent resident" has the same meaning
5 afforded a person "lawfully admitted for permanent residence" in 8
6 U.S.C. Sec. 1101(a)(20).

7 ~~((28))~~ (26) "Licensed collector" means a person who is
8 federally licensed under 18 U.S.C. Sec. 923(b).

9 ~~((29))~~ (27) "Licensed dealer" means a person who is federally
10 licensed under 18 U.S.C. Sec. 923(a).

11 ~~((30))~~ (28) "Loaded" means:

12 (a) There is a cartridge in the chamber of the firearm;

13 (b) Cartridges are in a clip that is locked in place in the
14 firearm;

15 (c) There is a cartridge in the cylinder of the firearm, if the
16 firearm is a revolver;

17 (d) There is a cartridge in the tube or magazine that is inserted
18 in the action; or

19 (e) There is a ball in the barrel and the firearm is capped or
20 primed if the firearm is a muzzle loader.

22 gun, mechanical rifle, submachine gun, or any other mechanism or
23 instrument not requiring that the trigger be pressed for each shot
24 and having a reservoir clip, disc, drum, belt, or other separable
25 mechanical device for storing, carrying, or supplying ammunition
26 which can be loaded into the firearm, mechanism, or instrument, and
27 fired therefrom at the rate of five or more shots per second.

28 ~~((32))~~ (30) "Manufacture" means, with respect to a firearm or
29 large capacity magazine, the fabrication, making, formation,
30 production, or construction of a firearm or large capacity magazine,
31 by manual labor or by machinery.

32 ~~((33))~~ (31) "Mental health professional" means a psychiatrist,
33 psychologist, or physician assistant working with a psychiatrist who
34 is acting as a participating physician as defined in RCW 18.71A.010,
35 psychiatric advanced registered nurse practitioner, psychiatric
36 nurse, social worker, mental health counselor, marriage and family
37 therapist, or such other mental health professionals as may be
38 defined in statute or by rules adopted by the department of health
39 pursuant to the provisions of chapter 71.05 RCW.

1 ~~((34))~~ (32) "Nonimmigrant alien" means a person defined as such
2 in 8 U.S.C. Sec. 1101(a) (15).

3 ~~((35))~~ (33) "Person" means any individual, corporation,
4 company, association, firm, partnership, club, organization, society,
5 joint stock company, or other legal entity.

6 ~~((36))~~ (34) "Pistol" means any firearm with a barrel less than
7 16 inches in length, or is designed to be held and fired by the use
8 of a single hand.

9 ~~((37))~~ (35) "Rifle" means a weapon designed or redesigned, made
10 or remade, and intended to be fired from the shoulder and designed or
11 redesigned, made or remade, and intended to use the energy of the
12 explosive in a fixed metallic cartridge to fire only a single
13 projectile through a rifled bore for each single pull of the trigger.

14 ~~((38))~~ (36) "Sale" and "sell" mean the actual approval of the
15 delivery of a firearm in consideration of payment or promise of
16 payment.

17 ~~((39))~~ (37) "Secure gun storage" means:

18 (a) A locked box, gun safe, or other secure locked storage space
19 that is designed to prevent unauthorized use or discharge of a
20 firearm; and

21 (b) The act of keeping an unloaded firearm stored by such means.

22 ~~((40) "Semiautomatic" means any firearm which utilizes a portion
23 of the energy of a firing cartridge to extract the fired cartridge
24 case and chamber the next round, and which requires a separate pull
25 of the trigger to fire each cartridge.~~

26 ~~(41))~~ (38) (a) "Semiautomatic assault rifle" means any rifle
27 which utilizes a portion of the energy of a firing cartridge to
28 extract the fired cartridge case and chamber the next round, and
29 which requires a separate pull of the trigger to fire each cartridge.

30 (b) "Semiautomatic assault rifle" does not include antique
31 firearms, any firearm that has been made permanently inoperable, or
32 any firearm that is manually operated by bolt, pump, lever, or slide
33 action.

34 ~~((42))~~ (39) "Serious offense" means any of the following
35 felonies or a felony attempt to commit any of the following felonies,
36 as now existing or hereafter amended:

37 (a) Any crime of violence;

38 (b) Any felony violation of the uniform controlled substances
39 act, chapter 69.50 RCW, that is classified as a class B felony or
40 that has a maximum term of imprisonment of at least 10 years;

1 (c) Child molestation in the second degree;
2 (d) Incest when committed against a child under age 14;
3 (e) Indecent liberties;
4 (f) Leading organized crime;
5 (g) Promoting prostitution in the first degree;
6 (h) Rape in the third degree;
7 (i) Drive-by shooting;
8 (j) Sexual exploitation;
9 (k) Vehicular assault, when caused by the operation or driving of
10 a vehicle by a person while under the influence of intoxicating
11 liquor or any drug or by the operation or driving of a vehicle in a
12 reckless manner;

22 1996, that is comparable to a serious offense, or any federal or out-
23 of-state conviction for an offense that under the laws of this state

26 (q) Any felony charged under RCW 46.61.502(6) or 46.61.504(6).
27 (~~(43)~~) (40) "Sex offense" has the same meaning as provided in
28 RCW 9.94A.030.
29 (~~(44)~~) (41) "Short-barreled rifle" means a rifle having one or
30 more barrels less than 16 inches in length and any weapon made from a
31 rifle by any means of modification if such modified weapon has an
32 overall length of less than 26 inches.
33 (~~(45)~~) (42) "Short-barreled shotgun" means a shotgun having one
34 or more barrels less than 18 inches in length and any weapon made
35 from a shotgun by any means of modification if such modified weapon
36 has an overall length of less than 26 inches.
37 (~~(46)~~) (43) "Shotgun" means a weapon with one or more barrels,
38 designed or redesigned, made or remade, and intended to be fired from
39 the shoulder and designed or redesigned, made or remade, and intended
40 to use the energy of the explosive in a fixed shotgun shell to fire

1 through a smooth bore either a number of ball shot or a single
2 projectile for each single pull of the trigger.

3 ~~((47))~~ (44) "Substance use disorder professional" means a
4 person certified under chapter 18.205 RCW.

5 ~~((48))~~ (45) "Transfer" means the intended delivery of a firearm
6 to another person without consideration of payment or promise of
7 payment including, but not limited to, gifts and loans. "Transfer"
8 does not include the delivery of a firearm owned or leased by an
9 entity licensed or qualified to do business in the state of
10 Washington to, or return of such a firearm by, any of that entity's
11 employees or agents, defined to include volunteers participating in
12 an honor guard, for lawful purposes in the ordinary course of
13 business.

14 ~~((49))~~ (46) "Undetectable firearm" means any firearm that is
15 not as detectable as 3.7 ounces of 17-4 PH stainless steel by walk-
16 through metal detectors or magnetometers commonly used at airports or
17 any firearm where the barrel, the slide or cylinder, or the frame or
18 receiver of the firearm would not generate an image that accurately
19 depicts the shape of the part when examined by the types of X-ray
20 machines commonly used at airports.

21 ~~((50))~~ (47) (a) "Unfinished frame or receiver" means a frame or
22 receiver that is partially complete, disassembled, or inoperable,
23 that: (i) Has reached a stage in manufacture where it may readily be
24 completed, assembled, converted, or restored to a functional state;
25 or (ii) is marketed or sold to the public to become or be used as the
26 frame or receiver of a functional firearm once finished or completed,
27 including without limitation products marketed or sold to the public
28 as an 80 percent frame or receiver or unfinished frame or receiver.

29 (b) For purposes of this subsection:

30 (i) "Readily" means a process that is fairly or reasonably
31 efficient, quick, and easy, but not necessarily the most efficient,
32 speedy, or easy process. Factors relevant in making this
33 determination, with no single one controlling, include the following:
34 (A) Time, i.e., how long it takes to finish the process; (B) ease,
35 i.e., how difficult it is to do so; (C) expertise, i.e., what
36 knowledge and skills are required; (D) equipment, i.e., what tools
37 are required; (E) availability, i.e., whether additional parts are
38 required, and how easily they can be obtained; (F) expense, i.e., how
39 much it costs; (G) scope, i.e., the extent to which the subject of
40 the process must be changed to finish it; and (H) feasibility, i.e.,

1 whether the process would damage or destroy the subject of the
2 process, or cause it to malfunction.

3 (ii) "Partially complete," as it modifies frame or receiver,
4 means a forging, casting, printing, extrusion, machined body, or
5 similar article that has reached a stage in manufacture where it is
6 clearly identifiable as an unfinished component part of a firearm.

7 ~~((51))~~ (48) "Unlicensed person" means any person who is not a
8 licensed dealer under this chapter.

9 ~~((52))~~ (49) "Untraceable firearm" means any firearm
10 manufactured after July 1, 2019, that is not an antique firearm and
11 that cannot be traced by law enforcement by means of a serial number
12 affixed to the firearm by a federal firearms manufacturer, federal
13 firearms importer, or federal firearms dealer in compliance with all
14 federal laws and regulations.

15 ~~((53))~~ (50) "Washington state patrol firearms background check
16 program" means the division within the state patrol that conducts
17 background checks for all firearm transfers and the disposition of
18 firearms.

19 NEW SECTION. **Sec. 3.** The following acts or parts of acts are
