## SUBSTITUTE SENATE BILL 5570

State of Washington 69th Legislature 2025 Regular Session

By Senate Ways & Means (originally sponsored by Senators Kauffman, Wellman, Hasegawa, Nobles, Riccelli, Stanford, Valdez, and C. Wilson)

READ FIRST TIME 02/28/25.

AN ACT Relating to supporting public school instruction in tribal sovereignty and federally recognized Indian tribes; amending RCW 28A.300.105 and 28A.320.170; adding a new section to chapter 28A.305 RCW; creating a new section; and providing expiration dates.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 Sec. 1. RCW 28A.300.105 and 2011 c 270 s 2 are each amended to 7 read as follows:

8 (1) To the extent funds are available, an Indian education 9 division, to be known as the office of Native education, is created 10 within the office of the superintendent of public instruction. The 11 superintendent shall appoint an individual to be responsible for the 12 office of Native education.

13 (2) To the extent state funds are available, with additional 14 support of federal and local funds where authorized by law, the 15 office of Native education shall:

(a) Provide assistance to school districts in meeting the
 educational needs of American Indian and Alaska Native students;

(b) Facilitate the development and implementation of curricula
and instructional materials in native languages, culture and history,
and the concept of tribal sovereignty pursuant to RCW 28A.320.170;

1 (c) Provide assistance to districts in the acquisition of funding 2 to develop curricula and instructional materials in conjunction with 3 native language practitioners and tribal elders;

4 (d) Coordinate technical assistance for public schools that serve
5 American Indian and Alaska Native students;

6 (e) Seek funds to develop, in conjunction with the Washington 7 state native American education advisory committee, and implement the 8 following support services for the purposes of both increasing the 9 number of American Indian and Alaska Native teachers and principals 10 and providing continued professional development for educational 11 assistants, teachers, and principals serving American Indian and 12 Alaska Native students:

13 (i) Recruitment and retention;

14 (ii) Academic transition programs;

15 (iii) Academic financial support;

16 (iv) Teacher preparation;

17 (v) Teacher induction; and

18 (vi) Professional development;

19 (f) Facilitate the inclusion of native language programs in 20 school districts' curricula;

(g) Work with all relevant agencies and committees to highlight he need for accurate, useful data that is appropriately disaggregated to provide a more accurate picture regarding American Indian and Alaska Native students; and

25 (h) Report to the governor, the legislature, and the governor's office of Indian affairs on an annual basis((, beginning in December 26  $\frac{2012_{I}}{100}$ ) regarding the state of Indian education and 27 the implementation of all state laws regarding Indian education, 28 29 specifically noting system successes and accomplishments, deficiencies, and needs. The reports issued in 2026 through 2029, 30 must also include: Information about consultations and collaborations 31 32 between school districts and federally recognized Indian tribes under RCW 28A.320.170, including tribal perspectives on the implementation 33 34 of the required curriculum; and recommendations for promoting tribal consultation efforts with school districts. 35

36 Sec. 2. RCW 28A.320.170 and 2024 c 200 s 2 are each amended to 37 read as follows:

38 (1)(a) Beginning July 24, 2015, when a school district board of 39 directors reviews or adopts its social studies curriculum, it shall

incorporate curricula about the history, culture, and government of the nearest federally recognized Indian tribe or tribes, so that students learn about the unique heritage and experience of their closest neighbors. <u>School districts must incorporate the curricular</u> <u>requirements of this section no later than September 1, 2026.</u>

6 (b) School districts shall meet the requirements of this section 7 by using the John McCoy (lulilaš) since time immemorial curriculum 8 developed and made available free of charge by the office of the 9 superintendent of public instruction and may modify that curriculum 10 in order to incorporate elements that have a regionally specific 11 focus or to incorporate the curriculum into existing curricular 12 materials.

(2) As ((they)) school districts conduct regularly scheduled 13 reviews and revisions of their social studies and history curricula, 14 15 ((school districts)) they shall consult and collaborate with any federally recognized Indian tribe within their district, and with 16 17 neighboring Indian tribes, including federally recognized Indian tribes whose traditional lands and territories included parts of 18 Washington, but that now reside in Oregon, Idaho, and British 19 <u>Columbia</u>, to incorporate expanded and improved curricular materials 20 21 about Indian tribes, and to create programs of classroom and 22 community cultural exchanges.

(3) (a) School districts shall collaborate with the office of 23 24 Native education created in RCW 28A.300.105 within the office of the superintendent of public instruction and the office of the 25 superintendent of public instruction on curricular areas regarding 26 27 tribal government and history that are statewide in nature, such as 28 the concept of tribal sovereignty and the history of federal policy 29 towards federally recognized Indian tribes. ((The program of Indian 30 education within the office of the superintendent of public 31 instruction shall help local school districts identify federally 32 recognized Indian tribes whose reservations are in whole or in part within the boundaries of the district and/or those that are nearest 33 to the school district)) 34

35 (b) The office of the superintendent of public instruction, 36 through the office of Native education, shall:

37 (i) Assist local school districts to identify federally 38 recognized Indian tribes whose reservations are in whole or in part 39 within the boundaries of the district and those that are nearest to 40 the school district, including federally recognized Indian tribes 1 whose traditional lands and territories included parts of Washington,

2 but that now reside in Oregon, Idaho, and British Columbia; and

3 <u>(ii) Collaborate with tribes that may have unique consultation</u> 4 <u>challenges under this section, such as consulting with a large number</u> 5 <u>of school districts or with school districts that have large student</u> 6 <u>enrollments</u>.

7 <u>NEW SECTION.</u> Sec. 3. A new section is added to chapter 28A.305 8 RCW to read as follows:

9 Beginning in the 2026-27 school year, the state board of education, in coordination with the office of Native education 10 11 created in RCW 28A.300.105 within the office of the superintendent of public instruction, shall implement a system of annual monitoring and 12 evaluations of school district compliance with RCW 28A.320.170. The 13 monitoring and evaluations, which may be conducted concurrently with 14 15 other oversight and monitoring conducted by the state board of 16 education, must include collected information for each school district about: 17

18 19 (1) Collaborations with federally recognized Indian tribes;

(2) The grade levels in which the curriculum is taught;

(3) The courses for which credit may be awarded and the number of students enrolled in, and having received credit for, those courses during the preceding school year;

(4) Summaries of the curriculum implementation process; and

24 (5) The availability and implementation of applicable 25 professional development.

(6) Beginning in 2027 and concluding in 2029, the state board of education, in accordance with RCW 43.01.036, shall annually report to the education committees of the legislature that summarizes school district compliance with RCW 28A.320.170. The reports required by this subsection may be incorporated within other oversight and monitoring reports produced by the state board of education.

(7) This section expires September 1, 2029.

33 <u>NEW SECTION.</u> Sec. 4. (1) By September 1, 2026, the office of 34 the superintendent of public instruction, in conjunction with the office of Native education created in RCW 28A.300.105 within the 35 office of the superintendent of public instruction, shall report to 36 37 the education committees of legislature concerning the 38 recommendations for:

1 (a) Compensating federally recognized Indian tribes, including 2 federally recognized Indian tribes whose traditional lands and 3 territories included parts of Washington, but that now reside in 4 Oregon, Idaho, and British Columbia, who provide expertise, 5 consultation, or collaboration pursuant to RCW 28A.320.170;

6 (b) Retroactively compensating federally recognized Indian 7 tribes, including federally recognized Indian tribes whose 8 traditional lands and territories included parts of Washington, but 9 that now reside in Oregon, Idaho, and British Columbia, who have 10 previously provided expertise, consultation, or collaboration 11 pursuant to RCW 28A.320.170; and

12 (c) Evaluation and accountability metrics for the implementation 13 of the curriculum and government-to-government consultation described 14 in RCW 28A.320.170.

15 (2) This section expires August 1, 2027.
