1 AN ACT Relating to establishing African diaspora heritage week; 2 amending RCW 1.16.050; and creating a new section.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

<u>NEW SECTION.</u> **Sec. 1.** The legislature intends to fully recognize and celebrate the rich legacy of the people of African descent, their independence days, holidays, cultural food, festivals, and to raise awareness of their diverse community needs. Further, the legislature intends to provide cultural recognition and celebration acknowledge and honor the history and cultural heritage of all the people of African descent, whose communities continuously demonstrate this legacy through traditional weddings, ethnic associations, religious institutions, traditional customs, rites of passage, and sporting events. Attendance at these events is not only an educational experience for all Washingtonians, but also serves as a unifying and therapeutic connection for the entire diaspora, facilitating opportunities for the elderly to interact with community youth to keep their minds active and to stay socially engaged.

Therefore, the last full calendar week in July of each year shall be known as African diaspora heritage week. This is designated as a time for people of this state to commemorate the contributions of

- 27 (2) Employees of the state and its political subdivisions, except employees of school districts and except those nonclassified 28 employees of institutions of higher education who hold appointments 29 30 or are employed under contracts to perform services for periods of less than twelve consecutive months, are entitled to one paid holiday 31 per calendar year in addition to those specified in this section. 32 Each employee of the state or its political subdivisions may select 33 the day on which the employee desires to take the additional holiday 34 35 provided for in this section after consultation with the employer pursuant to guidelines to be promulgated by rule of the appropriate 36 personnel authority, or in the case of local government by ordinance 37 38 or resolution of the legislative authority.

- 1 (3) Employees of the state and its political subdivisions, including employees of school districts and those nonclassified 2 employees of institutions of higher education who hold appointments 3 or are employed under contracts to perform services for periods of 4 less than twelve consecutive months, are entitled to two unpaid 5 6 holidays per calendar year for a reason of faith or conscience or an organized activity conducted under the auspices of a religious 7 denomination, church, or religious organization. This includes 8 employees of public institutions of higher education, including 9 community colleges, technical colleges, and workforce training 10 11 programs. The employee may select the days on which the employee 12 desires to take the two unpaid holidays after consultation with the employer pursuant to guidelines to be promulgated by rule of the 13 appropriate personnel authority, or in the case of local government 14 by ordinance or resolution of the legislative authority. If an 15 16 employee prefers to take the two unpaid holidays on specific days for 17 a reason of faith or conscience, or an organized activity conducted under the auspices of a religious denomination, church, or religious 18 organization, the employer must allow the employee to do so unless 19 the employee's absence would impose an undue hardship on the employer 20 21 or the employee is necessary to maintain public safety. Undue 22 hardship shall have the meaning established in rule by the office of 23 financial management under RCW 43.41.109.
 - (4) If any of the state legal holidays specified in this section are also federal legal holidays but observed on different dates, only the state legal holidays are recognized as a paid legal holiday for employees of the state and its political subdivisions. However, for port districts and the law enforcement and public transit employees of municipal corporations, either the federal or the state legal holiday is recognized as a paid legal holiday, but in no case may both holidays be recognized as a paid legal holiday for employees.
