1 AN ACT Relating to funding public schools, health care, social
2 services, and other programs and services to benefit Washingtonians
3 by modifying the application and administration of certain excise
4 taxes; amending RCW 82.04.192, 82.26.010, and 82.32.045; reenacting
5 and amending RCW 82.04.050 and 82.32.050; creating new sections; and
6 providing effective dates.

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

8 NEW SECTION. **Sec. 1.** The legislature finds that, through the
9 state's general fund, the state funds public schools, health care,
10 and social services that help Washingtonians to succeed and thrive.
11 These revenues help the state meet its paramount duty to amply
12 provide every child in the state with an education, including
13 children who qualify for special education services, creating the
14 opportunity for each child to succeed in school and achieve success
15 in life. Revenues generated by this act will support health care and
16 other programs that protect the safety and well-being of the public,
17 including behavioral health services for those living with mental
18 illness or substance use disorder, as well as supervision of
19 individuals who have committed crimes. These revenues will also fund
20 social services that provide critical, basic needs assistance for our

1 state's most vulnerable residents, including support for those with
2 developmental disabilities and long-term care for the elderly.

3 Furthermore, the legislature finds that the state's tax code must
4 be periodically reviewed and updated to ensure that tax policy
5 reflects our modern economy. The legislature recognizes that our
6 state and nation have moved away from a predominantly goods-based
7 economy towards a more service-based economy. As a result,
8 Washington's tax code, which is heavily reliant on sales taxes,
9 continues to reach a narrowing share of economic activity subject to
10 the retail sales tax. Similar to the marketplace fairness act of
11 2017, which extended retail sales tax to remote retailers with no
12 physical presence in the state to ensure the tax code reflected the
13 growing shift of retail sales toward online sales and away from
14 brick-and-mortar stores located in the state, so too must this
15 legislature consider extending the retail sales tax to computer-
16 related services, as well as remove exemptions to the retail sales
17 tax for digital automated services which have not been updated since
18 2009, and other services to which it is more appropriate to apply
19 retail sales tax in the state's current economy. The legislature
20 further recognizes that taxes on tobacco products, which have largely
21 gone unchanged over the last several decades, do not adequately
22 capture new and emerging nicotine products. As certain new products
23 come onto the market, they are exempt from excise tax, creating an
24 unfair advantage in the market against their competitors.

25 Thus, to help meet the state's paramount duty of amply providing
26 every child in the state with an education and to support the health
27 and well-being of Washingtonians, the legislature intends to
28 modernize the sales tax and taxes on nicotine products by extending
29 retail sales tax to select services, repealing certain sales tax
30 exemptions, applying taxes on tobacco to new nicotine products, and
31 requiring certain large businesses to make a one-time prepayment of
32 state sales tax collections.

33 PART I

34 EXTENDING RETAIL SALES TAX TO SELECT SERVICES

35 **Sec. 101.** RCW 82.04.050 and 2021 c 296 s 8 and 2021 c 143 s 2
36 are each reenacted and amended to read as follows:

37 (1)(a) "Sale at retail" or "retail sale" means every sale of
38 tangible personal property (including articles produced, fabricated,

1 or imprinted) to all persons irrespective of the nature of their
2 business and including, among others, without limiting the scope
3 hereof, persons who install, repair, clean, alter, improve,
4 construct, or decorate real or personal property of or for consumers
5 other than a sale to a person who:

6 (i) Purchases for the purpose of resale as tangible personal
7 property in the regular course of business without intervening use by
8 such person, but a purchase for the purpose of resale by a regional
9 transit authority under RCW 81.112.300 is not a sale for resale; or

10 (ii) Installs, repairs, cleans, alters, imprints, improves,
11 constructs, or decorates real or personal property of or for
12 consumers, if such tangible personal property becomes an ingredient
13 or component of such real or personal property without intervening
14 use by such person; or

15 (iii) Purchases for the purpose of consuming the property
16 purchased in producing for sale as a new article of tangible personal
17 property or substance, of which such property becomes an ingredient
18 or component or is a chemical used in processing, when the primary
19 purpose of such chemical is to create a chemical reaction directly
20 through contact with an ingredient of a new article being produced
21 for sale; or

22 (iv) Purchases for the purpose of consuming the property
23 purchased in producing ferrosilicon which is subsequently used in
24 producing magnesium for sale, if the primary purpose of such property
25 is to create a chemical reaction directly through contact with an
26 ingredient of ferrosilicon; or

27 (v) Purchases for the purpose of providing the property to
28 consumers as part of competitive telephone service, as defined in RCW
29 82.04.065; or

30 (vi) Purchases for the purpose of satisfying the person's
31 obligations under an extended warranty as defined in subsection (7)
32 of this section, if such tangible personal property replaces or
33 becomes an ingredient or component of property covered by the
34 extended warranty without intervening use by such person.

35 (b) The term includes every sale of tangible personal property
36 that is used or consumed or to be used or consumed in the performance
37 of any activity defined as a "sale at retail" or "retail sale" even
38 though such property is resold or used as provided in (a)(i) through
39 (vi) of this subsection following such use.

1 (c) The term also means every sale of tangible personal property
2 to persons engaged in any business that is taxable under RCW
3 82.04.280(1) (a), (b), and (g), 82.04.290, and 82.04.2908.

4 (2) The term "sale at retail" or "retail sale" includes the sale
5 of or charge made for tangible personal property consumed and/or for
6 labor and services rendered in respect to the following:

7 (a) The installing, repairing, cleaning, altering, imprinting, or
8 improving of tangible personal property of or for consumers,
9 including charges made for the mere use of facilities in respect
10 thereto, but excluding charges made for the use of self-service
11 laundry facilities, and also excluding sales of laundry service to
12 nonprofit health care facilities, and excluding services rendered in
13 respect to live animals, birds and insects;

14 (b) The constructing, repairing, decorating, or improving of new
15 or existing buildings or other structures under, upon, or above real
16 property of or for consumers, including the installing or attaching
17 of any article of tangible personal property therein or thereto,
18 whether or not such personal property becomes a part of the realty by
19 virtue of installation, and also includes the sale of services or
20 charges made for the clearing of land and the moving of earth
21 excepting the mere leveling of land used in commercial farming or
22 agriculture;

23 (c) The constructing, repairing, or improving of any structure
24 upon, above, or under any real property owned by an owner who conveys
25 the property by title, possession, or any other means to the person
26 performing such construction, repair, or improvement for the purpose
27 of performing such construction, repair, or improvement and the
28 property is then reconveyed by title, possession, or any other means
29 to the original owner;

30 (d) The cleaning, fumigating, razing, or moving of existing
31 buildings or structures, but does not include the charge made for
32 janitorial services; and for purposes of this section the term
33 "janitorial services" means those cleaning and caretaking services
34 ordinarily performed by commercial janitor service businesses
35 including, but not limited to, wall and window washing, floor
36 cleaning and waxing, and the cleaning in place of rugs, drapes and
37 upholstery. The term "janitorial services" does not include painting,
38 papering, repairing, furnace or septic tank cleaning, snow removal or
39 sandblasting;

1 (e) Automobile towing and similar automotive transportation
2 services, but not in respect to those required to report and pay
3 taxes under chapter 82.16 RCW;

4 (f) The furnishing of lodging and all other services by a hotel,
5 rooming house, tourist court, motel, trailer camp, and the granting
6 of any similar license to use real property, as distinguished from
7 the renting or leasing of real property, and it is presumed that the
8 occupancy of real property for a continuous period of one month or
9 more constitutes a rental or lease of real property and not a mere
10 license to use or enjoy the same. For the purposes of this
11 subsection, it is presumed that the sale of and charge made for the
12 furnishing of lodging for a continuous period of one month or more to
13 a person is a rental or lease of real property and not a mere license
14 to enjoy the same. For the purposes of this section, it is presumed
15 that the sale of and charge made for the furnishing of lodging
16 offered regularly for public occupancy for periods of less than a
17 month constitutes a license to use or enjoy the property subject to
18 sales and use tax and not a rental or lease of property;

19 (g) The installing, repairing, altering, or improving of digital
20 goods for consumers;

21 (h) Persons taxable under (a), (b), (c), (d), (e), (f), and (g)
22 of this subsection when such sales or charges are for property, labor
23 and services which are used or consumed in whole or in part by such
24 persons in the performance of any activity defined as a "sale at
25 retail" or "retail sale" even though such property, labor and
26 services may be resold after such use or consumption. Nothing
27 contained in this subsection may be construed to modify subsection
28 (1) of this section and nothing contained in subsection (1) of this
29 section may be construed to modify this subsection.

30 (3) The term "sale at retail" or "retail sale" includes the sale
31 of or charge made for personal, business, or professional services
32 including amounts designated as interest, rents, fees, admission, and
33 other service emoluments however designated, received by persons
34 engaging in the following business activities:

35 (a) Abstract, title insurance, and escrow services;

36 (b) Credit bureau services;

37 (c) Automobile parking and storage garage services;

38 (d) Landscape maintenance and horticultural services but
39 excluding (i) horticultural services provided to farmers and (ii)
40 pruning, trimming, repairing, removing, and clearing of trees and

1 brush near electric transmission or distribution lines or equipment,
2 if performed by or at the direction of an electric utility;

3 (e) Service charges associated with tickets to professional
4 sporting events;

5 (f) The following personal services: Tanning salon services,
6 tattoo parlor services, steam bath services, turkish bath services,
7 escort services, and dating services; (~~and~~)

8 (g) Information technology technical consulting services
9 including, but not limited to, planning and designing information
10 technology systems, network systems integration design services, and
11 systems integration design and consulting;

12 (h) Information technology training services, technical support,
13 and other services including, but not limited to, assisting with
14 network operations and support, help desk services, in-person
15 training related to hardware or software, network system support
16 services, data entry services, and data processing services;

17 (i) Custom website development services. For the purposes of this
18 subsection (3), "website development services" means the design,
19 development, and support of a website provided by a website developer
20 to a customer;

21 (j) Investigation, security services, security monitoring
22 services, and armored car services including, but not limited to,
23 background checks, security guard and patrol services, personal and
24 event security, armored car transportation of cash and valuables, and
25 security system services and monitoring. This does not include
26 locksmith services;

27 (k) Temporary staffing services. For the purposes of this
28 subsection (3), "temporary staffing services" means providing workers
29 to other businesses, except for hospitals licensed under chapter
30 70.41 or 71.12 RCW, for limited periods of time to supplement their
31 workforce and fill employment vacancies on a contract or for fee
32 basis;

33 (l) Advertising services. For the purposes of this subsection
34 (3), "advertising services" means all digital and nondigital
35 services, except for services rendered in respect to printing,
36 publishing, radio, and television including, but not limited to,
37 services directly related to the creation, preparation, production,
38 or the dissemination of advertisements. "Advertising services"
39 include layout, art direction, graphic design, mechanical
40 preparation, production supervision, placement, and rendering advice

1 to a client concerning the best methods of advertising that client's
2 products or services. "Advertising services" also include online
3 referrals, search engine marketing, and lead generation optimization,
4 web campaign planning, the acquisition of advertising space in the
5 internet media, and the monitoring and evaluation of website traffic
6 for purposes of determining the effectiveness of an advertising
7 campaign. "Advertising services" do not include web hosting services
8 and domain name registration;

9 (m) Live presentations including, but not limited to, lectures,
10 seminars, workshops, or courses where participants attend either in-
11 person or via the internet or telecommunications equipment that
12 allows audience members and the presenter or instructor to give,
13 receive, and discuss information with each other in real time; and

14 (n)(i) Operating an athletic or fitness facility, including all
15 charges for the use of such a facility or for any associated services
16 and amenities, except as provided in ((+g+)) (n)(ii) of this
17 subsection.

18 (ii) Notwithstanding anything to the contrary in ((+g+)) (n)(i)
19 of this subsection (3), the term "sale at retail" and "retail sale"
20 under this subsection does not include:

21 (A) Separately stated charges for the use of an athletic or
22 fitness facility where such use is primarily for a purpose other than
23 engaging in or receiving instruction in a physical fitness activity;

24 (B) Separately stated charges for the use of a discrete portion
25 of an athletic or fitness facility, other than a pool, where such
26 discrete portion of the facility does not by itself meet the
27 definition of "athletic or fitness facility" in this subsection;

28 (C) Separately stated charges for services, such as
29 (~~advertising,~~) massage, nutritional consulting, and body
30 composition testing, that do not require the customer to engage in
31 physical fitness activities to receive the service. The exclusion in
32 this subsection (3)((+g+)) (n)(ii)(C) does not apply to personal
33 training services and instruction in a physical fitness activity;

34 (D) Separately stated charges for physical therapy provided by a
35 physical therapist, as those terms are defined in RCW 18.74.010, or
36 occupational therapy provided by an occupational therapy
37 practitioner, as those terms are defined in RCW 18.59.020, when
38 performed pursuant to a referral from an authorized health care
39 practitioner or in consultation with an authorized health care
40 practitioner. For the purposes of this subsection (3)((+g+)) (n)

1 (ii) (D), an authorized health care practitioner means a health care
2 practitioner licensed under chapter 18.83, 18.25, 18.36A, 18.57,
3 18.71, or 18.71A RCW, or, until July 1, 2022, chapter 18.57A RCW;

4 (E) Rent or association fees charged by a landlord or residential
5 association to a tenant or residential owner with access to an
6 athletic or fitness facility maintained by the landlord or
7 residential association, unless the rent or fee varies depending on
8 whether the tenant or owner has access to the facility;

9 (F) Services provided in the regular course of employment by an
10 employee with access to an athletic or fitness facility maintained by
11 the employer for use without charge by its employees or their family
12 members;

13 (G) The provision of access to an athletic or fitness facility by
14 an educational institution to its students and staff. However,
15 charges made by an educational institution to its alumni or other
16 members of the public for the use of any of the educational
17 institution's athletic or fitness facilities are a retail sale under
18 this subsection (3) ~~((g))~~ (n). For purposes of this subsection (3)
19 ~~((g))~~ (n)(ii) (G), "educational institution" has the same meaning as
20 in RCW 82.04.170;

21 (H) Yoga, chi gong, or martial arts classes, training, or events
22 held at a community center, park, school gymnasium, college or
23 university, hospital or other medical facility, private residence, or
24 any other facility that is not operated within and as part of an
25 athletic or fitness facility.

26 (iii) Nothing in ~~((g))~~ (n)(ii) of this subsection (3) may be
27 construed to affect the taxation of sales made by the operator of an
28 athletic or fitness facility, where such sales are defined as a
29 retail sale under any provision of this section other than this
30 subsection (3).

31 (iv) For the purposes of this subsection (3) ~~((g))~~ (n), the
32 following definitions apply:

33 (A) "Athletic or fitness facility" means an indoor or outdoor
34 facility or portion of a facility that is primarily used for:
35 Exercise classes; strength and conditioning programs; personal
36 training services; tennis, racquetball, handball, squash, or
37 pickleball; or other activities requiring the use of exercise or
38 strength training equipment, such as treadmills, elliptical machines,
39 stair climbers, stationary cycles, rowing machines, pilates

1 equipment, balls, climbing ropes, jump ropes, and weightlifting
2 equipment.

3 (B) "Martial arts" means any of the various systems of training
4 for physical combat or self-defense. "Martial arts" includes, but is
5 not limited to, karate, kung fu, tae kwon do, Krav Maga, boxing,
6 kickboxing, jujitsu, shootfighting, wrestling, aikido, judo, hapkido,
7 Kendo, tai chi, and mixed martial arts.

8 (C) "Physical fitness activities" means activities that involve
9 physical exertion for the purpose of improving or maintaining the
10 general fitness, strength, flexibility, conditioning, or health of
11 the participant. "Physical fitness activities" includes participating
12 in yoga, chi gong, or martial arts.

13 For the purposes of (g) through (j) and (l) of this subsection
14 (3), the terms "sale at retail" and "retail sale" do not include a
15 sale between members of an affiliated group as defined in RCW
16 82.04.299(1)(f).

17 (4) (a) The term also includes the renting or leasing of tangible
18 personal property to consumers.

19 (b) The term does not include the renting or leasing of tangible
20 personal property where the lease or rental is for the purpose of
21 sublease or subrent.

22 (5) The term also includes the providing of "competitive
23 telephone service," "telecommunications service," or "ancillary
24 services," as those terms are defined in RCW 82.04.065, to consumers.

25 (6) (a) The term also includes the sale of prewritten computer
26 software, custom software, and customization of prewritten computer
27 software to a consumer, regardless of the method of delivery to the
28 end user. For purposes of ~~((a) and (b) of)~~ this subsection (6) (a),
29 the sale of prewritten computer software includes the sale of or
30 charge made for a key or an enabling or activation code, where the
31 key or code is required to activate prewritten computer software and
32 put the software into use. There is no separate sale of the key or
33 code from the prewritten computer software, regardless of how the
34 sale may be characterized by the vendor or by the purchaser.

35 (b) ~~((The term "retail sale" does not include the sale of or~~
36 ~~charge made for:~~

37 ~~(i) Custom software; or~~

38 ~~(ii) The customization of prewritten computer software.~~

39 ~~(e))~~ (i) The term also includes the charge made to consumers for
40 the right to access and use prewritten computer software, custom

1 software, and customization of prewritten computer software, where
2 possession of the software is maintained by the seller or a third
3 party, regardless of whether the charge for the service is on a per
4 use, per user, per license, subscription, or some other basis.

5 (ii)(A) The service described in ~~((e+))~~ (b)(i) of this
6 subsection (6) includes the right to access and use prewritten
7 computer software, custom software, and customization of prewritten
8 computer software to perform data processing.

9 (B) For purposes of this subsection (6) ~~((e+))~~ (b)(ii), "data
10 processing" means the systematic performance of operations on data to
11 extract the required information in an appropriate form or to convert
12 the data to usable information. Data processing includes check
13 processing, image processing, form processing, survey processing,
14 payroll processing, claim processing, and similar activities.

15 (7) The term also includes the sale of or charge made for an
16 extended warranty to a consumer. For purposes of this subsection,
17 "extended warranty" means an agreement for a specified duration to
18 perform the replacement or repair of tangible personal property at no
19 additional charge or a reduced charge for tangible personal property,
20 labor, or both, or to provide indemnification for the replacement or
21 repair of tangible personal property, based on the occurrence of
22 specified events. The term "extended warranty" does not include an
23 agreement, otherwise meeting the definition of extended warranty in
24 this subsection, if no separate charge is made for the agreement and
25 the value of the agreement is included in the sales price of the
26 tangible personal property covered by the agreement. For purposes of
27 this subsection, "sales price" has the same meaning as in RCW
28 82.08.010.

29 (8)(a) The term also includes the following sales to consumers of
30 digital goods, digital codes, and digital automated services:

31 (i) Sales in which the seller has granted the purchaser the right
32 of permanent use;

33 (ii) Sales in which the seller has granted the purchaser a right
34 of use that is less than permanent;

35 (iii) Sales in which the purchaser is not obligated to make
36 continued payment as a condition of the sale; and

37 (iv) Sales in which the purchaser is obligated to make continued
38 payment as a condition of the sale.

39 (b) A retail sale of digital goods, digital codes, or digital
40 automated services under this subsection (8) includes any services

1 provided by the seller exclusively in connection with the digital
2 goods, digital codes, or digital automated services, whether or not a
3 separate charge is made for such services.

4 (c) A retail sale of digital goods, digital codes, or digital
5 automated services does not include the following services if the
6 sale occurs between members of an affiliated group as defined in RCW
7 82.04.299(1)(f):

8 (i) Any service that primarily involves the application of human
9 effort by the seller, and the human effort originated after the
10 customer requested the service;

11 (ii) Live presentations, such as lectures, seminars, workshops,
12 or courses, where participants are connected to other participants
13 via the internet or telecommunications equipment, which allows
14 audience members and the presenter or instructor to give, receive,
15 and discuss information with each other in real time;

16 (iii) Advertising services. For purposes of this subsection
17 (8)(c), "advertising services" means all services directly related to
18 the creation, preparation, production, or dissemination of
19 advertisements. Advertising services include layout, art direction,
20 graphic design, mechanical preparation, production supervision,
21 placement, and rendering advice to a client concerning the best
22 methods of advertising that client's products or services.
23 Advertising services also include online referrals, search engine
24 marketing and lead generation optimization, web campaign planning,
25 the acquisition of advertising space in the internet media, and the
26 monitoring and evaluation of website traffic for purposes of
27 determining the effectiveness of an advertising campaign. Advertising
28 services do not include web hosting services and domain name
29 registration; and

30 (iv) Data processing services. For purposes of this subsection
31 (8)(c), "data processing service" means a primarily automated service
32 provided to a business or other organization where the primary object
33 of the service is the systematic performance of operations by the
34 service provider on data supplied in whole or in part by the customer
35 to extract the required information in an appropriate form or to
36 convert the data to usable information. Data processing services
37 include check processing, image processing, form processing, survey
38 processing, payroll processing, claim processing, and similar
39 activities. Data processing does not include the service described in
40 subsection (6)(b) of this section.

1 (d) For purposes of this subsection, "permanent" means perpetual
2 or for an indefinite or unspecified length of time. A right of
3 permanent use is presumed to have been granted unless the agreement
4 between the seller and the purchaser specifies or the circumstances
5 surrounding the transaction suggest or indicate that the right to use
6 terminates on the occurrence of a condition subsequent.

7 (9) The term also includes the charge made for providing tangible
8 personal property along with an operator for a fixed or indeterminate
9 period of time. A consideration of this is that the operator is
10 necessary for the tangible personal property to perform as designed.
11 For the purpose of this subsection (9), an operator must do more than
12 maintain, inspect, or set up the tangible personal property.

13 (10) The term does not include the sale of or charge made for
14 labor and services rendered in respect to the building, repairing, or
15 improving of any street, place, road, highway, easement, right-of-
16 way, mass public transportation terminal or parking facility, bridge,
17 tunnel, or trestle which is owned by a municipal corporation or
18 political subdivision of the state or by the United States and which
19 is used or to be used primarily for foot or vehicular traffic
20 including mass transportation vehicles of any kind.

21 (11) The term also does not include sales of chemical sprays or
22 washes to persons for the purpose of postharvest treatment of fruit
23 for the prevention of scald, fungus, mold, or decay, nor does it
24 include sales of feed, seed, seedlings, fertilizer, agents for
25 enhanced pollination including insects such as bees, and spray
26 materials to: (a) Persons who participate in the federal conservation
27 reserve program, the environmental quality incentives program, the
28 wetlands reserve program, and the wildlife habitat incentives
29 program, or their successors administered by the United States
30 department of agriculture; (b) farmers for the purpose of producing
31 for sale any agricultural product; (c) farmers for the purpose of
32 providing bee pollination services; and (d) farmers acting under
33 cooperative habitat development or access contracts with an
34 organization exempt from federal income tax under 26 U.S.C. Sec.
35 501(c)(3) of the federal internal revenue code or the Washington
36 state department of fish and wildlife to produce or improve wildlife
37 habitat on land that the farmer owns or leases.

38 (12) The term does not include the sale of or charge made for
39 labor and services rendered in respect to the constructing,
40 repairing, decorating, or improving of new or existing buildings or

1 other structures under, upon, or above real property of or for the
2 United States, any instrumentality thereof, or a county or city
3 housing authority created pursuant to chapter 35.82 RCW, including
4 the installing, or attaching of any article of tangible personal
5 property therein or thereto, whether or not such personal property
6 becomes a part of the realty by virtue of installation. Nor does the
7 term include the sale of services or charges made for the clearing of
8 land and the moving of earth of or for the United States, any
9 instrumentality thereof, or a county or city housing authority. Nor
10 does the term include the sale of services or charges made for
11 cleaning up for the United States, or its instrumentalities,
12 radioactive waste and other by-products of weapons production and
13 nuclear research and development.

14 (13) The term does not include the sale of or charge made for
15 labor, services, or tangible personal property pursuant to agreements
16 providing maintenance services for bus, rail, or rail fixed guideway
17 equipment when a regional transit authority is the recipient of the
18 labor, services, or tangible personal property, and a transit agency,
19 as defined in RCW 81.104.015, performs the labor or services.

20 (14) The term does not include the sale for resale of any service
21 described in this section if the sale would otherwise constitute a
22 "sale at retail" and "retail sale" under this section.

23 (15)(a) The term "sale at retail" or "retail sale" includes
24 amounts charged, however labeled, to consumers to engage in any of
25 the activities listed in this subsection (15)(a), including the
26 furnishing of any associated equipment or, except as otherwise

15 facilities, including but not limited to charges for admission and
16 locker or cabana rentals. Discrete charges for rides or other
17 attractions or entertainment that are in addition to the charge for
18 admission are not a retail sale under this subsection (15) (a) (iv).
19 For the purposes of this subsection, an amusement park or theme park
20 is a location that provides permanently affixed amusement rides,
21 games, and other entertainment, but does not include parks or zoos
22 for which the primary purpose is the exhibition of wildlife, or
23 fairs, carnivals, and festivals as defined in (b) (i) of this
24 subsection;

25 (v) Batting cage activities;

26 (vi) Bowling, but not including competitive events, except that
27 amounts paid by the event participants to the bowling alley operator
28 are retail sales under this subsection (15) (a) (vi). Likewise, amounts
29 paid by the event organizer to the operator of the bowling alley are
30 retail sales under this subsection (15) (a) (vi), if such amounts vary
31 based on the number of event participants;

32 (vii) Climbing on artificial climbing structures, whether indoors
33 or outdoors;

34 (viii) Day trips for sightseeing purposes;

35 (ix) Bungee jumping, zip lining, and riding inside a ball,
36 whether inflatable or otherwise;

37 (x) Horseback riding offered to the public, where the seller
38 furnishes the horse to the buyer and providing instruction is not the
39 primary focus of the activity, including guided rides, but not
40 including therapeutic horseback riding provided by an instructor

1 certified by a nonprofit organization that offers national or
2 international certification for therapeutic riding instructors;

3 (xi) Fishing, including providing access to private fishing areas
4 and charter or guided fishing, except that fishing contests and
5 license fees imposed by a government entity are not a retail sale
6 under this subsection;

7 (xii) Guided hunting and hunting at game farms and shooting
8 preserves, except that hunting contests and license fees imposed by a
9 government entity are not a retail sale under this subsection;

10 (xiii) Swimming, but only in respect to (A) recreational or
11 fitness swimming that is open to the public, such as open swim, lap
12 swimming, and special events like kids night out and pool parties
13 during open swim time, and (B) pool parties for private events, such
14 as birthdays, family gatherings, and employee outings. Fees for
15 swimming lessons, to participate in swim meets and other
16 competitions, or to join a swim team, club, or aquatic facility are
17 not retail sales under this subsection (15)(a)(xiii);

18 (xiv) Go-karting, bumper cars, and other motorized activities
19 where the seller provides the vehicle and the premises where the
20 buyer will operate the vehicle;

26 activities provided for children by a licensed child day care center

30 skeet, trap, sporting clays, "5" stand, and archery, but only in
31 respect to discrete charges to members of the public to engage in
32 these activities, but not including fees to enter a competitive
33 event, instruction that is entirely or predominately classroom based,
34 or to join or renew a membership at a club, range, or other facility;

35 (xvii) Paintball and airsoft activities;

36 (xviii) Skating, including ice skating, roller skating, and
37 inline skating, but only in respect to discrete charges to members of
38 the public to engage in skating activities, but not including skating
39 lessons, competitive events, team activities, or fees to join or

1 renew a membership at a skating facility, club, or other
2 organization;

3 (xix) Nonmotorized snow sports and activities, such as downhill
4 and cross-country skiing, snowboarding, ski jumping, sledding, snow
5 tubing, snowshoeing, and similar snow sports and activities, whether
6 engaged in outdoors or in an indoor facility with or without snow,
7 but only in respect to discrete charges to the public for the use of
8 land or facilities to engage in nonmotorized snow sports and
9 activities, such as fees, however labeled, for the use of ski lifts
10 and tows and daily or season passes for access to trails or other
11 areas where nonmotorized snow sports and activities are conducted.
12 However, fees for the following are not retail sales under this
13 subsection (15)(a)(xix): (A) Instructional lessons; (B) permits

10 RCW 82.04.4339, except for transactions excluded from the definition
11 of "sale at retail" or "retail sale" by any other provision of this

34 **CONCERNING THE TAXATION OF NICOTINE PRODUCTS**

1 (1) "Actual price" means the total amount of consideration for

6 (2) "Affiliated" means related in any way by virtue of any form
7 or amount of common ownership, control, operation, or management.

8 (3) "Board" means the liquor and cannabis board.

9 (4) "Business" means any trade, occupation, activity, or
10 enterprise engaged in for the purpose of selling or distributing
11 tobacco products in this state.

12 (5) "Cigar" means a roll for smoking that is of any size or shape
13 and that is made wholly or in part of tobacco, irrespective of
14 whether the tobacco is pure or flavored, adulterated or mixed with
15 any other ingredient, if the roll has a wrapper made wholly or in
16 greater part of tobacco. "Cigar" does not include a cigarette.

17 (6) "Cigarette" has the same meaning as in RCW 82.24.010.

18 (7) "Department" means the department of revenue.

19 (8) "Distributor" means (a) any person engaged in the business of
20 selling tobacco products in this state who brings, or causes to be
21 brought, into this state from without the state any tobacco products
22 for sale, (b) any person who makes, manufactures, fabricates, or
23 stores tobacco products in this state for sale in this state, (c) any
24 person engaged in the business of selling tobacco products without
25 this state who ships or transports tobacco products to retailers in
26 this state, to be sold by those retailers, (d) any person engaged in
27 the business of selling tobacco products in this state who handles
28 for sale any tobacco products that are within this state but upon
29 which tax has not been imposed.

30 (9) "Indian country" means the same as defined in chapter 82.24
31 RCW.

32 (10) "Little cigar" means a cigar that has a cellulose acetate
33 integrated filter.

34 (11) "Manufacturer" means a person who manufactures and sells
35 tobacco products.

36 (12) "Manufacturer's representative" means a person hired by a
37 manufacturer to sell or distribute the manufacturer's tobacco
38 products, and includes employees and independent contractors.

39 (13) "Moist snuff" means tobacco, or a similar product containing
40 nicotine, that is finely cut, ground, or powdered; is not for

1 smoking; and is intended to be placed in the oral, but not the nasal,
2 cavity.

3 (14) "Person" means any individual, receiver, administrator,
4 executor, assignee, trustee in bankruptcy, trust, estate, firm,
5 copartnership, joint venture, club, company, joint stock company,
6 business trust, municipal corporation, the state and its departments
7 and institutions, political subdivision of the state of Washington,
8 corporation, limited liability company, association, society, any
9 group of individuals acting as a unit, whether mutual, cooperative,
10 fraternal, nonprofit, or otherwise. The term excludes any person
11 immune from state taxation, including the United States or its
12 instrumentalities, and federally recognized Indian tribes and
13 enrolled tribal members, conducting business within Indian country.

14 (15) "Place of business" means any place where tobacco products
15 are sold or where tobacco products are manufactured, stored, or kept
16 for the purpose of sale, including any vessel, vehicle, airplane,
17 train, or vending machine.

18 (16) "Retail outlet" means each place of business from which
19 tobacco products are sold to consumers.

20 (17) "Retailer" means any person engaged in the business of
21 selling tobacco products to ultimate consumers.

22 (18)(a) "Sale" means any transfer, exchange, or barter, in any
23 manner or by any means whatsoever, for a consideration, and includes
24 and means all sales made by any person.

25 (b) The term "sale" includes a gift by a person engaged in the
26 business of selling tobacco products, for advertising, promoting, or
27 as a means of evading the provisions of this chapter.

28 (19)(a) "Taxable sales price" means:

29 (i) In the case of a taxpayer that is not affiliated with the
30 manufacturer, distributor, or other person from whom the taxpayer
31 purchased tobacco products, the actual price for which the taxpayer
32 purchased the tobacco products;

33 (ii) In the case of a taxpayer that purchases tobacco products
34 from an affiliated manufacturer, affiliated distributor, or other
35 affiliated person, and that sells those tobacco products to
36 unaffiliated distributors, unaffiliated retailers, or ultimate
37 consumers, the actual price for which that taxpayer sells those
38 tobacco products to unaffiliated distributors, unaffiliated
39 retailers, or ultimate consumers;

1 (iii) In the case of a taxpayer that sells tobacco products only
2 to affiliated distributors or affiliated retailers, the price,
3 determined as nearly as possible according to the actual price, that
4 other distributors sell similar tobacco products of like quality and
5 character to unaffiliated distributors, unaffiliated retailers, or
6 ultimate consumers;

7 (iv) In the case of a taxpayer that is a manufacturer selling
8 tobacco products directly to ultimate consumers, the actual price for
9 which the taxpayer sells those tobacco products to ultimate
10 consumers;

11 (v) In the case of a taxpayer that has acquired tobacco products
12 under a sale as defined in subsection (18)(b) of this section, the
13 price, determined as nearly as possible according to the actual
14 price, that the taxpayer or other distributors sell the same tobacco
15 products or similar tobacco products of like quality and character to
16 unaffiliated distributors, unaffiliated retailers, or ultimate
17 consumers; or

18 (vi) In any case where (a)(i) through (v) of this subsection do
19 not apply, the price, determined as nearly as possible according to
20 the actual price, that the taxpayer or other distributors sell the
21 same tobacco products or similar tobacco products of like quality and
22 character to unaffiliated distributors, unaffiliated retailers, or
23 ultimate consumers.

24 (b) For purposes of (a)(i) and (ii) of this subsection only,
25 "person" includes both persons as defined in subsection (14) of this
26 section and any person immune from state taxation, including the
27 United States or its instrumentalities, and federally recognized
28 Indian tribes and enrolled tribal members, conducting business within
29 Indian country.

30 (c) The department may adopt rules regarding the determination of
31 taxable sales price under this subsection.

32 (20) "Taxpayer" means a person liable for the tax imposed by this
33 chapter.

34 (21) "Tobacco products" means cigars, cheroots, stogies,
35 periques, granulated, plug cut, crimp cut, ready rubbed, and other
36 smoking tobacco, snuff, snuff flour, cavendish, plug and twist
37 tobacco, fine-cut and other chewing tobaccos, shorts, refuse scraps,
38 clippings, cuttings and sweepings of tobacco, and other kinds and
39 forms of tobacco, prepared in such manner as to be suitable for
40 chewing or smoking in a pipe or otherwise, or both for chewing and

1 smoking, and any other product, regardless of form, that contains
2 tobacco or nicotine, whether derived from tobacco or created
3 synthetically, and is intended for human consumption or placement in
4 the oral or nasal cavity or absorption into the human body by any
5 other means, but does not include cigarettes as defined in RCW

7 (22) "Unaffiliated distributor" means a distributor that is not
8 affiliated with the manufacturer, distributor, or other person from
9 whom the distributor has purchased tobacco products.

10 (23) "Unaffiliated retailer" means a retailer that is not
11 affiliated with the manufacturer, distributor, or other person from
12 whom the retailer has purchased tobacco products.

14 **REQUIRING CERTAIN BUSINESSES TO MAKE A ONE-TIME PREPAYMENT OF STATE**
15 **SALES TAX COLLECTIONS**

26 June 25, 2027, of the tax imposed under chapter 82.08 RCW equal to 80

30 before July 26, 2027. The taxpayer must correct the collection
31 amounts on the regularly filed excise tax return due on or before
32 July 26, 2027.

33 (2) The department of revenue may relieve any taxpayer or class
34 of taxpayers from the obligation of remitting monthly and may require
35 the return to cover other longer reporting periods, but in no event
36 may returns be filed for a period greater than one year. Except as
37 provided in subsection (3) of this section, for these taxpayers, tax

1 payments are due on or before the last day of the month next
2 succeeding the end of the period covered by the return.

3 (3) For annual filers, tax payments, along with reports and
4 returns on forms prescribed by the department, are due on or before
5 April 15th of the year immediately following the end of the period
6 covered by the return.

7 (4) The department of revenue may also require verified annual
8 returns from any taxpayer, setting forth such additional information
9 as it may deem necessary to correctly determine tax liability.

10 (5) Notwithstanding subsections (1) and (2) of this section, the
11 department may relieve any person of the requirement to file returns
12 if the following conditions are met:

13 (a) The person's value of products, gross proceeds of sales, or
14 gross income of the business, from all business activities taxable
15 under chapter 82.04 RCW, is less than \$125,000 per year;

16 (b) The person's gross income of the business from all activities
17 taxable under chapter 82.16 RCW is less than \$24,000 per year; and

18 (c) The person is not required to collect or pay to the
19 department of revenue any other tax or fee which the department is
20 authorized to collect.

21 (6)(a) Taxes imposed under chapter 82.08 or 82.12 RCW on taxable
22 events that occur beginning January 1, 2019, through June 30, 2019,
23 and payable by a consumer directly to the department are due, on
24 returns prescribed by the department, by July 25, 2019.

25 (b) This subsection (6) does not apply to the reporting and
26 payment of taxes imposed under chapters 82.08 and 82.12 RCW:

27 (i) On the retail sale or use of motor vehicles, vessels, or
28 aircraft; or

29 (ii) By consumers who are engaged in business, unless the
30 department has relieved the consumer of the requirement to file
31 returns pursuant to subsection (5) of this section.

32 **Sec. 402.** RCW 82.32.050 and 2022 c 282 s 2 and 2022 c 41 s 2 are
33 each reenacted and amended to read as follows:

34 (1) If upon examination of any returns or from other information
35 obtained by the department it appears that a tax or penalty has been
36 paid less than that properly due, the department shall assess against
37 the taxpayer such additional amount found to be due and shall add
38 thereto interest on the tax only. The department shall notify the
39 taxpayer by mail, or electronically as provided in RCW 82.32.135, of

1 the additional amount and the additional amount shall become due and
2 shall be paid within (~~thirty~~) 30 days from the date of the notice,
3 or within such further time as the department may provide.

4 (a) For tax liabilities arising before January 1, 1992, interest
5 shall be computed at the rate of nine percent per annum from the last
6 day of the year in which the deficiency is incurred until the earlier
7 of December 31, 1998, or the date of payment. After December 31,
8 1998, the rate of interest shall be variable and computed as provided
9 in subsection (2) of this section. The rate so computed shall be
10 adjusted on the first day of January of each year for use in
11 computing interest for that calendar year.

12 (b) For tax liabilities arising after December 31, 1991, the rate
13 of interest shall be variable and computed as provided in subsection
14 (2) of this section from the last day of the year in which the
15 deficiency is incurred until the date of payment. The rate so
16 computed shall be adjusted on the first day of January of each year
17 for use in computing interest for that calendar year.

18 (c)(i) Except as otherwise provided in this subsection (1)(c),
19 interest imposed after December 31, 1998, shall be computed from the
20 last day of the month following each calendar year included in a
21 notice, and the last day of the month following the final month
22 included in a notice if not the end of a calendar year, until the due
23 date of the notice.

24 (ii) For interest associated with annual tax reporting periods
25 having a due date as prescribed in RCW 82.32.045(3), interest must be
26 computed from the last day of April immediately following each such
27 annual reporting period included in the notice, until the due date of
28 the notice.

29 (iii) For purposes of computing interest under (c)(i) and (ii) of
30 this subsection (1):

31 (A) The same computation of interest applies regardless of
32 whether the department grants additional time for filing any return
33 under RCW 82.32.080(4)(a)(i).

34 (B) If the department extends a due date under subsection (3) of
35 this section or RCW 82.32.080(4)(b), and payment is not made in full
36 by the extended due date, interest is computed from the last day of
37 the month in which the extended due date occurs until the date of
38 payment.

39 (iv) If payment in full is not made by the due date of the
40 notice, additional interest shall be computed under this subsection

1 (1)(c) until the date of payment. The rate of interest shall be
2 variable and computed as provided in subsection (2) of this section.
3 The rate so computed shall be adjusted on the first day of January of
4 each year for use in computing interest for that calendar year.

5 (2) For the purposes of this section, the rate of interest to be
6 charged to the taxpayer shall be an average of the federal short-term
7 rate as defined in 26 U.S.C. Sec. 1274(d) plus two percentage points.
8 The rate set for each new year shall be computed by taking an
9 arithmetical average to the nearest percentage point of the federal
10 short-term rate, compounded annually. That average shall be
11 calculated using the rates from four months: January, April, and July
12 of the calendar year immediately preceding the new year, and October
13 of the previous preceding year.

14 (3) During a state of emergency declared under RCW 43.06.010(12),
15 the department, on its own motion or at the request of any taxpayer
16 affected by the emergency, may extend the due date of any assessment
17 or correction of an assessment for additional taxes, penalties, or
18 interest as the department deems proper.

19 (4) No assessment or correction of an assessment for additional
20 taxes, penalties, or interest due may be made by the department more
21 than four years after the close of the tax year, except (a) against a
22 taxpayer who has not registered as required by this chapter, (b) upon
23 a showing of fraud or of misrepresentation of a material fact by the
24 taxpayer, or (c) where a taxpayer has executed a written waiver of
25 such limitation. The execution of a written waiver shall also extend
26 the period for making a refund or credit as provided in RCW
27 82.32.060(2).

28 (5) (a) For taxes remitted under RCW 82.32.045(1)(b), a one-time
29 penalty equal to 10 percent of the amount of the tax due and payable
30 applies for:

31 (i) The failure of the taxpayer to submit the prepayment of state
32 sales tax pursuant to RCW 82.32.045 collected and remitted under
33 chapter 82.08 RCW; or

34 (ii) A taxpayer submitting a prepayment pursuant to RCW 82.32.045
35 lower than 80 percent of the amount of sales tax collected during the
36 June 2026 reporting period.

37 (b) The department may waive the penalty under (a) of this
38 subsection if the taxpayer provides documentation to the department
39 indicating that the taxpayer's June 2027 taxable retail sales are

1 less than 80 percent of the taxpayer's June 2026 taxable retail
2 sales.

3 (6) For the purposes of this section, the following definitions
4 apply:

5 (a) "Due date of the notice" means the date indicated in the
6 notice by which the amount due in the notice must be paid, or such
7 later date as provided by RCW 1.12.070(3).

8 (b) "Return" means any document a person is required by the state
9 of Washington to file to satisfy or establish a tax or fee obligation
10 that is administered or collected by the department and that has a
11 statutorily defined due date. "Return" also means an application for
12 refund under RCW 82.08.0206.

15 NEW SECTION. **Sec. 501.** If any provision of this act or its
16 application to any person or circumstance is held invalid, the
17 remainder of the act or the application of the provision to other
18 persons or circumstances is not affected.

19 NEW SECTION. **Sec. 502.** This act is necessary for the support of
20 the state government and its existing public institutions.

21 NEW SECTION. **Sec. 503.** Sections 101 and 201 of this act take
22 effect October 1, 2025.

23 NEW SECTION. **Sec. 504.** Section 301 of this act takes effect
24 January 1, 2026.

25 NEW SECTION. **Sec. 505.** Sections 401 and 402 of this act take
26 effect January 1, 2027.
