1 AN ACT Relating to nursing delegation; amending RCW 18.79.260,  
2 18.79.260, 18.88A.210, 18.88A.210, 18.88A.230, 18.88B.070, and  
3 70.127.010; providing effective dates; and providing expiration  
4 dates.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 **Sec. 1.** RCW 18.79.260 and 2025 c 58 s 5019 are each amended to  
7 read as follows:

8 (1) A registered nurse under his or her license may perform for  
9 compensation nursing care, as that term is usually understood, to  
10 individuals with illnesses, injuries, or disabilities.

11 (2) A registered nurse may, at or under the general direction of  
12 a licensed physician and surgeon, dentist, osteopathic physician and  
13 surgeon, naturopathic physician, optometrist, podiatric physician and  
14 surgeon, physician assistant, advanced registered nurse practitioner,  
15 or midwife acting within the scope of his or her license, administer  
16 medications, treatments, tests, and inoculations, whether or not the  
17 severing or penetrating of tissues is involved and whether or not a  
18 degree of independent judgment and skill is required. Such direction  
19 must be for acts which are within the scope of registered nursing  
20 practice.

1 (3) A registered nurse may delegate tasks (~~(of nursing care)~~) to  
2 other individuals in any setting where the registered nurse  
3 determines that it is in the best interest of the patient and within  
4 the nurse's scope of practice.

31 (5) No person may coerce a nurse into compromising patient safety  
32 by requiring the nurse to delegate if the nurse determines that it is  
33 inappropriate to do so. Nurses shall not be subject to any employer  
34 reprisal or disciplinary action by the board for refusing to delegate  
35 tasks or refusing to provide the required training for delegation if  
36 the nurse determines delegation may compromise patient safety.

10 nursing assistant-certified or home care aide, licensed under chapter  
11 18.88A or 18.88B RCW, respectively, may administer medications,  
12 including those that pierce the skin through subcutaneous injections,  
13 and may perform capillary blood sticks.

14 (8) Nursing task delegation protocols are not intended to  
15 regulate the settings in which delegation may occur, but are intended  
16 to ensure that nursing care services have a consistent standard of  
17 practice upon which the public and the profession may rely, and to  
18 safeguard the authority of the nurse to make independent professional  
19 decisions regarding the delegation of a task.

26 delegating nursing care tasks to family members and others for many  
27 years. The opportunity for a nurse to delegate nursing care tasks to  
28 home care aides certified under this chapter may enhance the  
29 viability and quality of health care services in community-based care  
30 settings and in-home care settings to allow individuals to live as  
31 independently as possible with maximum safeguards.

32 (2) (~~(a)~~) A certified home care aide who wishes to perform a  
33 nurse delegated task pursuant to RCW 18.79.260 must complete nurse  
34 delegation core training under chapter 18.88A RCW before the home

3 (1) "Administrator" means an individual responsible for managing  
4 the operation of an agency.

5 (2) "Department" means the department of health.

6 (3) "Director of clinical services" means an individual  
7 responsible for nursing, therapy, nutritional, social, and related  
8 services that support the plan of care provided by in-home health and  
9 hospice agencies.

10 (4) "Family" means individuals who are important to, and  
11 designated by, the patient or client and who need not be relatives.

12 (5) "Home care agency" means a person administering or providing  
13 home care services directly or through a contract arrangement to  
14 individuals in places of temporary or permanent residence. A home  
15 care agency (~~(that provides delegated)~~) where nurses delegate tasks

18 (6) "Home care services" means nonmedical services and assistance

21 not limited to: Personal care such as assistance with dressing,  
22 feeding, and personal hygiene to facilitate self-care; homemaker  
23 assistance with household tasks, such as housekeeping, shopping, meal  
24 planning and preparation, and transportation; respite care assistance  
25 and support provided to the family; or other nonmedical services or

27 (7) "Home health agency" means a person administering or  
28 providing two or more home health services directly or through a  
29 contract arrangement to individuals in places of temporary or  
30 permanent residence. A person administering or providing nursing  
31 services only may elect to be designated a home health agency for

33 (8) "Home health services" means services provided to ill,  
34 disabled, or vulnerable individuals. These services include but are  
35 not limited to nursing services, home health aide services, physical  
36 therapy services, occupational therapy services, speech therapy  
37 services, respiratory therapy services, nutritional services, medical  
38 social services, and home medical supplies or equipment services.

39 (9) "Home health aide services" means services provided by a home

10 (11) "Hospice agency" means a person administering or providing  
11 hospice services directly or through a contract arrangement to  
12 individuals in places of temporary or permanent residence under the  
13 direction of an interdisciplinary team composed of at least a nurse,  
14 social worker, physician, spiritual counselor, and a volunteer.

15 (12) "Hospice care center" means a homelike, noninstitutional  
16 facility where hospice services are provided, and that meets the  
17 requirements for operation under RCW 70.127.280.

18 (13) "Hospice services" means symptom and pain management  
19 provided to a terminally ill individual, and emotional, spiritual,  
20 and bereavement support for the individual and family in a place of  
21 temporary or permanent residence, and may include the provision of  
22 home health and home care services for the terminally ill individual.

23 (14) "Immediate jeopardy" means a situation in which the in-home  
24 services agency's noncompliance with one or more statutory or  
25 regulatory requirements has placed the health and safety of patients  
26 in its care at risk for serious injury, serious harm, serious  
27 impairment, or death.

28 (15) "In-home services agency" means a person licensed to  
29 administer or provide home health, home care, hospice services, or  
30 hospice care center services directly or through a contract  
31 arrangement to individuals in a place of temporary or permanent  
32 residence.

33 (16) "Person" means any individual, business, firm, partnership,  
34 corporation, company, association, joint stock association, public or  
35 private agency or organization, or the legal successor thereof that  
36 employs or contracts with two or more individuals.

37 (17) "Plan of care" means a written document based on assessment  
38 of individual needs that identifies services to meet these needs.

1 (18) "Quality improvement" means reviewing and evaluating  
2 appropriateness and effectiveness of services provided under this  
3 chapter.

4 (19) "Service area" means the geographic area in which the  
5 department has given prior approval to a licensee to provide home  
6 health, hospice, or home care services.

7 (20) "Social worker" means a person with a degree from a social  
8 work educational program accredited and approved as provided in RCW  
9 18.320.010 or who meets qualifications provided in 42 C.F.R. Sec.  
10 418.114 as it existed on January 1, 2012.

11 (21) "Survey" means an inspection conducted by the department to  
12 evaluate and monitor an agency's compliance with this chapter.
