1 AN ACT Relating to the professional engineers' registration act;
2 amending RCW 18.43.030, 18.43.033, 18.43.035, 18.43.040, 18.43.050,
3 18.43.060, 18.43.070, 18.43.080, 18.43.100, 18.43.130, 18.43.150,
4 18.43.170, and 18.43.200; and reenacting and amending RCW 18.43.020.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 **Sec. 1.** RCW 18.43.020 and 2019 c 442 s 8 are each reenacted and
7 amended to read as follows:

8 The definitions in this section apply throughout this chapter
9 unless the context clearly requires otherwise.

10 (1) "Board" means the state board of registration for
11 professional engineers and land surveyors, provided for by this
12 chapter.

13 (2) "Director" means the ~~((executive))~~ director of the Washington
14 state board of registration for professional engineers and land
15 surveyors.

16 (3) ~~((("Engineer" means a professional engineer as defined in this
17 section.~~

18 ~~(4))~~ "Engineer-in-training" means a candidate who: (a) Has
19 satisfied the experience requirements in RCW 18.43.040 for
20 registration; (b) has successfully passed the examination in the

1 fundamental engineering subjects; and (c) is enrolled by the board as
2 an engineer-in-training.

3 ~~((+5))~~ (4) "Engineering" means the "practice of engineering" as
4 defined in this section.

5 ~~((+6) "Land surveyor" means a professional land surveyor.~~

6 ~~+7))~~ (5) "Land-surveyor-in-training" means a candidate who: (a)
7 Has satisfied the experience requirements in RCW 18.43.040 for
8 registration; (b) successfully passes the examination in the
9 fundamental land surveying subjects; and (c) is enrolled by the board
10 as a land-surveyor-in-training.

11 ~~((+8))~~ (6)(a) "Practice of engineering" means any professional
12 service or creative work requiring engineering education, training,
13 and experience and the application of special knowledge of the
14 mathematical, physical, and engineering sciences to such professional
15 services or creative work as consultation, investigation, evaluation,
16 planning, design, and supervision of construction for the purpose of
17 assuring compliance with specifications and design, in connection
18 with any public or private utilities, structures, buildings,
19 machines, equipment, processes, works, or projects.

20 (b) A person shall be construed to practice or offer to practice
21 engineering, within the meaning and intent of this chapter, who
22 practices any branch of the profession of engineering; or who, by
23 verbal claim, sign, advertisement, letterhead, card, or in any other
24 way represents ~~((himself or herself))~~ themselves to be a professional
25 engineer, or through the use of some other title implies that ~~((he or
26 she is))~~ they are a professional engineer; or who holds ~~((himself or
27 herself))~~ themselves out as able to perform, or who does perform, any
28 engineering service or work or any other professional service
29 designated by the practitioner or recognized by educational
30 authorities as engineering.

31 (c) The practice of engineering does not include the work
32 ordinarily performed by persons who operate or maintain machinery or
33 equipment.

34 ~~((+9))~~ (7) "Practice of land surveying" means assuming
35 responsible charge of the surveying of land for the establishment of
36 corners, lines, boundaries, and monuments, the laying out and
37 subdivision of land, the defining and locating of corners, lines,
38 boundaries, and monuments of land after they have been established,
39 the survey of land areas for the purpose of determining the
40 topography thereof, the making of topographical delineations and the

1 preparing of maps and accurate records thereof, when the proper
2 performance of such services requires technical knowledge and skill.

3 ~~((10))~~ (8) "Professional engineer" means a person who, by
4 reason of ~~((his or her))~~ the person's special knowledge of the
5 mathematical and physical sciences and the principles and methods of
6 engineering analysis and design, acquired by professional education
7 and practical experience, is qualified to practice engineering as
8 defined in this section, as attested by ~~((his or her))~~ the person's
9 legal registration as a professional engineer.

10 ~~((11))~~ (9) "Professional land surveyor" means a person who, by
11 reason of ~~((his or her))~~ the person's special knowledge of the
12 mathematical and physical sciences and principles and practices of
13 land surveying, which is acquired by professional education and
14 practical experience, is qualified to practice land surveying and as
15 attested to by ~~((his or her))~~ the person's legal registration as a
16 professional land surveyor.

17 ~~((12))~~ (10) "Significant structures" include:

18 (a) Hazardous facilities, defined as: Structures housing,
19 supporting, or containing sufficient quantities of explosive
20 substances to be of danger to the safety of the public if released;

21 (b) Essential facilities that have a ground area of more than
22 five thousand square feet and are more than twenty feet in mean roof
23 height above average ground level. Essential facilities are defined
24 as:

25 (i) Hospitals and other medical facilities having surgery and
26 emergency treatment areas;

27 (ii) Fire and police stations;

28 (iii) Tanks or other structures containing, housing, or
29 supporting water or fire suppression material or equipment required
30 for the protection of essential or hazardous facilities or special
31 occupancy structures;

32 (iv) Emergency vehicle shelters and garages;

33 (v) Structures and equipment in emergency preparedness centers;

34 (vi) Standby power-generating equipment for essential facilities;

35 (vii) Structures and equipment in government communication
36 centers and other facilities requiring emergency response;

37 (viii) Aviation control towers, air traffic control centers, and
38 emergency aircraft hangars; and

39 (ix) Buildings and other structures having critical national
40 defense functions;

1 (c) Structures exceeding one hundred feet in height above average
2 ground level;

3 (d) Buildings that are customarily occupied by human beings and
4 are five stories or more above average ground level;

5 (e) Bridges having a total span of more than two hundred feet and
6 piers having a surface area greater than ten thousand square feet;
7 and

8 (f) Buildings and other structures where more than three hundred
9 people congregate in one area.

10 **Sec. 2.** RCW 18.43.030 and 2011 c 336 s 481 are each amended to
11 read as follows:

12 A state board of registration for professional engineers and land
13 surveyors is hereby created which shall exercise all of the powers
14 and perform all of the duties conferred upon it by this chapter.
15 (~~After July 9, 1986, the~~) The board shall consist of seven members,
16 who shall be appointed by the governor and shall have the
17 qualifications as hereinafter required. (~~The terms of board members~~
18 ~~in office on June 11, 1986, shall not be affected. The first~~
19 ~~additional member shall be appointed for a four-year term and the~~
20 ~~second additional member shall be appointed for a three-year term.~~)
21 On the expiration of the term of any member, the governor shall
22 appoint a successor for a term of five years to take the place of the
23 member whose term on said board is about to expire. However, no
24 member shall serve more than two consecutive terms on the board. Each
25 member shall hold office until the expiration of the term for which
26 such member is appointed or until a successor qualified as described
27 in this chapter shall have been duly appointed (~~and shall have~~

29 Five members of the board shall be registered professional
30 engineers licensed under the provisions of this chapter. Two members
31 shall be registered professional land surveyors licensed under this
32 chapter. Each of the members of the board shall have been actively
33 engaged in the practice of engineering or land surveying for at least
34 (~~ten~~) 10 years subsequent to registration, five of which shall have
35 been immediately prior to their appointment to the board.

36 Each member of the board shall (~~be a citizen of the United~~
37 ~~States and shall~~) have been a resident of this state for at least
38 five years and practiced in this state for at least five years
39 immediately preceding (~~his or her~~) the member's appointment.

1 Each member of the board shall be compensated in accordance with
2 RCW 43.03.240 and, in addition thereto, shall be reimbursed for
3 travel expenses incurred in carrying out the provisions of this
4 chapter in accordance with RCW 43.03.050 and 43.03.060.

5 The governor may remove any member of the board for misconduct,
6 incompetency, or neglect of duty. Vacancies in the membership of the
7 board shall be filled for the unexpired term by appointment by the
8 governor as hereinabove provided.

9 **Sec. 3.** RCW 18.43.033 and 1997 c 247 s 1 are each amended to
10 read as follows:

11 Upon request of the board, (~~and with approval of the director,~~
12 ~~the board chair shall appoint up to two individuals to serve as pro~~
13 ~~tem members of the board. The appointments are limited, as defined by~~
14 ~~the board chair, for the purpose of participating as a temporary~~
15 ~~member of the board on any combination of one or more committees or~~
16 ~~formal disciplinary hearing panels. An appointed individual must meet~~
17 ~~the same qualifications as a regular member of the board)) the
18 director shall select a candidate for a pro tem board member position
19 and upon approval of the board, the board chair shall make the
20 appointment. Up to three individuals may serve as pro tem board
21 members. A pro tem board member will be participating as a temporary
22 member of the board and perform services as needed and determined by
23 the director, including ensuring sufficient case reviewers, forming a
24 quorum at a board meeting, serving on any combination of one or more
25 committees, or participating as needed at formal disciplinary
26 hearings. An appointed individual must be registered under this

31 same compensation, including travel expenses, in accordance with RCW

33 ~~hundred eighty~~) 180 days unless approved by the director.~~

34 **Sec. 4.** RCW 18.43.035 and 2020 c 47 s 1 are each amended to read
35 as follows:

36 (1) The board may adopt and amend bylaws establishing its
37 organization and method of operation, including but not limited to

1 meetings, maintenance of books and records, publication of reports,
2 code of ethics, and rosters, and adoption and use of a seal.

3 (2) Four members of the board shall constitute a quorum for the
4 conduct of any business of the board.

5 (3) The board shall appoint its director, who must hold a valid
6 Washington license as a professional engineer or professional land
7 surveyor.

8 (4) The board may employ such persons as are necessary to carry
9 out its duties under this chapter.

10 (5) It may adopt rules reasonably necessary to administer the
11 provisions of this chapter. The board shall submit to the governor
12 periodic reports as may be required. A roster, showing the names and

26 (1) PROFESSIONAL ENGINEER. To be licensed as a professional
27 engineer, an applicant must meet the examination and experience
28 requirements delineated in this subsection (1).

29 (a) Examination requirements. An applicant must have received
30 passing scores on examinations required by the board in rule.

31 (b) Experience requirements. A specific record of eight years or
32 more of experience in engineering work of a character satisfactory to
33 the board and (~~indicating~~) showing that the applicant is competent
34 to practice engineering (~~; and successfully passing a written or oral~~
35 ~~examination, or both, in engineering as prescribed by the board.~~

36 ~~(ii) Graduation in an approved engineering curriculum of four~~
37 ~~years or more from a school or college approved by the board as of~~
38 ~~satisfactory standing shall be considered equivalent to four years of~~
39 ~~such required experience. The satisfactory completion of each year of~~

1 such an approved engineering course without graduation shall be
2 considered as equivalent to a year of such required experience.

4 college approved by the board shall be considered as equivalent to
5 two years of such required experience. However, no applicant shall
6 receive credit for more than four years of experience because of

11 branch of professional engineering. To receive a certificate of
12 registration in structural engineering, an applicant must hold a
13 current registration in this state in engineering and have)).

14 (i) The experience must be broad based and progressive to include
15 gaining knowledge and comprehension of engineering subjects and
16 applying engineering principles.

17 (ii) Education or teaching at a college or university may
18 constitute a portion of the required experience as follows:

19 (A) An undergraduate degree, or its equivalent, in an engineering
20 program approved by the board will be considered the equivalent of
21 four years of experience;

22 (B) Satisfactory completion of each year of an engineering
23 program may be considered the equivalent of one year of experience at
24 the discretion of the board;

25 (C) An undergraduate degree in a nonengineering program may be
26 considered the equivalent of engineering experience at the discretion
27 of the board;

28 (D) No more than four years of experience may be granted for
29 undergraduate education; and

30 (E) Experience may be granted for teaching and postgraduate
31 education as further defined by, and at the discretion of, the board.

32 (iii) The mere execution, as a contractor, of work designed by a
33 professional engineer, or the supervision of the construction of such
34 work as a foreman or superintendent may not be deemed to be the
35 practice of engineering.

36 (2) STRUCTURAL ENGINEER. Structural engineering is recognized as
37 a specialized branch of professional engineering. A professional
38 engineer must be registered as a structural engineer to provide
39 structural engineering services for significant structures. To become

1 licensed as a structural engineer, an applicant must meet the
2 following requirements:

3 (a) Hold a current registration as a professional engineer in
4 this state;

5 (b) Have at least two years of structural engineering experience,
6 of a character satisfactory to the board, in addition to the eight
7 years' experience required for registration as a professional
8 engineer (. ~~An applicant for registration as a structural engineer~~
9 ~~must also pass an additional examination as prescribed by the board.~~

10 ~~(iv) An engineer must be registered as a structural engineer in~~
11 ~~order to provide structural engineering services for significant~~
12 ~~structures. The board may waive the requirements of this subsection~~
13 ~~(1)(a)(iv) until December 31, 2010, if:~~

14 ~~(A) On January 1, 2007, the engineer is registered with the board~~
15 ~~as a professional engineer; and~~

16 ~~(B) Within two years of January 1, 2007, the engineer~~
17 ~~demonstrates to the satisfaction of the board that the engineer has~~
18 ~~sufficient experience in the duties typically provided by a~~

4 the board.

5 (ii) Graduation from a school or college approved by the board as
6 of satisfactory standing, including the completion of an approved
7 course in surveying, shall be considered equivalent to four years of
8 the required experience. Postgraduate college courses approved by the
9 board shall be considered for up to one additional year of the
10 required experience.

11 (d) (i) ~~As a land-surveyor-in-training:~~ An applicant for
12 registration as a professional land surveyor shall take the
13 prescribed examination in two stages. The first stage of the
14 examination may be taken upon submission of his or her application
15 for registration as a ~~land-surveyor-in-training~~ and payment of the
16 application fee prescribed in RCW 18.43.050 at any time after the
17 applicant has completed four years of the required land surveying
18 experience, as defined in this section, or has achieved senior
19 standing in a school or college approved by the board. The first
20 stage of the examination shall test the applicant's knowledge of
21 appropriate fundamentals of land surveying subjects, including
22 mathematics and the basic sciences.

23 (ii) At any time after the completion of the required eight years
24 of land surveying experience, as defined in this section, the
25 applicant may take the second stage of the examination upon
26 submission of an application for registration and payment of the
27 application fee prescribed in RCW 18.43.050. This stage of the
28 examination shall test the applicant's ability, upon the basis of
29 greater experience, to apply knowledge and experience in the field of
30 land surveying.

31 (iii) The first stage shall be successfully completed before the
32 second stage may be attempted. Applicants who have been approved by
33 the board to take the examination based on the requirement for six
34 years of experience under this section before July 1, 1996, are
35 eligible to sit for the examination.

36 (2) No person shall be eligible for registration as a
37 professional engineer, ~~engineer-in-training,~~ professional land
38 surveyor, or ~~land-surveyor-in-training,~~ who is not of good character
39 and reputation.

1 ~~(3) Teaching, of a character satisfactory to the board shall be~~
2 ~~considered as experience not in excess of two years for the~~

14 land surveyor, an applicant must meet the examination and experience

16 (a) Examination requirements. An applicant must have received
17 passing scores on examinations required by the board in rule.

18 (b) Experience requirements. A specific record of eight years or
19 more of experience in land surveying work of a character satisfactory
20 to the board and showing that the applicant is competent to practice
21 land surveying.

22 (i) The experience must be broad based and progressive to include
23 gaining knowledge and comprehension of land surveying subjects and
24 applying land surveying principles.

25 (ii) Education or teaching at a college or university may
26 constitute a portion of the required experience as follows:

27 (A) An undergraduate degree, or its equivalent, in a land
28 surveying program approved by the board is considered the equivalent
29 of four years of experience;

30 (B) Satisfactory completion of each year of a land surveying
31 program may be considered the equivalent of one year of experience at
32 the discretion of the board;

33 (C) An undergraduate degree in a nonland surveying program may be
34 considered the equivalent of land surveying experience at the
35 discretion of the board;

36 (D) No more than four years of experience will be granted for
37 undergraduate education; and

39 education as further defined by, and at the discretion of, the board.

1 (4) ENGINEER-IN-TRAINING. An applicant who has completed four
2 years of experience of the type outlined in subsection (1)(b) of this
3 section and has received a passing score on a board-approved
4 examination on the fundamentals of engineering may apply for an
5 engineer-in-training certificate from the board.

6 (5) LAND-SURVEYOR-IN-TRAINING. An applicant who has completed
7 four years of experience of the type outlined in subsection (3)(b) of
8 this section and has received a passing score on a board approved
9 examination on the fundamentals of land surveying may apply for a
10 land-surveyor-in-training certificate from the board.

11 **Sec. 6.** RCW 18.43.050 and 2019 c 442 s 5 are each amended to
12 read as follows:

13 Application for registration shall be on forms prescribed by the
14 board and furnished by the director(~~(, shall contain statements made~~
15 ~~under oath, showing the applicant's education and detail summary of~~
16 ~~his or her technical work and shall contain verification of the~~
17 ~~technical work from professional engineers that supervised the~~
18 ~~applicant's technical work and have personal knowledge of the~~
19 ~~applicant's engineering experience)).~~

20 The registration fee for professional engineers shall be
21 determined by the board, which shall accompany the application and
22 shall include the cost of (~~examination~~) application processing and
23 issuance of certificate. The fee for engineer-in-training shall be
24 determined by the board, which shall accompany the application and
25 shall include the cost of (~~examination~~) application processing and
26 issuance of certificate.

27 The registration fee for professional land surveyors shall be
28 determined by the board, which shall accompany the application and
29 shall include the cost of (~~examination~~) application processing and
30 issuance of certificate. The fee for land-surveyor-in-training shall
31 be determined by the board, which shall accompany the application and
32 shall include the cost of (~~examination~~) application processing and
33 issuance of certificate.

34 All registration fees are nonrefundable. Should the board find an
35 applicant ineligible for registration, the registration fee shall be
36 retained as an application fee.

37 **Sec. 7.** RCW 18.43.060 and 2019 c 442 s 9 are each amended to
38 read as follows:

1 When oral or written examinations are required, they shall be
2 held at such time and place as the board shall determine. If
3 examinations are required on fundamental engineering subjects (such
4 as ordinarily given in college curricula) the applicant shall be
5 permitted to take this part of the professional examination prior to
6 his or her completion of the requisite years of experience in
7 engineering work. The board shall issue to each applicant upon
8 successfully passing the examination in fundamental engineering or
9 land surveying subjects a certificate stating that the applicant has
10 passed the examination in fundamental ~~((engineering))~~ subjects and
11 that ~~((his or her))~~ the applicant's name has been recorded as an
12 engineer-in-training or land-surveyor-in-training.

13 The scope of the examination and the methods of procedure shall
14 be prescribed by the board with special reference to the applicant's
15 ability to design and supervise engineering works ~~((so as to insure))~~
16 to ensure the safety of life, health, and property. Examinations
17 shall be given for the purpose of determining the qualifications of
18 applicants for registration separately in engineering and in land
19 surveying. ~~((A candidate failing an examination may apply for~~
20 ~~reexamination. Subsequent examinations will be granted upon payment~~
21 ~~of a fee to be determined by the board.))~~

22 **Sec. 8.** RCW 18.43.070 and 2019 c 442 s 10 are each amended to
23 read as follows:

24 The board shall issue a certificate of registration upon payment
25 of a registration fee as provided for in this chapter, to any
26 applicant who, in the opinion of the board, has satisfactorily met
27 all the requirements of this chapter. In case of a registered
28 professional engineer, the certificate shall authorize the practice
29 of "professional engineering" and specify the branch or branches in
30 which specialized, and in case of a registered professional land
31 surveyor, the certificate shall authorize the practice of "land
32 surveying."

33 In case of engineer-in-training, the certificate shall state that
34 the applicant has successfully passed the examination in fundamental
35 engineering subjects required by the board and has been enrolled as
36 an "engineer-in-training." In case of land-surveyor-in-training, the
37 certificate shall state that the applicant has successfully passed
38 the examination in fundamental surveying subjects required by the
