Properly licensed pesticide applicators who have obtained coverage under the WSDA National Pollutant Discharge Elimination System Waste Discharge General Permit may apply glyphosate or imazapyr to control the noxious weed *Spartina* on the saltwater tidflats of Grays Harbor, Hood Canal, Willapa Bay, Puget Sound, and the north and west sides of the Olympic Peninsula.

MANAGEMENT POLICY**

The water quality program of the department of ecology (ecology) is seeking public comment on two draft policies. Program Policy 1-11, Chapter 1, *Assessment of Water Quality for the Clean Water Act Sections 303(d) and 305(b) Integrated Report* has been redrafted. Ecology is also seeking public comment on a new draft Chapter 2 to Program Policy 1-11, *Ensuring Credible Data for Water Quality Management*.

Program Policy 1-11, Chapter 1, Assessment of Water Quality for the Clean Water Act Sections 303(d) and 305(b) Integrated Report: The policy that guides the assessment process for state surface waters is undergoing revision. The purpose of the assessment is to determine the status of state water quality based on water quality standards criteria and available data. The state is required under Section 303(d) of the federal Clean Water Act (CWA) and the implementing regulations (40 C.F.R. 130.7) to periodically prepare a list of waters in which designated uses are impaired, as determined through the use of the water quality standards. The state is also directed to periodically submit other information in accordance with Section 305(b) of the CWA. Ecology is now beginning the process to prepare the 2006 list.

This policy describes how the standards are applied, requirements for the data used, and how to prioritize total maximum daily loads (TMDLs), among other issues.

Significant changes in the updated policy since 2002 include:

- Incorporate changes in data quality assurance requirements for data submission as a result of the *Water Quality Data Act* (WQDA) of 2004.

- Pollutant specific assessment and categorization procedures.
- Additional requirements for the amount of data necessary to place a parameter/segment combination in Category 1 (clean water).
- The environmental information management database will be used to manage most water quality data.

Program Policy 1-11, Chapter 2, Ensuring Credible Data for Water Quality Management: Ecology was directed to develop policy regarding the generation and use of credible data in certain water quality-related actions. This policy is required by the WQDA codified in RCW 90.48.570 through 90.48.590. The actions that require the use of credible data include the water quality assessment and TMDL calculations. Credible information and literature is used for revising water quality standards and developing water quality models. The primary basis of the draft policy is that credible data is generated through documentation of implementation of a quality assurance project plan. The plans have been a requirement for monitoring projects conducted by ecology staff and grant and loan recipients. Data used in the latest water quality assessment in 2002/2004 was also required to be collected under such plans.

Ecology will host public workshops in six cities across Washington to discuss the draft updated water quality assessment policy and the new credible data policy. Ecology staff will explain the draft policies and the public will have an opportunity to ask questions and share their thoughts with ecology staff and other participants. Participants should also formally submit any comments they have in writing.

NURSING FACILITY MEDICAID PAYMENT RATE METHODOLOGY**

The 2006 state legislature has passed changes to the method for determining facility-specific, per resident day Medicaid payment rates for nursing facility care in Washington. Unless otherwise indicated the changes are effective July 1, 2006. This notice includes a justification, description, and estimated rate impact of the changes.

JUSTIFICATION

The changes are mandated by the 2006 Washington state legislature in chapter 258, Laws of 2006, and in section 206, chapter 372, Laws of 2006, the state Operating Budget Appropriations Act.

**NEW RATES AND PROPOSED CHANGES
TO RATE METHODOLOGY**

In combination with a variety of other factors, including changes in the allowed costs of care, the methodological changes are estimated to result in a statewide average nursing facility Medicaid payment rate of \$147.57 per resident day, at a maximum, for state fiscal year 2006, running from July 1, 2005, to June 30, 2006, and \$156.41 for state fiscal year 2007, running from July 1, 2006, to June 30, 2007.

Chapter 258, Laws of 2006, makes several changes in the Medicaid nursing facility rate methodology, including:

(1) A "rebasin" of costs used to calculate the direct care and operations component rates to the 2003 cost report;

(2) Elimination of the minimum occupancy assumption in the calculation of the direct care component;

(3) Elimination of the minimum occupancy assumption in the calculation of the direct care component rate for nursing facilities returning previously "banked" beds to active status;

(4) A "freezing" of the variable return rate component for all facilities at the June 30, 2006, variable return rate allocation;

(5) Revision of case mix weights whenever direct care component rates are cost-rebased under RCW 74.46.431(4);

(6) Use of the 90% threshold for calculation of the quarterly case mix index; use of the facility average case mix index throughout the cost-rebasing period; and use of the average facility average case mix index from the four calendar quarters of the cost rebase year;

(7) A rise in the "lid" for the cost per case mix unit used in the calculation of the direct care component rate, from 110% to 112% of the peer group median; and elimination of the "floor" for the cost per case mix unit used in the calculation of the direct care component rate;

(8) Clarification that the 90% minimum occupancy threshold is to be used in calculation of the operations component median "lid";

(9) Creation of a new category of nursing facility to be known as a "vital local provider," defined as a nursing facility reporting a home office address located in Washington state, where the sum of Medicaid days for all Washington facilities reporting that address as their home office was greater than 215,000 in 2003; and

(10) Granting a "hold harmless" provision to vital local providers. For a vital local provider, the sum of the facility's direct care and operations component rates calculated as of July 1, 2006 (the effective date of chapter 258, Laws of 2006) will be compared to the sum of those same two component rates as of June 30, 2006 (the last day under chapter 74.46 RCW as it existed before the new law). If the sum as of July 1, 2006, is lower than the sum as of June 30, 2006, then the vital local provider will continue to receive the direct care and operations component rate allocations calculated as of June 30, 2006. In setting economic trends and conditions adjustment factors (sometimes called vendor rate increases) for the direct care and operations components rate allocations, the legislature may define different adjustment factors for vital local providers whose rates are set equal to their June 30, 2006, rates.
