**ISSUANCE OF INTERPRETIVE STATEMENT**

The department of revenue has issued Excise Tax Advisory 2036.29A. Computing Leasehold Excise Tax at Public Marinas (ETA 2036).

The leasehold excise tax (LET) is imposed on private interests in publicly owned real or personal property. The LET is "in lieu" of the property tax and intended to provide equity in taxation of all property. This advisory provides public marinas with an acceptable formula to compute the amount of LET the marinas as lessors are required to collect from lessees. This formula uses a square footage formula in conjunction with rental rates in calculating the LET due.

**Reviser's note:** The following material has *not* been adopted under the Administrative Procedure Act, chapter 34.05 RCW, but has been filed in the office of the code reviser and is published in the Register exactly as filed.

AMENDATORY SECTION (Amending WSR 95-15-044, filed 7/13/95, effective 8/15/95)

**WAC 137-28-210 Hearing officers.** (1) Each hearing shall be conducted by a hearing officer(s) within the rank/classification of lieutenant or above, or corrections specialist, designated by the superintendent.

(2) The hearing officer(s) will receive training in the disciplinary process and in the identification of inmates who

may be impaired in their ability to understand the hearing process and participate in their own defense.

(3) Hearing officers may not function in that capacity when they have direct personal involvement in the infraction under consideration. Such officers must disqualify themselves by giving notice to the superintendent, who will select a replacement.

(4) Direct personal involvement as that phrase is used in this section shall mean knowledge or interest acquired through witnessing or directly participating in the incident under consideration. This rule shall not preclude hearing officer participation where the hearing officer has acquired knowledge or interest indirectly or through review of the incident conducted as part of regular institutional responsibilities.

(5) Hearing officers may disqualify themselves or may be disqualified by the superintendent if actually biased for or against any inmate so that they cannot render a fair judgment in the hearing.

(6) Hearing officers must notify an infracted inmate if they are related to the infracting officer or the victim. The inmate may request another hearing officer or continue with the same hearing officer.

#### Announcing permit issuance of the Municipal Stormwater Phase I General Permit

On December 20, 2006, the department of ecology (ecology) is issuing a general permit to cover municipal stormwater. The title of the permit is "National Pollutant Discharge Elimination System and State Waste Discharge General Permit for Discharges from Large and Medium Municipal Separate Stormwater Sewers." The permit is also referred to as the "Phase I Municipal Stormwater Permit," or the "Phase I Permit." This final Phase I municipal stormwater permit becomes effective on January 19, 2007.

**What is being regulated by this permit and who is affected?** The Phase I Permit regulates discharges to waters of the state from large and medium municipal separate storm sewers.

A municipal separate storm sewer system (MS4) is a conveyance or system of conveyances including roads with drainage systems, municipal streets, catch basins, curbs, gutters, ditches, man-made channels, and/or storm drains which is:

1. Owned or operated by a city, town, county, district, association, or other public body created pursuant to state law having jurisdiction over disposal of sewage, industrial wastes, stormwater, or other wastes, including special districts under state law such as sewer districts, flood control districts or drainage districts, or similar entity.

2. Designed or used for collecting or conveying stormwater.

3. Not a combined sewer system.

4. Not part of a publicly owned treatment works (POTW) (see 40 C.F.R. 122.2).

This Phase I municipal stormwater permit applies to the cities of Seattle and Tacoma and the unincorporated areas of Clark, King, Pierce, and Snohomish counties. This permit will also apply to special purpose districts located within those jurisdictions including the ports of Tacoma and Seattle.

A special purpose district is subject to this permit if the district's stormdrain system:

1. Is a public entity.

2. Is located within or partially within the cities of Seattle or Tacoma or the unincorporated area of Clark, King, Pierce, and Snohomish counties.

3. Owns or operates a stormdrain system that discharges to surface waters.

Special purpose districts that could be subject to this permit include public ports (including the ports of Tacoma and Seattle), irrigation districts, diking and drainage districts, flood control districts, public schools, public universities, and state agencies. Ecology will regulate special purpose districts subject to this permit as secondary permittees.

This permit will not apply to municipal separate storm sewers systems owned or operated by the Washington state department of transportation (WSDOT). MS4s owned or operated by the WSDOT remain covered under the 1995 Phase I municipal stormwater general permits. Ecology will be issuing a separate permit to cover WSDOT.

**Purpose of the permit:** Federal and state water quality laws require a permit for the discharge of stormwater (see Federal Water Pollution Control Act Title 22 United States Code, Section 1251 et seq., state Water Pollution Control Act, chapter 90.48 RCW and Washington waste discharge general permit regulation WAC 173-226-130). The permit addresses these legal requirements and controls the discharge of pollutants to protect surface water and ground water quality in Washington state.

The Phase I permit requires municipalities and secondary permittees covered by the permit to develop and implement a stormwater management program to control stormwater runoff into and from their storm sewer system. The goals of the stormwater management program are to:

- Reduce the discharge of pollutants to the "maximum extent practicable."
- Protect water quality.
- Satisfy appropriate requirements of the Clean Water Act.

**How to apply for the NPDES MS4 permit:** Appendix 5 of the permit contains the forms, instructions and sample public notice information. If you want to apply for coverage under the Phase I municipal stormwater permit, complete these three basic steps:

1. Completely fill out the notice of intent.
2. Send a complete notice of intent to Department of Ecology, Water Quality Program, Municipal Stormwater Permits, P.O. Box 47696, Olympia, WA 98504-7696.
3. Publish a notice at least once a week for two consecutive weeks in a single newspaper of general circulation in the county or city in which your district is located.

Operators of **regulated MS4s** who fail to submit an NOI by January 19, 2007, could be in violation of the Clean Water Act for discharging without a permit.

**Changes from the draft to the final general permit:** Ecology made numerous changes to improve clarity and readability of the permit. The following are some of the more significant changes made between the draft and final permit:

- In the final permit, ecology revised Special Condition S4 *Compliance with Standards* and added a procedure that permittees must follow if ecology determines that the permittee is causing or contributing to a violation of state water quality standards.
- The final permit contains revised exceptions and variance criteria in Appendix 1. The permittees may use the criteria to determine exceptions and variances to the minimum requirements for new development and redevelopment.
- The deadline for adopting ordinances and implementing the new permit requirements to control stormwater runoff from new development, redevelopment, and construction sites was extended in the final permit from twelve months to eighteen months from the effective date of the permit.
- Ecology simplified record-keeping and cost-accounting requirements in the final permit.

**Appeal Process:** The permit may be appealed within thirty days. Pursuant to chapter 43.21B RCW, appeals must be filed with the pollution control hearings board and served on the department of ecology within thirty days of receipt of the permit.

Phase II Municipal Stormwater Permit for Western  
Washington**

On December 20, 2006, the department of ecology (ecology) is issuing a general permit to cover municipal separate storm systems. The title of the final permit is "National Pollutant Discharge Elimination System (NPDES) and State Waste Discharge General Permit for Discharges from Small Municipal Separate Stormwater Sewers in Western Washington." The permit is also referred to as the "Phase II Municipal Stormwater Permit for Western Washington." This final Phase II municipal stormwater permit for western Washington becomes effective on January 19, 2007.

**What is being regulated by this permit and who is affected?** In December 1999, the federal Environmental Protection Agency (EPA) published the Phase II municipal stormwater regulations. These regulations went into effect in March 2003. This permit regulates discharges from small municipal separate storm sewer systems located in western Washington pursuant to EPA regulations and Washington state water pollution control law.

A municipal separate storm sewer system (MS4) is a conveyance or system of conveyances including roads with drainage systems, municipal streets, catch basins, curbs, gutters, ditches, man-made channels and/or storm drains which is:

1. Owned or operated by a city, town, county, district, association, or other public body created pursuant to state law having jurisdiction over disposal of sewage, industrial wastes, stormwater, or other wastes, including special districts under state law such as sewer districts, flood control districts or drainage districts, or similar entity;
2. Designed or used for collecting or conveying stormwater;
3. Not a combined sewer system; and
4. Not part of a publicly owned treatment works (POTW) (see 40 C.F.R. 122.2).

Under EPA rules, entities that need a permit:

- Own or operate a MS4 that discharges to surface waters; and
- Are located in urbanized areas as defined by the United States Census Bureau; and
- Serve a population of more than 1,000.

Cities and Towns: Aberdeen, Algona, Anacortes, Arlington, Auburn, Bainbridge Island, Battle Ground, Bellevue, Bellingham, Black Diamond, Bonney Lake, Bothell,

Bremerton, Brier, Buckley, Burien, Burlington, Camas, Centralia, Clyde Hill, Covington, Des Moines, DuPont, Duvall, Edgewood, Edmonds, Enumclaw, Everett, Federal Way, Ferndale, Fife, Fircrest, Gig Harbor, Granite Falls, Issaquah, Kelso, Kenmore, Kent, Kirkland, Lacey, Lake Forest Park, Lake Stevens, Lakewood, Longview, Lynnwood, Maple Valley, Marysville, Medina, Mercer Island, Mill Creek, Milton, Monroe, Mountlake Terrace, Mount Vernon, Mukilteo, Newcastle, Normandy Park, Oak Harbor, Olympia, Orting, Pacific, Port Orchard, Port Angeles, Poulsbo, Puyallup, Redmond, Renton, Sammamish, SeaTac, Sedro-Woolley, Shoreline, Snohomish, Steilacoom, Sumner, Tukwila, Tumwater, University Place, Vancouver, Washougal, Woodinville, and Yarrow Point.

**Counties:** Cowlitz, Kitsap, Thurston, Skagit, and Whatcom.

In addition, the EPA rules also require permit coverage for special purpose districts operating a regulated MS4 within census defined urban areas. A special purpose district is subject to this permit if the district's stormdrain system:

1. Is publically owned.
2. Is located within or partially within a census defined urban area of western Washington.
3. Discharges to surface waters.
4. Serves more than 1,000 people, including resident and commuter population.

Special purpose districts that could be subject to this permit include public ports, irrigation districts, diking and drainage districts, flood control districts, public schools, public universities, and state agencies. Ecology will regulate special purpose districts subject to this permit as secondary permittees. Secondary permittees will generally have reduced permit requirements.

This permit will not apply to the Washington state department of transportation, which ecology will cover under a separate permit.

**Purpose of the general permit:** The general permit covers stormwater discharges from municipally owned or operated storm sewer systems in certain urbanized areas of western Washington. Federal and state water quality laws require a permit for the discharge of stormwater (Federal Water Pollution Control Act Title 22 United States Code, Section 1251 et seq., State Water Pollution Control Act, chapter 90.48 RCW). The permit addresses these legal requirements and requires the public entities covered by the permit to control the discharge of pollutants to protect surface water and ground water quality in Washington state.

The general permit will require municipalities and other entities covered by the permit to develop and implement a stormwater management program. A stormwater management program contains the following minimum elements:

1. Public education and outreach,
2. Public involvement and participation,
3. Illicit discharge detection and elimination,
4. Controlling runoff from new development, redevelopment and construction sites, and
5. Pollution prevention and good housekeeping.

The stormwater management program includes requirements for controlling pollution in stormwater from areas of existing development, as well as in areas of expected future

growth. In addition, the proposed permit requires programs to address approved total maximum daily loads (TMDLs) or water cleanup plan requirements, and to evaluate the program itself.

1. Completely fill out the notice of intent.
2. Send a complete notice of intent to Department of Ecology, Water Quality Program, Municipal Stormwater Permits, P.O. Box 47696, Olympia, WA 98504-7696.
3. Publish a notice at least once a week for two consecutive weeks in a single newspaper of general circulation in the county or city in which your district is located.

Operators of **regulated MS4s** who fail to submit an NOI by January 19, 2007, could be in violation of the Clean Water Act for discharging without a permit.

**Changes from the draft to the final general permit:** Ecology made numerous changes to improve clarity and readability of the permit. The following are some of the more significant changes made between the draft and final permit:

- The final permit does not authorize the relaxation of thresholds that are less protective of the environment than those currently in effect by the permittee. Permittees may not repeal existing local requirements to control stormwater that go beyond the requirements of the final permit. Specifically, if a local government is currently regulating stormwater runoff at sites that are less than 1 acre they must continue to do so.
- In the final permit, ecology revised Special Condition S4 *Compliance with Standards* and added a procedure that permittees must follow if ecology determines that the permittee is causing or contributing to a violation of state water quality standards.
- The final permit contains revised exceptions and variance criteria in Appendix 1. The permittees may use the criteria to determine exceptions and variances to the minimum requirements for new development and redevelopment.
- The deadline for adopting ordinances and implementing programs to control stormwater runoff from new development, redevelopment, and construction sites was extended in the final permit from twenty-four



months to thirty months from the effective date of the permit.

- Ecology simplified record-keeping and cost-accounting requirements in the final permit.

**Appeal Process:** The permit may be appealed within thirty days. Pursuant to chapter 43.21B RCW, appeals must be filed with the pollution control hearings board and served on the department of ecology within thirty days of receipt of the permit.

In addition, EPA rules also require permit coverage for special purpose districts operating a regulated MS4 within census defined urban areas. A special purpose district is subject to this permit if the district's stormdrain system:

1. Is publically owned.
2. Is located within or partially within a census defined urban area of western Washington.
3. Discharges to surface waters.
4. Serves more than 1,000 people, including resident and commuter population.

Special purpose districts that could be subject to this permit include public ports, irrigation districts, diking and drainage districts, flood control districts, public schools, public universities, and state agencies. Ecology will regulate special purpose districts subject to this permit as secondary permittees.

 State Implementation Plan

The state of Washington and local air pollution control agencies periodically submit air quality regulations to the department of ecology (ecology) for inclusion in Washington's state implementation plan (SIP). The SIP is a statewide plan for meeting federal health-based standards for certain air pollutants.

Ecology will hold a public hearing to:

- Receive comments on including changes to several permitting regulations for new and modified air pollution sources in the SIP; and
- Provide for additional clarifications and administrative updates.

The proposed changes are necessary for consistency of local, state and federal air quality rules for stationary sources. They also clarify requirements for existing and new stationary sources of air pollution by eliminating conflicts with chapter 70.94 RCW and 40 C.F.R. Part 51. When incorporated into the SIP, the rules reduce the number of duplicated state and local regulations.

At the hearing, ecology will receive comments on amending the following local air quality agency and energy facility site evaluation council (EFSEC) regulations in the SIP:

Energy Facility Site Evaluation Council:

Amend: WAC 463-78-005, 463-78-030, and 463-78-100.

Add: WAC 463-78-140.

Northwest Clean Air Agency:

Amend: Sections 200, 300, 301, and 325.

Add: Section 305.

Olympic Regional Clean Air Agency:

Recodification: Various.

Puget Sound Clean Air Agency:

Amend: Regulation 1, Sections 3.07, 3.11, 3.25, 5.03, 6.01 and 6.03.

Spokane County Air Pollution Control Authority:

Amend: Regulation I, Article II, Section 2.13.

There are seven local air quality agencies in Washington state: Benton Clean Air Authority, Northwest Clean Air Agency, Olympic Regional Clean Air Agency, Puget Sound Clean Air Agency, Southwest Clean Air Agency, Spokane County Air Pollution Control Authority, and Yakima Regional Clean Air Authority. Additionally, EFSEC is a state agency with authority from the United States Environmental Protection Agency and the state of Washington to issue permits under the federal Clean Air Act and Washington Clean Air Act for facilities under its jurisdiction.

State Implementation Plan Revision:  
Interstate Transport  
of Ozone and Fine Particulate Matter

The department of ecology (ecology) developed this revision to the Washington state implementation plan (SIP) to meet requirements of the Clean Air Act regarding interstate transport of ozone (O<sub>3</sub>) and fine particulate matter (PM<sub>2.5</sub>). On July 18, 1997, EPA promulgated revised National Ambient Air Quality Standards (standards) for O<sub>3</sub> and new standards for PM<sub>2.5</sub>. When EPA adopts a new or revised air quality standard, the Clean Air Act requires states to prepare a SIP, which is a statewide plan for meeting federal standards. This SIP must prohibit air pollutants in amounts that will contribute significantly to nonattainment of standards, or interfere with maintenance of the standards, in another state. It must also prohibit air pollutants in amounts that will interfere with measures in another state's SIP to prevent significant deterioration of air quality or protect visibility.
