Dear Mr. Worthington:

This letter is in response to your petition for rulemaking, which was initially filed with the Board of Pharmacy (Board) on October 29, 2007. The Board considered your petition during its business meeting on December 13, 2007, and issued its written denial on December 28, 2007. On January 26, 2008, you then petitioned that denial to the Governor's Office under RCW 34.05.330. After careful consideration of your petition and the Board's denial, I am denying your petition.

I support efforts to implement Initiative 692—as intended by the voters in 1998, and ESSB 6032—as intended by the Legislature in 2007, to allow for limited medical marijuana use by patients with terminal or debilitating illnesses. I also recognize that organizations, including the Institute of Medicine, note both the potential therapeutic value and potential risk factors of medical marijuana. As a result, it is therefore important to address patient needs while simultaneously ensuring patient safety. The Board in denying your petition arrived at the same well-reasoned conclusion.

With that in mind, I am denying your petition to allow for the completion of actions required by the passage of ESSB 6032. Your petition is principally concerned with local law enforcement agencies' implementation and interpretation of the state's medical marijuana law. ESSB 6032 was intended to address these issues by outlining appropriate actions for law

enforcement as it relates to medical marijuana and by requiring the Department of Health (DOH) to define in rule an appropriate 60-day supply of medical marijuana. DOH is in the process of finalizing its rule and is expected to issue a report in July 2008. I therefore believe this to be a more appropriate next step, one which is consistent with the Legislature's intent, to addressing your concern regarding law enforcement.

EXECUTIVE ORDER 05-02

GOVERNMENT MANAGEMENT, ACCOUNTABILITY AND PERFORMANCE (GMAP)

WHEREAS, the citizens of Washington hold their government accountable for results; and

WHEREAS, they want good value for their tax dollars; and

WHEREAS, they want their government to focus on the priorities that are important to the public, and in pursuing those priorities, they want their government to be effective and efficient; and

WHEREAS, government leaders must demonstrate successful performance in clear, measurable terms; and

WHEREAS, Washington State has made progress by aligning government spending to citizen priorities in the Priorities of Government process and using performance management to improve the quality and cost effectiveness of services in some agencies;

NOW, THEREFORE, I, Christine Gregoire, Governor of the state of Washington, hereby order and direct agencies to take the next steps to build public confidence in government by adopting a comprehensive government management, accountability and performance system (GMAP).

GMAP will give the public a clear, concise view of how government programs are working and whether citizens are receiving value for their dollars. GMAP will give citizens a way to judge the effectiveness of government programs. GMAP will allow agency leaders to shine a spotlight on problems and make decisions with greater clarity and accuracy. At the same time, it will give agency managers new tools to solve problems and improve services.

GMAP calls upon the Governor and other agency leaders to:

- Take personal responsibility and hold the agency and its management accountable for results;
- Use strategies that work, and make corrections when they don't:
- 3. Base decisions not on guesswork or preference but on accurate, up-to-date information;
- 4. Make decisions timely;
- 5. Follow up to make sure there's implementation after a decision has been made;
- 6. Take risks and learn from mistakes; and
- 7. Communicate clearly to citizens about results.

GMAP will require each agency to:

- 1. Develop clear, relevant and easy-to-understand measures that show whether or not programs are successful;
- 2. Demonstrate how programs contribute to the priorities that are important to citizens;
- 3. Gather, monitor, and analyze program data;
- 4. Evaluate the effectiveness of programs:

- 5. Hold regular problem-solving sessions within the agency to improve performance;
- 6. Allocate resources based on strategies that work;
- Regularly report to the Governor on their perfor-7. mance.

The Governor's Office of Management Accountability and Performance will lead the effort to implement GMAP and will prepare more detailed guidance on implementing the intent of this executive order. The Department of Personnel will work with the GMAP Office to develop and deliver training to support GMAP. The Department of Information Services will assist in developing the tools and technology needed by agencies to implement GMAP. Everyone from agency managers to front-line employees will work creatively and cooperatively within and across agencies to improve government service.

The Governor will issue regular reports to the public that reflect the principles of GMAP. Each report will include a realistic assessment of government performance, including both successes and failures. These reports will be clear and easy to read, and they will focus on what is most important to citizens.

This executive order supersedes the reporting requirements specified in Executive Order 97-03.

This executive order shall take effect immediately.

As provided in the Act, the Governor will then recommend the final design to the Secretary of the Treasury for final approval;

NOW, THEREFORE, I, Christine O. Gregoire, Governor of the state of Washington, hereby order that the Washington State Quarter Advisory Commission is hereby established. The Commission shall develop the narrative design concepts to be presented to the United States Mint and shall make recommendations to the Governor regarding the final design of the Washington State quarter.

The Commission shall consist of the following members:

Mike Gregoire, First Gentleman, Honorary Chair

Kris Tucker, Executive Director, State Arts Commission, Administrative Chair

Michael J. Murphy, State Treasurer (or designee)

Dr. Terry Bergeson, State Superintendent of Public Instruction (or designee)

President, Washington State Historical Society (or designee)

Two Members of the Senate (determined by each Caucus)

Two Members of the House (determined by each Caucus)

Member of the American Numismatic Association (determined by the Association)

Nine Citizens at large (determined by the Governor and representing the geographic, demographic and artistic diversity of the state)

Each member of the Commission shall remain a member until the final design of the Washington quarter has been publicly announced. If a member is unable to serve, the Chair shall appoint a replacement.

The Commission shall adopt a procedure for the solicitation, review and consideration of all narrative design concepts received by the Commission. The Commission's procedures shall be consistent with the requirements of the 50 States Commemorative Coin Act. In addition, the Commission is to review and consider graphic designs that were submitted before the creation of the Commission. By September 2005, the Commission shall submit three to five narrative concepts for the Washington quarter to the Governor.

When the United States Mint provides the state with its final design renderings of the narrative concepts, the Commission will provide an opportunity for public comment and voting on a people's choice. The Commission shall make a final selection recommendation to the Governor. The Governor shall have final approval of the design submitted to the United States Mint.

This executive order takes effect immediately and shall expire when the quarter is publicly unveiled in Washington State.

EXECUTIVE ORDER 05-05

ARCHEOLOGICAL AND CULTURAL RESOURCES

WHEREAS Washington has a rich and diverse cultural heritage, as represented by the numerous archaeological and historic sites that have been identified and located throughout our state; and

WHEREAS preservation and protection of these sites provides educational and cultural values for all citizens and leads to better understanding between cultures of our shared history; and

WHEREAS many citizens of Washington contribute their time and efforts to preserve and protect Washington's unique

archaeological and historic sites, and traditional cultural places; and

WHEREAS these sites and places hold special cultural, historical, and spiritual significance for both tribal members and citizens of Washington; and

WHEREAS the Department of Archaeology and Historic Preservation (DAHP) and the Governor's Office of Indian Affairs (GOIA) have key statewide responsibility to enhance the public's awareness of the need and value of protecting Washington's heritage and establish effective consultation with Native American tribal governments.

NOW, THEREFORE, I, Christine O. Gregoire, Governor of the state of Washington, hereby order all state agencies to:

- Review capital construction projects and land acquisitions for the purpose of a capital construction project, not undergoing Section 106 review under the National Historic Preservation Act of 1966 (Section 106), with the DAHP and affected Tribes to determine potential impacts to cultural resources. This review shall be required on all capital construction projects unless they are categorically exempted by DAHP. Cultural resources are defined as archeological and historical sites and artifacts, and traditional areas or items of religious, ceremonial and social uses to affected tribes. This review should be done as early in the project planning process as possible. Should DAHP identify a known culturally significant site in the area of a project, or should DAHP inform the agency of the potential that such a significant site is likely to be found in a project locale, the agency shall:
 - A. Work with DAHP and affected Tribes on appropriate archaeological survey and mitigation strategies consistent with state and federal laws.
 - B. Consult with affected Tribes in a way that includes a face-to-face meeting or other agreed upon method to discuss the project before a state agency completes the project design. The agency will work with GOIA and DAHP to identify affected tribes and, if needed, seek their help to arrange a meeting to discuss the project in question. If an agency is unable to arrange such a meeting, it will promptly notify GOIA and DAHP of the situation.
 - C. Take reasonable action to avoid, minimize or mitigate adverse effects to the archeological or cultural resource.
 - D. Notify DAHP and GOIA, in advance, of any meeting with affected Tribes during which matters concerning cultural resources related to a capital construction project will be discussed, and extend invitations to both agencies to attend any such meetings. If representatives from DAHP or GOIA cannot attend, the agencies will

provide DAHP and GOIA with detailed meeting notes.

- Submit all agreements between state agencies and affected Tribes concerning cultural resources that are developed outside the Section 106 process for review and comment to DAHP. DAHP's review and comment on any such agreement must occur before the agency can sign such agreement. Consult with DAHP and affected Tribes during project design and prior to construction on projects not undergoing Section 106 review, as a condition to receiving state grants or loans for the purposes of a capital construction project. Should either DAHP or the affected Tribes identify cultural resources affected by the proposed project, the state agency or agencies will ensure that the grant recipient finds reasonable ways to avoid, minimize or mitigate impacts to the resource before state funding is disbursed. State agencies shall take steps to insure that this type of review is incorporated into their grant and loan management process.
- 3. The Office of Financial Management is directed to include in its capital budget instruction a requirement that agencies consult with DAHP and GOIA, as appropriate, as part of the budgeting process for pre-design, design and construction.
- 4. To the extent that they have not already received training, all appropriate state agency employees managing capital construction projects or pass through capital grants will attend Government-to-Government training and Cultural Resource training provided by GOIA and DAHP.
- By January 15, 2007, DAHP shall report back to the Governor's Office and the Office of Financial Management on the implementation of this executive order including any recommendations on ways of improving implementation.

I invite institutions of higher education, public schools, statewide elected officials, boards, commissions, and others to implement the practices herein described within their agencies.

This executive order takes effect immediately.

EXECUTIVE ORDER 06-01

Superseding Executive Order 89-09 Reaffirming The Interagency Committee of State Employed Women

WHEREAS it has been the policy of state government to provide equal opportunities to all employees in state government.

Women employed in state government have unique and special issues with working conditions and accessing employment and leadership opportunities.

The Interagency Committee of State Employed Women ("Committee") has provided leadership, mentoring and networking opportunities for women in state government and has identified the continuing needs of state employed women.

It is good public policy to enhance the opportunities that allow women to fully participate in the workforce of state government.

Executive Order 89-09 established the Committee and contained certain restrictions that limit the participation of women in certain small agencies in the work of the Committee.

I reaffirm my support of the Interagency Committee of State Employed Women, and recognize the need for greater representation of women in state government.

NOW, THEREFORE, I, Christine O. Gregoire, Governor of Washington State, by virtue of the authority vested in me, do hereby supersede Executive Order 89-09 with this Executive Order and reaffirm the establishment of and need for the Interagency Committee of State Employed Women.

A. DUTIES

- The Committee shall examine and define issues pertaining to the rights and needs of women employed in state government and make policy recommendations to the Governor and state agencies with respect to desirable changes in program and law especially in the area of education, training, career development, and other conditions of employment.
- 2. The Committee shall also advise state agencies on the development and implementation of comprehensive and coordinated policies, plans and programs focusing on the special issues and needs of women in state government.
- 3. Each state department or agency shall provide appropriate and reasonable resources to the Committee as needed in order that the Committee may carry out the purposes of this Executive Order. Appropriate and reasonable resources shall include but not be limited to each department or agency designating at least one person to serve on

the Committee as its representative; granting that representative reasonable accommodation to attend Committee meetings and events; providing, as necessary and available, office supplies, distribution capabilities, and meeting facilities for Committee work.

4. A simple majority of the Committee members shall constitute a quorum for the purpose of conducting business.

B. COMMITTEE MEMBERSHIP

- 1. Membership shall consist of a diverse group of state department and agency representatives with a maximum number of 60 members.
- Persons appointed to serve on the Committee shall serve two-year terms, except in the case of a vacancy in which event appointment shall be for the remainder of the unexpired term for which the vacancy occurs.
- The reasonable expenses incurred by a person designated by a department or agency as its representative to the Committee shall be borne by that representative's employing department or agency.
- 4. The Chair of the Committee shall be appointed by the Governor and serve at the Governor's pleasure. Committee meetings shall be at the call of the Chair or a majority of the members of the Committee.

C. STAFF

- 1. The Governor's Office shall designate one of the Governor's Executive Policy Advisors as its Committee liaison and staff person.
- 2. The Committee shall have the authority to receive such gifts, grants and endowments from public or private sources as may be made from time to time or otherwise for the use and benefit or the purposes of the Committee and to expend the same, including any income generated from them according to the terms of those gifts, grants or endowments.

REGULATORY IMPROVEMENT Improve, Simplify and Assist

WHEREAS, this Administration wants to make it easy to do business in the state of Washington; and

Citizens and businesses deserve state agencies that will be innovative and creative in simplifying their procedures for permits, licenses, regulatory compliance and all other business operations; and

Businesses should expect state agencies to provide:

- Clear rules and regulations;
- Consistent, high-quality, problem-solving service;
- Timely responses;
- User-friendly processes; and

All state agencies and other levels of government should work to reduce multi-agency barriers for business; and

Citizens need results that protect the public health and safety and do not compromise environmental quality; and

The top priorities of this administration include improving and simplifying the licensing, permitting, tax collection and other state business systems; and

The directors of certain state agencies, and a representative for local jurisdictions, signed a Project Charter in January 2006, which guides the development and implementation of a one-stop business portal for Washington citizens and businesses

NOW, THEREFORE, I, Christine O. Gregoire, Governor of the state of Washington, direct all regulatory, taxing, licensing, and permitting agencies and programs to improve and simplify service to Washington citizens and businesses.

The Governor's Regulatory Improvement Program will work with agencies to:

- A. Develop a One-Stop Business Portal. This single, secure, online portal will make licensing, permitting, regulatory approvals or filings, and tax collection easier for business.
- B. Provide Multi-Agency Reviews for Permits.

 Agencies will ease the burden of dealing with multiple agencies for permits by streamlining the process with features such as multi-agency permit teams, concurrent permit reviews, offering single points of contact, and providing on-line tools, education, and outreach. State agencies also will develop permit review systems and procedures that include local and federal agencies.
- C. **Engage in On-going Regulatory Improvement.**The Director of the Office of Regulatory Assistance will work with state, local and federal agencies to make on-going improvements that will make the

permitting, licensing, and regulatory processes easier and more effective. To do this, the Office of Regulatory Assistance will:

- Consult regularly with stakeholders;
- Develop and implement innovative regulatory best practices;
- Work with local and federal governments to develop coordinated permitting, licensing and related regulatory systems;
- Utilize the latest technology to ensure all the work of businesses and citizens with the state is as efficient and user-friendly as possible; and
- Report annually to the Governor on the status of regulatory improvement work plans.
- D. Listen to Our Clients. Agencies will use surveys, focus and advisory groups, interviews, complaint tracking or other methods to understand citizen and business perspectives and to improve service design and delivery.
- E. Talk Clearly to the Public. Agencies will make their letters, instructions and processes clear and understandable to citizens and businesses. They will standardize and simplify forms and applications. They will write their processes, rules, online tools, and public information in clear language that will improve accessibility, reduce processing times and increase user-friendliness.
- F. **Be Accountable.** Agencies that collect taxes or provide permits, licenses, approvals, and other regulatory services will:
 - Establish measurable service delivery standards to address issues such as:
 - o Turnaround or response times,
 - o Professionalism and helpfulness,
 - o Consistency,
 - o Efficiency and effectiveness, and
 - o Overall quality of service outcomes;
 - Regularly measure progress;
 - Report quarterly through Governor and agency Government Management, Accountability, and Performance (GMAP) review sessions;
 - Consider benchmarks from similar agencies or programs;
 - Set targets for improvement; and
 - Use Plain Talk standards (Executive Order 05-03) for written materials.

INVESTIGATION OF HEALTH PROFESSIONAL SEXUAL MISCONDUCT

WHEREAS, it is Washington State's paramount duty to protect the public and ensure safe, quality health care; and

Washington residents deserve a system that makes patient safety the top priority and instills confidence in the professionalism and training of their health care providers; and

The state's disciplining authorities, including the Department of Health and state boards and commissions, are responsible for ensuring patient safety by regulating health care professions and sanctioning those providers who exhibit unprofessional conduct; and

Sexual misconduct by health professionals in Washington is unacceptable and demands strong regulatory action by the state's disciplining authorities to better protect the public.

NOW, THEREFORE, I, Christine O. Gregoire, Governor of the State of Washington, direct all health profession disciplining authorities, including those reporting to the Secretary of Health and independent boards and commissions, to promptly investigate, without exception, all allegations of sexual misconduct by health care professionals within their respective governing authorities.

It is not the policy of Washington State to tolerate sexual misconduct, particularly by health care providers who act in service to the public. Rather, it is the policy of Washington State to thoroughly investigate all allegations of such conduct.

Washington State's health profession disciplining authorities shall work collaboratively with the Secretary of Health to:

- Establish a comprehensive definition of sexual misconduct, no later than September 1, 2006, that will be used in investigations of such conduct across all State health care professions; and
- 2) Establish comprehensive protocols for investigating allegations of sexual misconduct, no later than July 1, 2006, to ensure that any State action in this regard is uniform across all State health professions; and
- 3) Provide an annual report to the Governor on the application of these tasks.

This Executive Order shall take effect immediately.

HEALTHCARE COMMITMENTS Quality, Accountability and Transparency

WHEREAS, the health care system in Washington State has many strengths, including world class health care institutions and dedicated health care providers, improvements can and must be made to promote increased quality, accountability, and transparency in health care;

Washington State, as a purchaser of health care services for 1.3 million Washingtonians, has a key role in creating a marketplace that emphasizes performance and accountability, by tracking performance measures and making this information transparent for consumers;

Consumers expect to receive health care services that meet their needs, that prevent serious or chronic illness or disability, and that are based on the best scientific knowledge available;

Private sector health care purchasers, insurers and benefit administrators, providers, and consumers alike need good information to make appropriate health care decisions;

Health information technology is expanding our capacity to gather, analyze, and share crucial health information; and

Time and money are wasted on unnecessary medical procedures when information is not adequately shared.

NOW, THEREFORE, I, Christine O. Gregoire, Governor of the state of Washington, on the occasion of initiating the Puget Sound Health Alliance National Pilot Project charter, recommit to making Washington State a leader in the way we buy and use health care and to:

• Emphasize evidence-based health care. Support the State Health Technology Assessment Program in order to eliminate costly, ineffective and dated treatments that have either been shown to be unsafe, to

not work, or have been replaced with better treatments.

- Better manage chronic diseases. Continue to develop models of care for those with chronic illnesses by contracting with providers that can demonstrate improved care.
- Make better use of information technology. Legislation passed in 2005 sets a statewide goal to have all hospitals, integrated delivery systems, and providers adopt health information technologies by 2012. Build on the recommendations of the Health Information Infrastructure Advisory Board to meet this goal.
- Promote prevention, healthy lifestyles, and healthy choices. Include performance measures in state health contracts to foster better health outcomes such as improved vaccination rates, smoking cessation, and physical activity.
- Create more transparency in the health care system. Support the Puget Sound Health Alliance and its efforts to provide Washingtonians with accurate, consistent information on the quality and cost of health care services.

These efforts shall continue to be coordinated by the Secretary of the Department of Social and Health Services, the Secretary of the Department of Health, and the Administrator of the Health Care Authority in partnership with the federal and local governments, private sector health purchasers, and other stakeholders in our state's health care system.

WASHINGTON CLIMATE CHANGE CHALLENGE

WHEREAS, there is scientific consensus that increasing emissions of greenhouse gases are causing global temperatures to

rise at rates that have the potential to cause economic disruption, environmental damage, and a public health crisis;

The drivers of climate change are global, but the effects of climate change on Washington are local and unique, including our dependence on snowpack for fresh water, our reliance on hydropower for energy, and our significant amount of shoreline:

According to the University of Washington's Climate Impacts Group, the effects of climate change are already being felt in the state of Washington in the form of average yearly temperatures rising faster over the 20th Century than the global average, mountain glaciers in the North Cascades losing up to a third of their area since 1950, snow pack in the Cascades declining by 35%, peak spring river runoff occurring 10 to 30 days earlier and the proportion of stream flow that arrives in summer decreasing as much as 34% in sensitive river basins; and

WHEREAS, Washington has taken significant actions to address climate change, including:

- Adopting the 2005 Clean Car Act requiring certain automobiles to meet tougher emissions standards beginning with 2009 models;
- Retrofitting 50% of school buses and 20% of local government diesel engine vehicles to reduce highly toxic diesel emissions;
- Leading the nation in requiring fuel suppliers to ensure that 2% of the fuel they sell is biodiesel or ethanol:
- Leading the nation in adopting high performance green building standards and having one of the most energy efficient building codes in the nation;
- Implementing the best energy efficiency standards for appliances;
- Passing a clean energy initiative to increase the amount of energy efficiency and renewable resources in our state's electricity system;
- Purchasing hybrid and low emission vehicles for state agency use;
- Adopting the Columbia River Water Management Act, which will work toward meeting the water storage needs for agriculture, communities, and salmon; and

WHEREAS, Washington has tremendous opportunities to build a healthier and more prosperous future by embracing the challenge of climate change through expanding our clean energy economy;

Washington's rural communities can gain economic benefit through the production of renewable fuels, keeping more of the money Washington residents spend on imported fuels here at home; and

WHEREAS, Washington has worked closely with California and Oregon in establishing the West Coast Governors' Global Warming Initiative and is working with other western states to address climate change in a coordinated effort and through the Western Governors Association; and

WHEREAS, Washington's vast hydroelectric system must be taken into account in any regional or national climate program; and

Washington State must continue its work to be prepared for the inevitable impacts of climate change.

NOW, THEREFORE, I, Christine O. Gregoire, Governor of the state of Washington declare the state's commitment to address climate change by:

- Establishing the following greenhouse gas emissions reduction and clean energy economy goals for Washington State:
 - By 2020, reduce greenhouse gas emissions in the state of Washington to 1990 levels, a reduction of 10 million metric tons below 2004 emissions;
 - By 2035, reduce greenhouse gas emissions in the state of Washington to 25% below 1990 levels, a reduction of 30 million metric tons below 2004;
 - By 2050, the state of Washington will do its part to reach global climate stabilization levels by reducing emissions to 50% below 1990 levels or 70% below our expected emissions that year, an absolute reduction in emissions of nearly 50 million metric tons below 2004;
 - By 2020, increase the number of clean energy sector jobs to 25,000 from the 8,400 jobs we had in 2004;
 - By 2020, reduce expenditures by 20% on fuel imported into the state by developing Washington resources and supporting efficient energy use.
- Implementing the significant policy actions taken in 2005 and 2006 to reduce greenhouse gas emissions. These actions will move Washington State to at least 60% of the 2020 goal and grow the clean energy economy by:
 - Working to ensure cars sold in Washington meet stringent emission standards beginning with 2009 models;
 - Retrofitting the most polluting diesel engines in school buses and local government vehicles;
 - Working with farmers, entrepreneurs, fuel distributors and retailers to assure that biofuel feedstocks are grown in Washington; that refiners, blenders and distributors of biofuels create family wage jobs in Washington; and that the public can purchase fuel blends that reduce our dependence on imported fuel;
 - Constructing high performance green buildings;
 - Maintaining the highest levels of efficiency in our state's energy code and regularly updating and enhancing those standards;
 - Examining compliance with appliance efficiency standards and updating and enhancing those standards:
 - Implementing the requirements of the Energy Independence Act by adopting rules that help utilities to succeed in meeting their renewable energy targets;
 - Pursuing new water resources in Eastern Washington, including water conservation projects, develop-

- ing new storage and new creative water management alternatives; and
- Reducing energy use by state agencies by achieving the goals established in Executive Order 05-01, Establishing Sustainability and Efficiency Goals for State Operations.
- Achieving at least the remaining 40% toward the 2020 goal for Washington State and planning for our future, I, FURTHER, order and direct:
 - A. The Director of the Department of Ecology and the Director of the Department of Community, Trade and Economic Development in consultation with a broad range of stakeholders to develop a climate change initiative, Washington Climate Change Challenge, to achieve the goals of this Executive Order. Executive Cabinet agencies are directed to provide their full assistance and support in developing Washington Climate Change Challenge. I invite the Office of the Insurance Commissioner, the Commissioner of Public Lands, institutions of higher education, and members of the Legislature to assist in this effort.
 - B. The Director of the Department of Ecology and the Director of the Department of Community, Trade and Economic Development shall include representatives from business, including transportation, forestry and energy sectors, agriculture, local, county and regional governments, institutions of higher education, labor unions, environmental groups and other interested residents as appropriate in the development of Washington Climate Change Challenge.
 - C. Washington Climate Change Challenge shall address the following elements and process steps:
 - Consider the full range of policies and strategies for the state of Washington to adopt or undertake to ensure the economic and emission reductions goals are achieved, including policy options that can maximize the efficiency of emission reductions including market-based systems, allowance trading, and incentives;
 - ii) Determine specific steps the state of Washington should take to prepare for the impact of global warming, including impacts to public health, agriculture, the coast line, forestry, and infrastructure;
 - iii) Assess what further steps the state of Washington should take to be prepared for the impact of global warming to water supply and management;
 - iv) Initiate active involvement by the state of Washington in the development of regional and national climate policies and coordination with British Columbia;
 - Recommend how the state of Washington, as an entity, can reduce its generation of greenhouse gas emissions;
 - vi) Work with the state of Washington's local governments to maximize coordination

- and effectiveness of local and state climate initiatives; and
- vii) Inform the general public of the process, solicit comments and involvement and develop recommendations for future public education and outreach.
- D. The Director of the Department of Ecology and the Director of the Department of Community, Trade and Economic Development shall submit Washington Climate Change Challenge to the Office of the Governor within one year of the signing of this Executive Order.

This Executive Order shall take effect immediately.

- Are students experiencing a truly seamless education system?

By looking at data from many sources within the education system, the P-20 Council will determine whether we are getting the expected return on our investment and where and how we need to make improvements.

The P-20 Council's task is to track progress on the Washington Learns long-term goals and on the specific investments that have been made. - 13. One representative of tribal education programs from a federally recognized tribe, appointed by the Governor.

The Governor's P-20 Council will be convened by the Governor and will be staffed and supported by the Office of Financial Management. Other agencies will provide information and support as requested by the Governor.

EXECUTIVE ORDER 07-04

Voter Registration Assistance

WHEREAS, Washington began offering voter registration services through the state Department of Licensing in 1992;

WHEREAS, the United States Congress passed the National Voter Registration Act of 1993 (NVRA) requiring states to, among other things, offer voter registration opportunities at state offices that provide public assistance and state offices that provide state-funded programs primarily engaged in serving persons with disabilities;

WHEREAS, the Washington State legislature subsequently enacted statutes designed to implement the public agency provisions of the NVRA which are codified at RCW 29A.08.310 through RCW 29A.08.360; and

WHEREAS, the right to vote is fundamental, and it is a primary duty of government to make the opportunity to register and assistance with registering to vote available to all eligible citizens.

NOW, THEREFORE, I, Christine O. Gregoire, Governor of the state of Washington, designate the Department of Social and Health Services (DSHS) as a voter registration assistance agency as required by the NVRA and state law. I further direct DSHS to coordinate voter registration assistance activities in the following manner:

- 1. Appoint a Voter Registration Assistance Officer who will monitor and be responsible for efficient and appropriate compliance with state and federal voter registration assistance laws;
- Analyze how best to use technology to efficiently and effectively provide voter registration assistance for in-person services as well as tele-centers and web portals; and

3. Cooperate with the Secretary of State's Office to ensure that DSHS delivers voter registration assistance services in a manner that allows the Secretary of State to carry out the Secretary's voter registration responsibilities efficiently.

Nothing in the implementation of this Executive Order shall be interpreted to allow a state agency, state office, or agency employee to:

- 1. Attempt to influence an applicant's political preference or registration;
- Display any such political preference or allegiance;
- 3. Make any statement that would discourage an applicant from registering to vote; or
- Make any statement or take any action that would lead an applicant to believe that a decision to register or not to register to vote has any bearing on the availability or amount of services or assistance provided;

I further strongly encourage all state agencies to:

- Provide on their web sites a link to the Secretary of State's voter registration web site; and
- Further consider and implement other means by which the agency can promote voter registration.

This Executive Order shall take effect immediately.

RE: Clarification of Washington cattle import regulations and brand inspection requirements.

In order to provide clarity regarding Washington state import regulations and brand inspection requirements related to cattle, the Washington state department of agriculture issues this interpretive statement pursuant to RCW 34.05.010 (8) and 34.05.230.

It has come to the attention of the department that cattle are being brought into Washington state solely for the purpose of having the cattle meet state animal health requirements (i.e. to receive mature brucellosis vaccinations). It is acceptable to stop cattle in transit through the state for animal welfare reasons such as watering or feeding. However, shipments of cattle stopping to receive disease testing or vaccinations are no longer considered in transit and will be considered Washington state cattle. Persons bringing cattle into the state for testing or vaccination must meet Washington state animal health and livestock inspection requirements (i.e. brand inspection, Washington state required testing and vaccination, etc.). These regulations are found in chapters 16-54 and 16-86 WAC among others.

In addition, a brand inspection shall be required under the current regulations. If cattle change ownership or are transported out of the state after arrival in Washington, a
