PRESIDING CHIEF JUDGE—
EXECUTIVE COMMITTEE

(a) *Executive Committee.* There is hereby created an executive committee of the Court of Appeals. It shall be made up of the Presiding Chief Judge, as chair, and the remaining Chief Judges of the divisions of the court and the Acting Chief Judge of Division One.

(b) *Duties of the Executive Committee.* The executive committee shall be ~~in general charge of~~ responsible for administering the affairs of the Court of Appeals. Decisions on the Court's budget and other important decisions shall be made by the full Court; other decisions affecting the Court as a whole may be made by the executive committee. The full Court may delegate additional authority as appropriate. The committee's Its duties shall include the following:

(1) Coordinating the judicial work of the court to the end that its case load can be handled expeditiously;

(2) ~~Administering the budget of the court~~ Making budget recommendations to the full Court, submitting the approved budget to the Legislature, and administering the budget;

(3) Recommending to and implementing policies determined by the Court of Appeals as a whole;

(4) ~~Appointing special committees for the court as necessary;~~

(5) ~~Appointing representatives of the court to serve on judicially related committees or task forces which may require a Court of Appeals representative;~~

(6) ~~Counseling and directing the Presiding Chief Judge on matters of liaison with the organizations set forth below;~~

(7) (4) Such other duties as the Court of Appeals as a whole may from time to time direct;

(8) (5) If the Presiding Chief Judge is not serving as the Chief Judge of a division or the Acting Chief Judge of Division One, the Presiding Chief Judge shall not have a vote on the executive committee.

(c) *Selection of Presiding Chief Judge.* ~~In April of each year~~ Each year, during the appellate judges' spring conference, the Court of Appeals shall select a Presiding Chief

Judge for the Court of Appeals. For any year in which spring conference is not held, the selection shall be conducted by May 1.

(1) Those eligible for the position of Presiding Chief Judge shall be the Chief Judges of each of the divisions of the Court of Appeals ~~and the Acting Chief Judge of Division One~~, and any other judge who has served as a Chief Judge of any Division ~~or as acting Chief Judge of Division One~~.

(2) The position of Presiding Chief Judge shall rotate annually, and be selected from Division I every other year.

(3) The term of the Presiding Chief Judge shall be for 1 year.

(d) *Duties of the Presiding Chief Judge.* The duties of the Presiding Chief Judge shall be those duties delegated by the Court of Appeals as a whole or by the executive committee.

(1) Act as a liaison and representative for the Court of Appeals with all ~~other organizations; other levels of the judicial system, namely, the Supreme Court, the superior courts, the courts of limited jurisdiction, and the federal courts;~~

(2) Act as liaison and representative for the Court of Appeals with the Washington State Bar Association;

(3) Act as liaison and representative for the Court of Appeals with the Washington State Administrator for the Courts;

(4) Act as liaison and representative for the Court of Appeals with the press and the public;

(5) Act as liaison and representative for the Court of Appeals with the legislative branch of government;

(6) Act as liaison and representative for the Court of Appeals with the executive branch of government;

(2) Appoint representatives of the court to serve on judicially related committees or task forces which may require a Court of Appeals representative;

(3) Appoint special committees for the court as necessary;

~~(7)~~ (4) Perform such other duties as the executive committee shall from time to time direct.

(e) *Meetings and Reports.* ~~The Presiding Chief Judge shall call quarterly meetings of the Court of Appeals as a whole. Other meetings shall be~~ Meetings of the Court of Appeals as a whole shall be called as directed by the executive committee. At meetings, the Presiding Chief Judge will:

(1) Preside;

(2) Prepare an agenda and, if possible, forward the proposed agenda to all members of the Court of Appeals in advance of each meeting;

(3) Report to the Court of Appeals with reference to his liaison activities with the organizations set forth above;

(4) Arrange for the meeting place;

(5) Arrange for the recording of minutes;

(6) Arrange for maintenance of ~~Maintain~~ the records of all meetings of the court.

(f) Voting at Meetings of the Court of Appeals as a Whole. Members who attend a meeting, including by telephone or videoconference, may vote in that meeting.

(g) Role of Committees other than the Executive Committee. Committees other than the executive committee report to, and may make recommendations to, the executive committee. Decisions about these recommendations are to be

made by the executive committee or the full Court, unless special authority is delegated to a particular committee for a particular purpose.

(f) (h) *Amendments.* Amendments to this rule must be approved by a majority of the members of the Court of Appeals. An Order adopting the amendments shall be signed by the Presiding Chief Judge. The Order shall be filed in the clerk's office of each Division of the Court of Appeals and a copy provided to the Reporter of Decisions.

Introduction: In 1994, the Washington state department of ecology (ecology) developed a national pollutant discharge elimination system (NPDES) general permit to regulate the discharge of wastewater from fresh fruit packing facilities. This permit was reissued in 1999 and 2004. A draft general permit and fact sheet are being developed for reissuance in 2009.

This permit was developed to meet the requirements of chapters 90.48, 90.52, and 90.54 RCW as amended, and the Federal Water Pollution Control Act (FWPCA) (Title 33 United States Code, Section 1251 et seq.) as amended. All requirements of 40 Code of Federal Regulations (C.F.R.) 122.41 and 122.42 are incorporated in this general permit by reference.

The fruit packing industry is eligible for coverage under a general permit due to: (1) The similar wastewater characteristics among facilities; (2) the uniform discharge conditions to which all facilities would be subject; and (3) the significant reduction of resources necessary for permit handling. However, individual NPDES/state waste discharge permits will still be applied in those instances where ecology determines the general permit is not appropriate for a facility or an individual facility does not wish to be covered by the general permit.

This general permit establishes treatment/disposal methods, effluent limits, and best management practices for discharges from the fresh fruit packing industry. Compliance with this general permit is anticipated to protect human health and waters of the state.

Types of Facilities or Dischargers and Geographic Area Covered: Every new or existing fresh fruit packing facility within the entire state of Washington which receives, packs, stores, and/or ships either hard or soft fruit is required to apply for coverage under either this general permit or an individual NPDES/state waste discharge permit.

Documents Available for Review: The proposed general permit, fact sheet, economic impact analysis, and other related documents are on file and may be inspected and copied between the hours of 8:00 a.m. and 4:30 p.m., Monday through Friday at the following ecology location. Copies of the documents may be sent to interested parties upon request. Contact the following ecology office for further information.

EXECUTIVE ORDER 09-01

**WAIVER OF COLLECTION OF CERTAIN FEES OWED TO THE
DEPARTMENT OF LABOR & INDUSTRIES DURING THE CUR-
RENT STATE OF EMERGENCY**

WHEREAS, RCW 43.06.220(2) specifically authorizes the Governor to issue an Order waiving or suspending the collection of certain fees owed to the Department of Labor & Industries (L&I) in an area described in a current state of emergency proclaimed by the Governor; and

WHEREAS, the waiver or suspension authority discussed above is further specified in RCW 19.28.101(8) and includes waiver of L&I electrical fees that could otherwise be imposed pursuant to RCW 19.28.101(4) and implementing regulations in WAC 296-46B-901(7); and

WHEREAS, the following statewide Governor's state of emergency proclamations issued pursuant to RCW 43.06.010(12) are currently in effect: #08-10 issued December 24, 2008; #08-11 issued January 2, 2009, and amending #08-10; and #09-01 issued January 9, 2009, and amending #08-10; and

WHEREAS, the City of Pacific is within the area described in the above-cited emergency proclamations and suffered extensive and unexpected damage resulting from unprecedented flooding; and

WHEREAS, sixty (60) residences within the City of Pacific have been identified by the Mayor of the City as needing initial L&I electrical wiring and equipment inspections as a result of the flooding, some of which may also need L&I repair and replacement inspections, and all such inspections are immediately necessary to protect the health and safety of the residents; and

WHEREAS, the Mayor of the City of Pacific has requested L&I's assistance in promptly inspecting the electrical wiring and equipment in the residences described above and the waiver of any inspection fees as L&I might otherwise impose; and

WHEREAS, protection of public health, safety, and welfare during a state of emergency is a fundamental purpose of government recognized in the Emergency Management Act (Chapter 38.52 RCW); and

WHEREAS, in order to protect the health, safety and welfare of the residents described above, it is reasonable and appropriate to conclude that L&I should be authorized to provide the requested inspection services without delays attributable to the imposition and collection of inspection fees, that waiver of collection of said fees will promote and secure the safety and protection of the civilian population described above by encouraging appropriate electrical safety inspections, and that L&I minimize applicable regulatory requirements to encourage immediate necessary electrical inspections to flood damaged electrical installations.

NOW THEREFORE, I, Christine O. Gregoire, Governor of the state of Washington, do hereby order that L&I is authorized to provide the electrical inspections described herein without collection of fees that could otherwise be imposed pursuant to RCW 19.28.101 and WAC 296-46B-901(7), as necessary for the sixty (60) residences identified by the Mayor of the City of Pacific having electrical installations damaged as the result of winter storms occurring January 6, 2009, through January 16, 2009, effective immediately and until February 28, 2009, or earlier termination of the currently applicable state of emergency.

The department of revenue has issued Property Tax Advisory (PTA) 14.2.2009 to replace PTA 14.1.2009.

PTA 14.1.2009 explains that neither compensating tax nor additional tax is due when tribally owned land classified under chapter 84.33 RCW (designated forest land) or chapter 84.34 RCW (current use classification) is transferred to the United States to be held in trust for a federally recognized Indian tribe. The department has issued PTA 14.2.2009 to clarify that tribally owned land removed from current use classification or as designated forest land for any reason is not subject to these taxes.

**RESCISSION OF EXECUTIVE ORDERS AND
 ELIMINATION OF CERTAIN BOARDS AND COMMISSIONS**

WHEREAS, certain executive orders and boards and commissions have been rendered ineffective due to either the enactment of superseding law, subsequent executive orders, through an internal expiration provision or are no longer needed for the efficient administration of state government; and

WHEREAS, the existence of obsolete executive orders and unneeded boards and commissions can lead to a lack of accountability and create confusion and unnecessary regulatory burden on executive agencies and the public;

WHEREAS, most of the advisory functions of boards and commissions can be performed without the administrative costs of maintaining formal organizations, and executive agencies are being strongly encouraged to enhance public input using modern communication technology, and identify new, less costly, and more effective opportunities to ensure citizen participation and government openness; and

(2) All funds held by, or other moneys due to, the terminated entity shall revert to the fund from which they were appropriated, or if that fund is abolished to the general fund; and

(3) All contractual rights and duties of an entity shall be assigned or delegated to the entity assuming the responsibilities of the terminated entity, or if there is none to such entity as the governor shall direct.

This Executive Order shall take effect immediately.

SUBJECT: SHARED SERVICES DIRECTIVE

On Monday, February 9, I announced our Government Reform Package. One of the key components of this package is movement to a shared services model of delivering many of the "back office" functions that support the work of your various agencies - areas such as information technology, property and building management, motor pool and human resources.

Other states and private sector organizations have achieved significant benefits through the use of shared services - the practice of having a single group provide back-office administrative services or customer-facing activities for multiple agencies or departments. Sharing administrative functions between agencies will allow you to focus on your core missions of providing essential services to Washingtonians. I expect that our new shared services approach and governance structure will capture the benefits of economies of scale in a way that ensures good customer service to the client agencies. The service providers must be accountable for delivering a defined quality of service for a specific cost to the client agencies.

By this directive, I am requesting that each of your agencies provide full assistance and support in the development and implementation of a shared services model for how we operate. I have requested the directors of the following offices and agencies to lead this effort:

- Governor's Executive Policy Office
- Department of Information Services
- Department of Personnel
- Department of General Administration
- Office of Financial Management

Between now and the end of this calendar year, the directors will work in partnership with state agencies to create shared service centers with expertise in the following operational areas. These centers would gradually become responsible for administering the following consolidated lines of business across state government:

Information Technology. The Department of Information Services will focus on using common infrastructure and services - including consolidation of e-mail services and expansion of the statewide data center - to reduce costs and improve information security and the collection of management information across state government.

Fleet Management. The Department of General Administration will assume operational responsibility for smaller motor fleets currently managed by state agencies. Consolidating fleets will eliminate under-used vehicles, improve maintenance, reduce costs to agencies, and result in a "greener" fleet that consumes less fuel and produces fewer emissions.

EXECUTIVE ORDER 09-03

CAPITAL STIMULUS PROJECT STREAMLINING

WHEREAS, our nation is experiencing the worst economic times since the Great Depression; and

WHEREAS, state government desires to do all it can to help citizens, buyers, renters and employees survive through this difficult economy and to help Washington businesses stay viable; and

WHEREAS, Congress is contemplating an economic stimulus package to include fiscal assistance for transportation and other building projects in our state; and

WHEREAS, the state legislature will be considering a similar package of projects using state capital and transportation funds to create jobs, including green jobs, and address significant and necessary infrastructure needs throughout the state Washington; and

WHEREAS, to stimulate our state's economy as fully as possible, work on these projects must be ready to begin as soon as possible and all necessary permits must be in place; and

WHEREAS, this executive order applies to all cabinet agencies, and all non-cabinet agencies are encouraged to implement the articles listed within;

NOW THEREFORE, I, Christine O. Gregoire, Governor of the state of Washington to ensure that potential state projects qualify for funding and are ready to proceed to construction as part of the economic stimulus proposals from Congress and the Legislature hereby order all cabinet agencies and encourage non-cabinet agencies to:

1. Ensure that all necessary information about what data, studies, and drawings are required to complete permit applications is readily available either online, through in-person conferences, or through the use of telecommunication or internet technologies;
2. Participate in a team led by the Office of Regulatory Assistance made up of representatives from state government and invited representatives of federal, tribal and local governments to help funding agencies ascertain the level of permit readiness for qualifying projects, to advise agencies on how best to educate project proponents about readying their projects for permit and to ensure status of permit reviews.
3. Provide estimated timelines for agency responses to applicant submittals, including any time needed to determine if an application is complete and the expected review time for a complete application;
4. Where necessary and possible without undercutting public safety or environmental safeguards, take all measures necessary, including prioritizing work to complete the projects with existing or cost-reimbursable resources and the adoption of emergency

rules, to expedite application procedures, project decision making and appeals of project-related permit decisions;

- 5. Invite appropriate federal agencies, as well as tribal and local governments, to assist by joining state agencies in streamlining efforts similar to those described in this executive order; and
- 6. Utilize alternative decision making and dispute resolution techniques to resolve regulatory issues without litigation, for example by making use of the Office of Regulatory Assistance as needed to coordinate between local, state, tribal and federal review agencies and making use of mediation services available through the Environmental Hearings Office as a dispute resolution tool.
