Document Description: Ecology has determined that existing law may be reasonably interpreted not to require a permit for the on-site storage and use of rooftop or guzzler collected rainwater. Under the department's policy, the onsite storage and/or beneficial use of rooftop or guzzler collected rainwater is not subject to the permit process of chapter 90.03 RCW. If and when the department determines that rooftop or guzzler rainwater harvesting systems are likely to negatively affect instream values or existing water rights, local restrictions may be set in place to govern subsequent new systems. To qualify as rooftop collected rainwater, the roof collecting the rainwater must be part of a fixed structure above the ground with a primary purpose other than the collection of rainwater for beneficial use. A guzzler is a device used to catch and store rainwater to provide drinking water for wildlife, livestock or birds.

<u>The Department's Rooftop/Guzzler Collected Rainwater</u> <u>Policy</u>

The on-site storage and/or beneficial use of rooftop or guzzler collected rainwater is not subject to the permit process of RCW 90.03. If and when the department determines that rooftop or guzzler rainwater harvesting systems are likely to negatively affect instream values or existing water rights, local restrictions may be set in place to govern subsequent new systems. To qualify as rooftop collected rainwater, the roof collecting the rainwater must be part of a fixed structure above the ground with a primary purpose other than the collection of rainwater for beneficial use. A guzzler is a device used to catch and store rainwater to provide drinking water for wildlife, livestock or birds.

PROCLAMATION BY THE GOVERNOR 09-05

WHEREAS, on October 11, 2009, a large scale landslide uplifted a large section of State Route (SR) 410 and pushed it and a significant amount of earth into the Naches River, destroying at least two homes, extensively damaging SR 410, changing the river's course, and causing the evacuation of nearby residents as a result of potential flooding; and

As a result of the massive landslide, on October 12, 2009, the Washington State Department of Transportation (WSDOT) and Washington State Patrol (WSP) closed a 47-mile section of SR 410 between Mount Rainier National Park's Lake Tipsoo and the junction with US 12, five miles west of Naches, and the expected duration of the closure is currently unknown; and

The estimated cost to repair the damage is over \$1,000,000, the highway repair project is expected to be complex and relatively lengthy, the emergency condition has eliminated vehicle traffic on the highway and caused significant detours, delays, and inconvenience that affect public health and safety; and

Such conditions will persist until the repair work is completed and the highway reopened to vehicles; and

WSDOT is coordinating resources to repair the highway and rechannel the river, is continuing to assess the damage caused by this event, and is working closely with local jurisdictions to develop short- and long-term repairs for the roadway and detours; and

It is necessary for the Washington State Department of Transportation to use emergency contracting procedures; and

The landslide and its effects continue to impact the life and health of our citizens, as well as the property, and transportation infrastructure of Washington State, and is a public disaster that affects life, health, property or public peace.

NOW, THEREFORE, I, Christine O. Gregoire, Governor of the state of Washington, as a result of the above-noted situation and under Chapters 38.52 and 43.06 RCW, do hereby proclaim that a State of Emergency exists in Yakima County in the State of Washington, and direct the plans and procedures in the *Washington State Comprehensive Emergency Management Plan* be implemented. State agencies and departments are directed to utilize state resources and to do everything reasonably possible to assist affected political subdivisions in an effort to respond to and recover from the event.

Department of Ecology to Modify the General Permit for Aquatic Weed Control in Irrigation Systems

The Washington state department of ecology has made a preliminary determination to modify the general permit for irrigation systems. The permit covers entities that use pesticides to control aquatic weeds in irrigation systems. The department of ecology expects to modify the permit by March 2010. The department of ecology originally issued the general permit in 2008. It will expire in February 2013.

The permit covers irrigation districts and irrigation water suppliers who apply aquatic herbicides and algaecides in irrigation canals and ditches. Currently, sixteen irrigation districts are covered by the permit. The modification to the permit would allow the use of the pesticide endothall. Endothall is an alternative to acrolein, the herbicide that irrigation districts historically used but is being phased out.

We expect to complete the draft version of the permit modification and release it for public comment by January 2010. The proposed timeline for drafting the permit is:

A modification of a permit can be appealed pursuant to RCW 43.21B.310. Entities that are currently covered by the permit do not need to reapply for coverage under the modified permit.
