During the rule development process, the advisory committee identified an opportunity to improve the rule structure by creating two new sections. The intent of this action is to improve the rule structure and make it easier to implement.

Currently WAC 173-400-110 covers both new source applicability and the new source permit process. This proposal divides the two topics [into] two sections, which makes the rule easier to implement.

This rule making has three focal points: Development of nonattainment area new source review (NSR) rules, correcting state implementation plan deficiencies, and general housekeeping.
