Proposed Amendments to SAR 21

RULE 21. JUSTICES PRO TEMPORE

(a) Generally. If one or more justices recuse on a case which reduces the court to an even number, a pro tempore justice shall be appointed by the Chief Justice when available, unless a majority of the court directs otherwise. In all

other cases of recusal, the Chief Justice shall notify the other justices, in writing, of the recusal as soon as the fact of recusal becomes known to the Chief Justice, and the majority shall direct whether a pro tempore justice should be appointed when available.

(b) Qualifications. If a pro tempore justice is to be selected, the proposed selection shall be made in the manner set forth hereafter by the Chief Justice, or at the Chief Justice's option by the Clerk of the Court, from a list of active and retired court of appeals judges. The list shall be approved on an annual basis by a majority of the Court. All retired appellate judges will be included on the list, *except* those who prefer not to be on the list or who are (1) incapacitated, (2) are litigants whose cases have been in this court or will probably likely come to this court, (3) are over 75 years of age (the mandatory judicial retirement age in this state), or (4) are in a practicing law firm as a sole practitioner, member of a law firm, or of counsel to a law firm, or (5) who prefer not to be on the pro tem list. legal counsel for any private, nonprofit, or government entity.

AMENDATORY SECTION (Amending WSR 05-13-004, filed 6/2/05, effective 7/2/05)

WAC 137-48-060 Mail costs. (1) Except as otherwise stated in this section, mail costs shall be the responsibility of the inmate.

- (2) Mail which arrives at the institution with postage due may, at the option of the superintendent, be delivered to the inmate. The institution may pay the postage due in accordance with subsection (3) of this section, or hold the mail for a reasonable period of time so as to allow the inmate to arrange for payment of the postage due. If such arrangements are not made within the time provided, the package/mail may be donated to charity or discarded.
- (3) Indigent inmates shall be authorized to receive postage up to the equivalent to the mailing cost of ((ten)) <u>five</u> standard first class letters per week. This indigent postage provision shall cover both legal and/or regular letters.
- (4) The department shall recoup any expenditures made by the institution for postage due on incoming mail and/or indigent postage for letters, (as identified in subsection (3) of this section) may be recouped by the institution whenever such indigent inmate has ten dollars or more of disposable income in his/her trust fund account.

LEGAL NOTICE: The Washington state department of agriculture (WSDA) plant protection division is hereby notifying the affected public that the herbicides glyphosate (e.g. Aquamaster®, Aquaneat®, or Rodeo®) and imazapyr (e.g. Habitat® or Polaris AQ®), surfactants (e.g. Agri-DexTM, Class Act Next GenerationTM, CompetitorTM, Dyne-AmicTM, KineticTM, or LI-700TM) and marker dyes may be used to control invasive *Spartina* grass species between June 1, 2010, and October 31, 2010. Properly licensed pesticide applicators who have obtained coverage under the WSDA national pollutant discharge elimination system (NPDES) waste discharge general permit may apply glyphosate or imazapyr to control the noxious weed *Spartina* on the saltwater tideflats of Grays Harbor, Hood Canal, Willapa Bay, Puget Sound, and the north and west sides of the Olympic Peninsula.

Use of herbicides is one of the options used to control *Spartina*. These infestations may also be treated, but not eradicated, by mowing, digging, crushing, or covering.

Insurance Services: Office of the medical director, state fund claims administration, self-insurance and crime victims.

New Policy: Provider Bulletin 10-03 Advanced Imaging Utilization Review.

In 2009, the Washington legislature passed ESHB 2105, which directed the state to convene an advanced imaging management work group to identify evidence-based best practice guidelines for advanced imaging. State agencies were directed to implement the work group recommendations. This bulletin announces the implementation of the recommendations.

The bulletin provides guidelines and utilization review for advanced imaging studies. Beginning June 1, 2010, the department of labor and industries will implement evidence-based guidelines for MRI scans of the spine and upper and lower extremities; and CT and MRI scans for headaches. These require prior authorization. For state fund claims, prior authorization must go through the department's contracted utilization firm. Requests for advanced imaging for crime victims' claims go through labor and industries' crime victims' compensation program. Requests for advance[d] imaging for self-insured claims go through the self-insured

employer or third party administrator. Labor and industries will pilot an expedited review program for advanced imaging studies with organizations that meet certain criteria.

Policy #11-1: Providing notifications to employees and employers. The purpose of this policy is to clarify the requirements of employer-to-employee and employee-to-employer notices, as stated in RCW 41.05.009 and 41.05.065 (iii),(iv) and (v). Effective June 1, 2010.

Policy #17-1: Determining faculty eligibility for summer/short class sessions. The purpose of this policy is to provide a method for determining eligibility for the employer contribution for faculty teaching nontraditional class sessions. Effective January 1, 2010.

Policy #17-2: Determining faculty eligibility after a layoff. The purpose of this policy is to apply the criteria for maintaining the employer contribution toward insurance coverage after a layoff, as described in WAC 182-12-129, to faculty. Effective January 1, 2010.

Policy #17-3: Determining faculty eligibility for off quarter/semester and for decreases in workload. The purpose of this policy is to clarify when a faculty qualifies for the employer contribution toward insurance coverage during an off-quarter/semester and when there is a decrease in workload. Effective January 1, 2010.

The PEBB customer service is rescinding the following policies:

Policy #409: *Determining half-time employment*. The purpose of this policy was to clarify accepted methods for calculating half-time employment for employees. This is now addressed in statute.

Policy #2-11: Extension of PEBB deadlines, grace periods, and other timelines for members affected by Hurricane Katrina. The purpose of this policy was to extend deadlines and other timeframes for affected individuals acting on behalf of PEBB members affected by Hurricane Katrina. This policy is no longer required by federal regulations.
