At present, the public disclosure commission has eight rules under development through permanent rule making and plans to incorporate the recodification of chapter 42.17 RCW throughout Title 390 WAC through expedited rule making:

1. **Topic:** Implementing chapter 145, Laws of 2011.

Status: A CR-101 was filed last June in preparation for rule making to implement chapter 145, Laws of 2011 (ESSB 5021). The commission will likely approve draft language in September.

Statutory Authority: RCW 42.17.370(1).

Statute Being Implemented: Chapter 145, Laws of 2011.

WAC Cite: WAC 390-16-011 Forms—Registration for political committees, 390-16-060 Forms for report of independent expenditures and electioneering communications, 390-17-315 Political committees—Qualifications to contribute, 390-18-060 Electioneering communication reporting threshold and sponsors, 390-19-030 Electronic filing—

Reporting threshold, and 390-37-103 Commission options following receipt of a staff report on alleged violations.

2. Topic: Adjusting contribution limits.

Status: The commission is required to adjust contribution limits in even-numbered years. A CR-101 was filed in June. The commission will likely review changes in economic factors at the September meeting. Adjustments to dollar amounts will also be considered then.

Statutory Authority: RCW 42.17.370(1).

Statute Being Implemented: RCW 42.17.690.

WAC Cite: WAC 390-05-400 Changes in dollar amounts.

3. Topic: Adjusting the reporting threshold for out-of-state political committees.

Status: The commission is required to annually adjust the reporting threshold for major contributions disclosed by an out-of-state political committee. A CR-101 was filed in June. The commission will likely review changes in economic factors at the September meeting and consider changing the reporting threshold.

Statutory Authority: RCW 42.17.370(1).

Statute Being Implemented: RCW 42.17.093 (1)(g).

WAC Cite: WAC 390-16-050 Forms—Out-of-state political committees.

4. Topic: Recodification of chapter 42.17 RCW.

Status: The commission will proceed with expedited rule making in early November to incorporate the recodification of chapter 42.17 RCW throughout Title 390 WAC. No substantive changes will be made to the affected rules.

Statutory Authority: RCW 42.17.370(1).

Statute Being Implemented: Chapter 204, Laws of 2010.

PUBLIC NOTICE FOR *SPARTINA* TREATMENT IN WESTERN WASHINGTON

LEGAL NOTICE: The Washington state department of agriculture (WSDA) plant protection division is hereby notifying the affected public that the herbicides glyphosate (e.g. Aquamaster®, Aquaneat®, or Rodeo®) and imazapyr (e.g. Habitat® or Polaris AQ®), surfactants (e.g. Agri-Dex™, Class Act Next Generation™, Competitor™, Dyne-Amic™, Kinetic™, or LI-700™) and marker dyes may be used to control invasive *Spartina* grass species between June 1, 2011, and October 31, 2011. Properly licensed pesticide applicators who have obtained coverage under the WSDA national pollutant discharge elimination system (NPDES) waste discharge general permit may apply glyphosate or imazapyr to

control the noxious weed *Spartina* in Grays Harbor, Hood Canal, Willapa Bay, Puget Sound, the north and west sides of the Olympic Peninsula, and the mouth of the Columbia River.

Use of herbicides is one of the options used to control *Spartina*. These infestations may also be treated, but not eradicated, by mowing, digging, crushing, or covering.

INTERPRETIVE STATEMENT ISSUED

The department of revenue has issued the following excise tax advisory (ETA): ETA 3054.2011 Sales to residents of states or possessions of the United States, and territories or provinces of Canada, that do not impose a tax of at least three percent.

RCW 82.08.0273 provides an exemption from the retail sales tax to certain nonresidents of Washington for purchases of tangible personal property, digital goods, and digital codes, *for use outside this state*. This ETA has been updated to explain that the exemption is available only to residents of states other than Washington, United States possessions, or Canadian territories or provinces that do not impose or have imposed on its behalf, a generally applicable retail sales tax, use tax, value added tax, gross receipts tax on retailing activities, or similar generally applicable tax of three percent or more. See SB 5763 (chapter 7, Laws of 2011).

Licensed dealers or harvesters must also submit with their request appropriate scientific studies demonstrating that the proposed control measures will reduce the risk of *Vp* illness so that it is no longer reasonably likely to occur.
