Prevailing Rate of Wage

Pursuant to RCW 39.12.015, 39.12.020, and WAC 296-127-011, on February 1, 2012, the industrial statistician and director of the department of labor and industries will determine and publish on the internet the statewide prevailing rates of wage. Pursuant to WAC 296-127-011, these rates become effective March 2, 2012, thirty days after publication.

Every contractor and subcontractor on every public works project must file a statement of intent to pay prevailing wages and an affidavit of wages paid. Both forms must be filed on every project. The filing of the affidavit of wages paid does not set aside the requirement to also file the statement of intent to pay prevailing wages. The department may fine contractors \$500 for failure to file these forms.

The department of ecology is proposing to renew and modify the "irrigation system aquatic weed control national pollutant discharge elimination system (NPDES) and state waste discharge general permit" in March 2012. The modified draft permit and fact sheet are available for review and public comment from February 15, 2012, to March 30, 2012. The department of ecology will host an informational workshop and public hearing on its proposal. The public is encouraged to give written comments during the public comment period or oral comments at the public hearing.

Purpose of the Permit: The general permit covers the discharge of pesticides used in irrigation systems in Washington state to control plant and algae growth. The proposed

permit addresses legal requirements under the Washington State Water Pollution Control Act and regulates the discharge of pollutants to protect water quality. Proposals for modifications to the permit include changes for endothall (Cascade and Teton) and fluridone. The effective use of endothall enables less use of the more toxic acrolein. The draft permit includes other proposed changes.

The department of ecology issues a general permit in place of a series of individual permits for similar permitted activities. Individual activities that receive coverage under the general permit must comply with the terms and conditions of the permit.
