In accordance with RCW 90.58.030 (3)(e), the office of financial management (OFM) shall adjust the "substantial development" dollar threshold defined in the Shoreline Management Act every five years beginning July 1, 2007. The new dollar threshold shall be transmitted to the office of the code reviser for publication in the Washington State Register at least one month before the new threshold takes effect.

**Notice of Substantial Development Dollar Threshold**

RCW 90.58.030 (3)(e), a part of the Shoreline Management Act, defines a substantial development to include any development with a fair market value exceeding five thousand dollars. The statute requires OFM to adjust this dollar threshold for inflation every five years. The adjustment is to be based on changes in the consumer price index for the

urban areas of Seattle, Washington, during that five-year period. The new dollar threshold shall be published in the state register at least one month before the new dollar threshold takes effect.

In accordance with these requirements, OFM submits for publication the new dollar threshold of six thousand four hundred sixteen dollars. The new dollar threshold takes effect September 15, 2012.

The new threshold was calculated as follows. Over the five-year period from June 2007 to June 2012, the consumer price index for urban wage earners and clerical workers for the Seattle-Tacoma-Bremerton, Washington, area as reported by the Bureau of Labor Statistics, United States Department of Labor, increased by 12.2 percent. This percentage applied to the prior threshold of five thousand seven hundred eighteen dollars results in an updated threshold of six thousand four hundred sixteen dollars.

In accordance with RCW 34.05.314, the public disclosure commission (the commission) submits this semi-annual agenda for rules under development.

**1. Topic:** Public records.

**Status:** On July 11, 2012, the commission filed proposed rules with the code reviser giving notice of an intended August 23, 2012, public hearing and adoption date. Proposed amendments will recognize and adopt relevant provisions of the state's model public records rules and otherwise update the commission's public records rules.

**Statutory Authority:** RCW 42.17A.110(1).

**Statute Being Implemented:** Chapter 42.17A RCW.

**WAC Cite:** Chapters 390-13 and 390-14 WAC.

**2. Topic:** Contribution limits.

**Status:** WAC 390-05-400 was amended June 30, 2012, on an emergency basis to insert and adjust contribution limits for school board candidates (enacted by chapter 202, Laws of 2012, effective June 7, 2012) in accordance with adjustments made to other candidate contribution limits made earlier in 2012. The preproposal statement to begin permanent rule making was filed May 10, 2012.

**Statutory Authority:** RCW 42.17A.110(1).

**Statute Being Implemented:** Chapter 202, Laws of 2012, RCW 42.17A.125 and 42.17A.405.

**WAC Cite:** WAC 390-05-400 Changes in dollar amounts.

**3. Topic:** Enforcement procedures.
