Amendments to bring state-chartered commercial banks and savings banks doing "derivatives transactions" into compliance with Section 611 of the Dodd-Frank Wall Street Reform and Consumer Protection Act, which takes effect January 21, 2013. The amendments also liberalize the definition of "capital and surplus" consistent with federal rules for national banks and makes exceptions to the general lending limit for nonconforming loans and exceptions for general decline in the capital markets and emergency circumstances, subject to agency approval. All other existing "lending limits" rules are rested in new chapter 208-512A WAC with no substantive changes.

Contractors will also be required to provide annual audited financial statements to the department of early learning to verify costs incurred for the MTCC program. DEL will work with existing contractors to develop processes to assist with the implementation of programmatic and administrative changes of the MTCC program.
