Under this provision, the ACA gives qualified hospitals the opportunity to immediately enroll patients who are likely eligible for medicaid under the state's eligibility guidelines, for a temporary period of time. Qualifying hospitals must be willing to comply with state policies and procedures for making PE determinations.

At this time, there is insufficient data to estimate the fiscal impact of implementing this program.

Policy #31-2: Use of Spousal Plan Questionnaire and Calculator Tools. This policy provides direction when a PEBB subscriber is determining if he or she must pay a premium surcharge for an enrolled spouse or domestic partner who chose not to enroll in his or her employer-based group medical insurance.

Policy #33-1: Verifying Legal Union's Residency Status. This policy clarifies which documents the PEBB program considers valid for establishing state residency.

Policy #45-2: Special Open Enrollment (SOE). This policy applies whenever a subscriber requests an enrollment change or election change outside of the PEBB annual open enrollment.

Addendum #45-2A: Special Open Enrollment (SOE) Matrix: Summary of permitted changes.

Policy #91-1: Requesting a Reasonable Alternative for Completing Wellness Incentive Program Requirements or Avoiding the Tobacco Use Premium Surcharge. This policy applies when a subscriber who is eligible to participate in the PEBB wellness incentive program is seeking a reasonable alternative to a wellness incentive program requirement in order to receive a wellness incentive as described in WAC 182-12-300.

Policy #91-2: Tobacco as it Relates to Religious or Ceremonial Use. This policy applies whenever a PEBB subscriber is attesting to an enrolled member's tobacco use status. The purpose of the policy is to clarify the exception for the religious or ceremonial use of tobacco.

Announcing the Public Comment Period and Hearing for the Draft Water Treatment Plant General Permit and Fact Sheet

The department of ecology (ecology) proposes to reissue the water treatment plant national pollutant discharge elimination system waste discharge general permit (permit). The permit was last issued in July 2009 and is scheduled to expire at the end of August 2014. The new draft permit and fact sheet, which explains the technical bases for the permit, are available for review and public comment from **April 16, 2014, through May 31, 2014, at 5 p.m.** Ecology will host an informational workshop and a public hearing on the draft permit.

Purpose of the Permit: The permit provides coverage for certain water treatment plants located in Washington state that produce potable or industrial supply water and discharge backwash effluent from certain water treatment filtration processes. Under federal and state water quality law (federal Clean Water Act and state Water Pollution Control Act), a permit is required for the discharge of wastewater. The federal definition of wastewater includes backwash effluent from water treatment plants. Certain water treatment plant facilities that produce finished water at a rate of at least 35,000 gallons per day and that discharge wastewater either directly or indirectly to surface water must obtain permit authorization for their discharge.

Applying for Coverage Under the Permit: Facilities that applied for coverage and are covered under the existing permit will also be covered under the new permit. New or unpermitted facilities may obtain coverage under the permit by submitting a complete permit application to ecology and satisfying all applicable public notice and State Environmental Policy Act requirements (WAC 173-226-200). Access to

the application is available online www.ecy.wa.gov/programs/wq/wtp/application.html.

Submitting Written Comments: Ecology will accept written comments on the draft permit and fact sheet from **April 16, 2014, through May 31, 2014, at 5 p.m.** All comments, including those sent by e-mail, must contain the commenter's name and postal address. Comments should reference specific permit text when possible.

Public Workshops: On May 14, 2014, a public workshop on the draft water treatment plant general permit will be held in Lacey, Washington. The purpose of the workshop is to explain the proposed new permit. Schedule and location information on the workshop is listed below, under public hearing.

Public Hearing: On May 14, 2014, ecology will host a public hearing to provide an opportunity for people to give formal oral testimony and comments on the draft permit. The public hearing will begin immediately following the public workshop.

Public workshop begins on May 14, 2014, at 1:30 p.m.; public hearing begins immediately following the public workshop; at the Ecology Headquarters Building, Room ROA-32, 300 Desmond Drive, Lacey, WA 98503.

Issuing the Permit: After ecology receives and considers all public comments, it will issue the final permit and a response to comments. Ecology expects to issue the new permit and response to comments in July 2014, with an effective date of September 1, 2014.
