3. Does the authorized use of an off-road vehicle under RCW 46.09.450 pertain to a road authorized under RCW 46.09.360 having a speed limit greater than 35 miles per hour?

The department of revenue has cancelled the following excise tax advisory (ETA): **ETA 3182.2013 Trade Shows, Conventions, and Educational Seminars Sponsored by Nonprofit Trade and Professional Organizations.**

This ETA explained when a trade show, convention, or educational seminar is considered open to the general public for purposes of the business and occupation (B&O) tax deduction in RCW 82.04.4282 Deductions—Fees, dues, charges. The department and stakeholders have reexamined the need for this ETA and agree that existing WAC 458-20-256 is sufficiently clear and the additional explanation contained in the ETA is not needed and has therefore cancelled ETA 3182.2013. This action does not represent a change to the department's understanding or interpretation of the current statutory requirements to qualify for the deduction.

 Subject: Development of statewide transition plan for compliance with new federal rules.
 Effective Date: October 31, 2014.

Document Description: A final federal rule, published in January 2014, created requirements for home and community-based settings (HCBS) in medicaid programs operated under sections 1915 (c), (i), and (k) of the Social Security Act. The rule supports opportunities to maximize access to the benefits of community living and to receive services in the most integrated setting for HCBS program participants. DSHS is conducting an assessment of settings where medicaid funded home and community-based services are provided and is preparing a report for Centers for Medicare and Medicaid Services that will include a transition plan for settings that don't meet the new settings requirements. The transition plan will include actions the state will take to address identified issues. Those steps may include but are not limited to revised contractual requirements, standardized residential admission agreements, changes to licensing survey elements and changes to WAC.

Purpose of the Permit: Federal Water Pollution Control Act Title 22 United States Code, Section 1251 et seq., and state Water Pollution Control Act, chapter 90.48 RCW (see also WAC 173-226-130) require a permit for discharge of wastewater to waters of the state. The permit addresses these legal requirements and controls the discharge of pollutants to protect water quality. The permit requires permittees to develop and implement deconstruction and site management and solid waste control plans and comply with applicable limitations. It also details inspection, sampling, and reporting requirements.

Public Notice Process and Comments: Ecology accepted public comments on the draft permit and fact sheet from July 16, 2014, until August 22, 2014. Ecology held a public hearing and workshop in Seattle, Washington on August 19, 2014. Ecology responded to written comments in Appendix C of the fact sheet. Announcing a Draft Individual Permit for Burrowing Shrimp Management on Commercial Oyster and Clam Beds in Willapa Bay and Grays Harbor for Review and Comment

Proposed Permit: The Washington state department of ecology (ecology) is proposing a new individual permit to regulate the use of imidacloprid for management of burrowing shrimp on commercial oyster and clam beds in Willapa Bay and Grays Harbor, a surface water of Washington state. Permit development was requested by the Willapa/Grays Harbor Oyster Growers Association (WGHOA) to control burrowing shrimp on commercial oyster and clam beds in Willapa Bay and Grays Harbor to aid in the cultivation and harvest of oysters and clams.

Washington's water quality statutes and regulations do not allow the discharge of pollutants to waters of the state without permit coverage. Imidacloprid, the pesticide proposed for management of burrowing shrimp is a potential

pollutant, and therefore requires a discharge permit before application to surface waters.

The applicant has applied for a sediment impact zone (SIZ) as the proposed discharge will likely impact sediment quality on sediments where the pesticide is applied. A SIZ allows for sediments and sediment dwelling organisms in the treatment areas to be temporarily impacted. A sediment monitoring program will be established to ensure that recovery or recolonization of treatment areas occurs. The applicant requests approval for a SIZ that covers an area of one thousand five hundred acres annually in Willapa Bay and five hundred acres annually in Grays Harbor throughout the term of the permit. If granted by ecology, the SIZ will be incorporated into the discharge permit as a permit condition.

As part of the environmental review necessary under the State Environmental Policy Act, ecology has determined that this proposal is likely to have significant adverse impacts on the environment. A draft environmental impact statement (DEIS) has been prepared. The DEIS, discharge permit and SIZ will be available for review and comment for forty-five days beginning on October 24, through December 8, 2014.

Purpose of the Permit: This permit would allow the management of burrowing shrimp on commercial oyster and clam beds in Willapa Bay and Grays Harbor, using the pesticide imidacloprid. WGHOGA must apply for coverage under this permit prior to implementing burrowing shrimp control activities using imidacloprid.

The public review period for these documents ends on December 8, 2014.
